The Right Honourable the Lords of the Committee of Privy Council for Trade have received, from the Secretary of State for Foreign Affairs, a Despatch from Her Majesty's Minister at Buenos Ayres, enclosing the following Instructions for Foreign Exhibitors at the Exhibition to be held at Cordoba in the year 1870:—

THE CORDOBA EXHIBITION OF 1870.

INSTRUCTIONS FOR FOREIGN EXHIBITORS.

The National Government, by Decree of the 25th inst, has ratified the following regulations as drawn up by Messrs Oliviera and Arenales on the part of the committee of Directors:—

Art. I. Any one may exhibit machinery applicable for new industries, such as the manufacture of cloth, woollens, paper, sugar, liquors, &c.; or for agricultural purposes, as steam-ploughs, pumps, harrows, thrashers, corn-shellers, pressers, and machinery for flax industry. Also machinery for mining, for Artesian wells, for brick-making and tiles; samples of cast-iron articles for ornament or use, models of architecture, of woodwork of every kind, of water-supply and drainage of lands, as well as everything relating to agriculture, mining, or public conveyance, and roads.

Art. II. All these articles will be admitted duty-free in the Custom House at Rosario, to which part they must be forwarded, with the mark "E. N.," and consigned to the Rosario Committee or to the agents of the exhibitors, who will hand them over in proper form to the Directing Committee.

Art. III. The freight by the Central Argentine Railway from Rosario to Cordoba, and all other expenses en route, will be defrayed by the National Government on going out, those on the return having to be defrayed by exhibitors in case the articles are not sold in Cordoba.

Art. IV. The space necessary for the machinery and the objects mentioned in Art. I., will be given free to exhibitors within the building of the Exhibition, and they will also be allowed every facility, as long as it does not interfere with the order and the rules of the Exhibition hereafter to be issued.

Art. V. The period for sending a list of the articles intended to be exhibited, stating the amount of space required in square metres or yards, will close on the 1st of December of this year. Foreign exhibitors should, on or before the above date, send written applications to Argentine diplomatic agents, consuls, or agents accredited by the Commission, who will remit them at once to the Commission, so that the latter may receive them the first days of January 1870, so as to enable articles to be exhibited to reach Cordoba about the middle of March same year.

Art. VI. Exhibitors in Paris may address to the Argentine Minister, D. Mariano Balcarce, 5, Rue de Berlin; in London, to M. B. Sampson, Esq., Argentine Consul-General, 1, George Street, Mansion House, E.C.; in the United States, to the Argentine Minister at Washington, Dr Don Manuel Garcia. For information and details as to the products to be exhibited, their qualities, and what is most adaptable to our wants, as well as the conditions in which they can be admitted, reference can be made to the special agent of the commissioners, Mr Belisario Roldan, at present travelling in Europe and N. America, and whose address is in London, care of F. Forromé, Esq., 45, Lime Street, E.C. In New York, care of Ed. F. Davidson, Esq., 120, Pearl Street.
Art. VII. The Argentine Diplomatic Agents

and Consuls abroad will also be able to furnish intending exhibitors with every information and

details they may require.

Art. VIII. On delivering goods in Rosario, the agents of manufacturers must declare the prices of the objects to be exhibited, the motive-power, or the consumption of coal of steam engines, as well as the cost of freight from the manufactory to Rosario, exhibitors being obliged to satisfy any demand made during the Exhibition for their respective articles at the prices put on them for Rosario, as stated above.

Art. IX. Exhibitors having any articles applicable to new industries in the country, besides having agents within the building of the Exhibition to look after them, must also provide the necessary hands for working them on experimental For this purpose, in the written application alluded to in Art. VI., mention must be made by manufacturers of the number of workmen they intend to send along with the machinery.

Art. X. Foreign exhibitors or their agents will be entitled to a gratification of 40 hard dollars (£8) for each of the working engineers or workmen they may have within the building of the Exhibition for the purpose of showing how to work the

machinery

Art. XI. The 15th of March being the date at which all articles intended to be exhibited are to be collected in the city of Cordoba, exhibitors or their agents must before that date remit to the Secretary of the Directing Commission a list specifying the articles, agents, &c., intended for exhibition, adding all possible descriptive details, and the address of the inventor or manufacturer. Should the machinery or instrument contain any improvement, a detailed note should be added, and, if possible, illustrated by a sketch or plan.

Art. XII. The specifications that may be

necessarily called for must be concise and not exceed ten lines. Should they exceed that limit exhibitors will pay for their publication in the general Catalogue of the Exhibition 20 cents. silver for every additional line. In case exhibitors wish a sketch to be added, the blocks must be sent to the Secretary, together with the note alluded to in the above Art., who will use his discretion in publishing those he may deem necessary. In this case exhibitors will pay 50 cents. silver for every sketch.

Art. XIII. The Commission will deliver to each exhibitor a number or order for each article, which must be affixed in a prominent part to the article itself, and will be reproduced in the general catalogue.

Art. XIV. The Directing Commission is not responsible for any damage caused within the building of the Exhibition or out of it.

The Right Honourable the Lords of the Committee of Privy Council for Trade have received, from the Secretary of State for Foreign Affairs, a translation of a Decree issued by the President of Nicaragua on the 15th July last.

The following is the sole Article of this Decree :-

ART. From this date the Port of Corinto remains closed to exterior commerce, in merchandize of every kind; and it is hereby made known that the Government of the Republic will in no way whatsoever be responsible for losses and damages suffered by native or foreign merchants who may load or discharge any kind of vessel whatever in the said port.

(No. 79.)—England.—West Coast.—Bristol CHANNEL.

Alterations in Caldy Island Light.

The Trinity House, London, has given notice that the following alterations have been made in Caldy Island Light, Bristol Channel.

The illuminating apparatus has been changed from catoptric to dioptric or by lenses, and of the first order.

The light to seaward, as heretofore, is a fixed white light between the bearings S.W. by W. round by North to E. by S.  $\frac{3}{4}$  S., but red from the Woolhouse shoal and Higheliff bank, or from S.W. by W. to S. by W.  $\frac{1}{3}$  W., and westward towards Old Castle head from E. by S.  $\frac{3}{4}$  S. to S.E. by E.

Over the remainder of the circle, including Caldy-road, the light will be visible, except where obscured by the land.

Also, that a vessel exhibiting a white light has been temporarily placed two cables West of a wreck off Sully Island in 3\frac{3}{4} fathoms at low water springs from her, Laver ook point is open of South end of Sully Island E. by N. 4 N.

A wreck buoy has also been placed 40 yards north-east of the wreck.

#### CARNARVON BAY.

Intended New Light Vessel between Bardsley Island and South Stack.

Also, that early in December 1869, a lightvessel will be placed between Bardsley Island and South Stack.

The light will be a revolving light with white and red flashes at intervals of twenty seconds, in the order of two white and one red.

The light-vessel will be moored in 30 fathoms at low water springs, S.S.W. 3 W. 123 miles from the South Stack lighthouse.

The light is intended to facilitate the navigation of St George's Channel, and to indicate to vessels their position when they may be influenced by the indraught of Carnarvon Bay.

Position of Barrack Rock, Dingle Bay.

A rock, long known by fishermen in the neighbourhood to exist as the Barrack Rock, on the north side of Dingle bay, has recently been examined by Staff Commander E. K. Calver, and its position determined.

The rock has a surface of about 2,000 feet rising from a base less than half a cable in extent, with  $4\frac{1}{2}$  fathoms on it at low water springs; it lies S.E.  $\frac{2}{3}$  S.  $2\frac{6}{10}$  miles from Thunder rock (south of Vickillane Island), and S. W. by W.  $\frac{1}{2}$  W.  $5\frac{3}{4}$ miles from Slea Head.

There is a break on the rock with a heavy swell.
