Her Majesty's Most Gracious Speech, delivered by the Lords Commissioners, to both Houses of Parliament, on Tuesday, February 8, 1870.

My Lords and Gentlemen,

WE have it in command from Her Majesty again to invite you to resume your arduous duties, and to express the regret of Her Majesty that recent indisposition has prevented Her from meeting you in person, as had been Her intention, at a period of remarkable public interest.

The friendly sentiments which are entertained in all quarters towards this country, and which Her Majesty cordially reciprocates, the growing disposition ro resort to the good offices of Allies in cases of international difference, and the conciliatory spirit in which several such cases have recently been treated and determined, encourage Her Majesty's confidence in the continued maintenance of the general tranquillity.

Papers will be laid before you with reference to recent occurrences in New Zealand.

Gentlemen of the House of Commons,

The Estimates for the services of the approaching financial year are in a forward state of preparation. Framed with a view in the first place to the effective maintenance of the Public Establishments, they will impose a diminished charge upon the Subjects of Her Majesty.

the Subjects of Her Majesty.

The condition of the Revenue has answered to the expectations which were formed during the

past Session.

Her Majesty trusts that you will be disposed to carry to its completion the inquiry which you last year instituted into the mode of conducting Parliamentary and Municipal Elections, and thus to prepare the materials of useful and early legislation.

My Lords and Gentlemen,

It will be proposed to you to amend the laws respecting the occupation and acquisition of land in Ireland, in a manner adapted to the peculiar circumstances of that country, and calculated, as Her Majesty believes, to bring about improved relations between the several classes concerned in Irish agriculture, which collectively constitute the great bulk of the people. These provisions, when matured by your impartiality and wisdom, as Her

Majesty trusts, will tend to inspire among persons with whom such sentiments may still he wanting, that steady confidence in the law and that desire to render assistance in its effective administration which mark Her Subjects in general; and thus will aid in consolidating the fabric of the Empire.

We are further directed by Her Majesty to state that many other subjects of public importance appear to demand your care; and among these especially to inform you that a Bill has been prepared for the enlargement, on a comprehensive scale, of the means of National Education.

In fulfilment of an engagement to the Government of the United States a Bill will be proposed to you for the purpose of defining the status of Subjects or Citizens of foreign countries who may desire naturalization, and of aiding them in the

attainment of that object.

You will further be invited to consider Bills, prepared in compliance with the Report of the Commission on Courts of Judicature, for the improvement of the constitution and procedure of the Superior Tribunals of both original and

appellate jurisdiction.

The question of religious tests in the Universities and Colleges of Oxford and Cambridge has been under discussion for many years. Her Majesty recommends such a legislative settlement of this question as may contribute to extend the usefulness of these great Institutions and to heighten the respect with which they are justly regarded.

Bills have been prepared for extending the incidence of rating, and for placing the collection of the large sums locally raised for various purposes on a simple and uniform footing.

Her Majesty has likewise to recommend that you should undertake the amendment of the laws which regulate the grant of licences for the sale of fermented and spirituous liquors.

Measures will also be brought under your consideration for facilitating the transfer of land, for regulating the succession to real property in case of intestacy, for amending the laws as to the disabilities of members of Trade Combinations, and for both consolidating and improving the body of Statutes which relate to Merchant Shipping.

Upon these and all other subjects Her Majesty devoutly prays that your labours may be constantly attended by the blessing of Almighty God.

WILLIAM SIMPSON, R.N., late Chief Boatman in charge of the Coast Guard Station at Bude, Cornwall.

The following is an account of the services in respect of which the decoration has been conferred :-

During a very heavy gale, on the 13th September 1869, the ship "Avonmore" was wrecked on the coast of Cornwall, near Bude, and the Second Officer and six other members of the crew were drowned.

The rocket apparatus from Bude was taken to the spot, and under the personal direction of WILLIAM SIMPSON, Chief Boatman in charge of the Coast Guard Station there, nine of the crew were saved by it.

Six of the crew still remained on the wreck, one of them with a broken limb, lying jammed amongst the debris on the vessel's deck; SIMPSON saw that these six men could neither save them-selves nor be saved by the apparatus unless additional assistance was rendered from the shore.

Although the ship was expected to break up momentarily, SIMPSON determined to reach the deck himself, if possible, by means of the gear.

When being hauled to the wreck the line became fast in the block, and the gear was for a

In consequence of the failure in the gear SIMPSON was hauled through the water under the stern of the ship amongst floating wreck, and it was not without difficulty and perseverance, and much risk, that he succeeded unaided in reaching the deck.

The ship was on her beam ends, masts had gone by the board, the decks were swept by the sea,

and the leaside was under water.

When on board the wreck SIMPSON saw that the gear, which had become choked by drift This he set oakum, must at once be cleared. himself to do with his teeth, whilst he held on to the wreck with his hands.

When the rocket gear was restored to working order and got clear of all obstacles, four other volunteers were hauled on board from the shore to assist, and under SIMPSON'S direction the wounded man was extricated from the debris, and the whole of the six remaining members of the crew were saved.

SIMPSON was the last to leave the wreck.

And whereas it is expedient that the Post-master-General should be authorized to allow the pre-payment of the postage upon the said respective packets to be made in certain cases in money, in lieu of stamps, as required by the hereinbefore recited Warrants.

Now we, the Commissioners of Her Majesty's Treasury, in exercise of the powers vested in us in and by the said hereinbefore recited Acts, or either of them, and of all other powers enabling us in this behalf, do, by this Warrant, under the hands of two of us, the said Commissioners, by the authority of the Statute in that case made and provided, order, direct, and consent as follows:—

- 1. That, notwithstanding anything in the said hereinbefore recited or referred to Warrants contained to the contrary, it shall be lawful for the Postmaster-General to permit the postage chargeable upon any of the respective packets hereinbefore mentioned to be prepaid in money, at such Post-office, within such hours, and under and subject to all such regulations, conditions, and restrictions, as he in his discretion shall from time to time think fit and direct.
- 2. All such packets as are mentioned in this Warrant shall remain subject in every respect (save as in this Warrant mentioned) to the several orders, regulations, conditions, and restrictions now in force and applicable thereto, and the several Warrants hereinbefore recited or referred to shall (save in so far as they are or may be respectively altered or affected by this present Warrant) continue in full force and effect.
- 3. The terms and expressions used in this Warrant shall be construed to have the like meaning, in all respects, as they would have had if inserted in the said firstly hereinbefore recited Act.
