I HAVE the l mour to transmit herewith to your Lordship, extracted from the "Moniteur Universal," of this day, a Decree, appointing a Prize Court at the seat of the Delegation of the Government of National Defence.

GOUVERNEMENT DE LA DEFENSE NATIONALE.

La Délégation du Gouvernement de la Défense Nationale,

Sur le rapport du Vice-Amiral, Ministre de la Marine et des Colonies,

Considérant qu'il importe de ne pas laisser en souffrance les intérêts des neutres engagés dans les questions de prises, que l'interruption des communications avec Paris ne permet pas de soumettre au Conseil Permanent des Prises les instructions déjà terminées et celles qui le seront jusqu'à une époque indéterminée ;

DECRÈTE :

Article 1er. Un Conseil provisoire des prises est institué au siége de la délégation du Gouvernement de la défense nationale.

Art. 2. Le Conseil est composé :

D'un président, de quartre membres, et d'un commissaire du Gouvernement.

Les membres composant le Conseil sont pris parmi les fonctionnaires des départements de la Justice, des Affaires étrangères et de la Marine, en nombre égal et nommés sur la présentation des ministres de leur département respectif. Leurs fonctions sont gratuites.

Un secrétaire-greffier est attaché au Conseil

Art. 3. Ce Conseil remplacera le Conseil des Prises instituté à Paris, jusqu'au rétablissement des communications ; il en aura les attributions et procèdera dans les mêmes formes. Les parties auront le droit de signer les mémories et requêtes qui seront présentés au Conseil des Prises. Art. 4. Le Conseil provisoire sera dissous aussitôt que le Conseil permanent pourra fonctionner.

Le registre de ses décisions sera alors déposé aux archives du Conseil permanent.

Art. 5. Sont nommés membres du Conseil Provisoire des Prises :---

Barboux, Avocat à la Cour d'Appel de Paris, désigné comme Secrétaire.

GOVERNMENT OF NATIONAL DEFENCE.

The Delegation of the Government of National Defence,

On the report of the Vice-Admiral, Minister of Marine and the Colonies,

Considering that it is of importance not to leave exposed to injury the interests of neutrals engaged in prize questions, and that the interruption of communication with Paris does not allow the reference to the permanent Prize Court of the proceedings already terminated, and those to be hereafter determined, until an indefinite period;

DECREES

Art. 1. A Provisional Prize Court is established at the seat of the Delegation of the Government of National Defence.

Art. 2. The Court is composed :

Of a President, of four Members, and of a Government Commissioner.

The members of the Court are chosen from among the functionaries of the Departments of Justice, of Foreign Affairs, and of Marine, in equal numbers, and are appointed on the nomination of the Ministers of their respective Departments. Their functions are gratuitous.

A Secretary Registrar is attached to the Court.

Art. 3. This Court will be substituted for the Prize Court established at Paris until communication is re-established. It will have the same attributes, and will proceed in the same forms. Parties will have the right to sign memorials and petitions, which will be laid before the Prize Court.

Art. 4. The Provisional Court will be dissolved as soon as the Permanent Court shall be able to act.

The register of its decisions will then be deposited in the archives of the Permanent Court.

Board of Trade, Whitehall, October 31, 1870.

The Right Honourable the Lords of the Committee of Privy Council for Trade have received, from the Secretary of State for Foreign Affairs, a copy of a Despatch from Her Majesty's Minister at Madrid, enclosing a copy of a Decree of the Spanish Government, dated 15th July last, approving the new General Customs Ordinances :--

DECREE.

(TRANSLATION.)

ART. 1. The General Customs Ordinances,^{*} drawn up in fulfilment of the law of the 1st July 1869, are approved.

ART. 2. These Ordinances will come into force on the 1st November next.

ART. 3. From the prescription of Art. 2 is excepted the disposition which requires masters of vessels to have a manifest of their cargoes ready drawn up on entering Spanish waters. That disposition will come into operation on 1st January 1871 for vessels arriving from all ports in Europe, all ports of Asia and Africa in the Mediterranean, and African ports on the Atlantic as far as Cape Mogador; and on 1st April 1871 for vessels arriving from all other ports in Asia and Africa, and from all ports in America and Oceania.

Until this disposition comes into operation masters of vessels must come provided with the Consular-Register as hitherto; on and after the 1st November, however, those who wish it may cease to provide themselves with the register, and subject themselves at once to the formation of the aforesaid manifest.

Board of Trade, Whitehall, October 31, 1870.

The Right Honourable the Lords of the Committee of Privy Council for Trade have received, from the Secretary of State for Foreign Affairs, from Her Majesty's Minister at Madrid, a copy of an Order addressed by the Spanish Colonial those Islands. The above-mentioned Articles will in future be respectively worded as follows :-

ART. 42. If the examination shows minus differences in the number, weight, measure, or value of the effects, then, for the payment of the duty, that which is manifested in the declaratory notes shall be abided by; but where there are plus differences, whether in quality or quantity, Arts. 156 and 157 shall be observed.

ART. 156. If, on examining and comparing goods of lawful commerce with the declarations of the parties interested, there be found in the goods a plus or minus difference in quantity or quality not exceeding 4 per cent., they shall be despatched according to the result of the said acts. When the plus differences in quantity or quality between that which is found and that which is declared exceeds 4 per cent., the parties interested shall suffer an additional duty equal to the difference between the duty to have been paid on the goods according to the declarations and the duty to be applied in consequence of the result of the examination. As regards oil, dried cod fish, greases, soap, butter, and other oleaginous goods liable to waste away, plus or minus differences shall not be accounted as such, if they do not exceed 5 per cent. in goods coming from Asia, and 8 per cent. in goods coming from other countries. For calculating the rate per cent. of the differences that may appear in one and the same despatch, and the amount of the additional duty according to the basis laid down in the second paragraph of this Article, all those belonging to one item of the Tariff shall be taken together (even although the goods be in different packages), to deduce therefrom that which ultimately constitutes the fraud attempted. If the merchandise be woven goods, the calculation shall be made by taking together all those of the same class, even although they belong to different items of the Tariff, taking care not to mix up plain goods with goods in imitation of serge (asargados), nor embroidered with unembroidered goods.

The amount of the additional duty spoken of in this Article shall be divided between the Exchequer and the employés.

ART. 157. When the differences are produced by the appearance of less goods, or of other goods hable to lower duty than the goods declared, duty shall be exacted on the whole of the goods set forth in the declaration. Goods of lawful commerce which, not having been declared, may be found fraudulently hidden, shall be confiscated.

ART. 158. If, on making the examination and valuation of duty, prohibited goods are found, which the parties interested may have declared as considering them allowed, a fine of the fourth part of the value thereof shall be imposed, and divided between the Exchequer and the employés con-cerned in the discovery. The owners shall be obliged to re-export, and in the meantime the goods shall remain in the Custom-house in deposit. If the said goods shall not have been declared, they shall be confiscated. If they have not been declared and are found fraudulently hidden they shall be confiscated, and an additional duty shall be imposed equal to the value of the goods. The amount of this additional duty, which, like the confiscated goods, shall be divided

A fine of 400 escudos shall be imposed for the non-presentation of the said document within the term to be fixed at discretion.

> ART. 159. When passengers bring unregistered goods exceeding 200 escudos in value, the goods to that amount shall first be set on one side and the rest shall be charged double the respective Tariff duty. If the goods have not been declared, double duty shall be charged on the whole; but if, besides this, they have been fraudulently hidden in secret compartments of boxes, or in any other manner, they shall be confiscated.
