# PRISON OF DUNBLANE.

The Right Honourable Henry Austin Bruce, One of Her Majesty's Most Honourable Privy Council, and Principal Secretary of State, &c., &c., &c.

WHEREAS the Prison of Dunblane, in the County of Perth, has recently, in conformity with Plans which received the approval of One of Her Majesty's Principal Secretaries of State, been altered and enlarged in so far that the same contains within the enclosure, entered from the outer gate, the accommodation following ; videlicet :-

- 1st. Thirteen Cells for Male Criminal Prisoners.
- 2d. Five Cells for Female Criminal Prisoners.
- 3d. A Room for Civil Prisoners.

4th. Two Airing Yards on the top of the building.

5th. A Kitchen.

6th. A. Washing-room.

7th. A Room for a Female Attendant.

8th. A House for the Governor.

In virtue of the powers contained in the Prisons (Scotland) Administration Act, 1860, I do hereby Order and Intimate that the said Building as so altered and enlarged shall, on and after the 8th day of March 1871, under the Name of the Prison of Dunblane, be a LEGAL PRISON for the Detention of Civil and Criminal Prisoners: Provided that in the case of Criminal Prisoners under Sentence of Imprisonment, the same shall only be a Legal Place of Imprisonment for periods not exceeding six months from the date of their respective Sentences: And that every Prisoner under a Sentence which may exceed six months, shall, before the expiry of six months from the date thereof, be removed to the Prison of Perth, by or under the direction of the Prison Board for the County of Perth.
