The Right Honourable Henry Austin Bruce, one of Her Majesty's Most Honourable Privy Council and Principal Secretary of State, &c. &c. &c.

WHEREAS the Prison of Kirkwall is not a suitable place of detention for Prisoners during the latter portion of long sentences, and it is desirable that the period during which Criminal Prisoners under long sentences may be detained therein should be limited:

In virtue of the powers contained in the Prisons (Scotland) Administration Act, 1860, I do hereby order and direct that the Prison of Kirkwall, in the County of Orkney, shall, on and after the 20th day of January 1873, cease to be a Prison for the detention beyond two months from the date of their respective sentences of Criminal Prisoners sentenced to imprisonment; and that the Prison of Aberdeen, in the County of Aberdeen, shall be the Prison to which the Prisoners who cannot be detained in the Prison of Kirkwall, by reason of Prisoners for which the same is legal, shall be removed; and further, that the removal of such Prisoners shall be carried out by or under the direction of the Prison Poard of the County of Orkney, under the powers conferred on them by the said Act.

Given under my hand and seal, at Whitehall, this 18th day of December 1872, in the 36th year of Her Majesty's reign.
