PRELIMINARIES OF PEACE between his Majesty and the French Republic were figned last night at Lord Hawkesbury's Office, in Downing-street, by the Right Hon. Lord HAWKES-BURY, one of his Majesty's Principal Secretaries of State, on the part of his Majesty, and by M. OTTO, on the part of the French Government.

Extract of a dispatch from Lord Elgin to Lord Hawkesbury, dated Constantinople, September 6 1801, mi inight.

Extract of a letter from Sir John Hely Hutchinson, To Vice-Admiral Pole, Commander in Chief, &c. vice Johnson, deceased.

K. B. to the Earl of Elgin, dated head-quarters camp before Alexandria, Aug. 27, 1801.

I just seize the opportunity of a messenger going to Constantinople, (dispatched by the Captain Pacha,) to inform your Excellency, that General Menou offered last night to capitulate for the town and forts of A. lexandria, and demanded an armistice of three days for the purpose of arranging the terms of the capitulation; this I have granted accordingly.
