To repeal or alter and amend sections 18 and 25 of the Act of 1871, and to provide for two or more ordinary meetings of the Company being held in each year, and for the declaration and payment of half-yearly or interim or other dividends on the stocks and shares of the Company, and to make such other provisions with respect to meetings of the Company and the declaration of dividends as

the Bill may provide.
5. To authorize the Company to purchase, acquire, lease, and hold lands and heritages, mines and minerals, sell, convey, feu, assign, or otherwise dispose of any lands, or heritages, or mines and minerals, or leases thereof now belonging to, or held by, or which at any time hereafter may belong to, or be acquired or held by them, and to provide for the application of the price or proceeds thereof.

6. To incorporate with or apply to the Bill the provisions, or some of the provisions, of 'The Companies Clauses Consolidation (Scotland) Act 1845,' and 'The Companies Clauses Act 1863, with such exceptions and modifications as may be considered expedient.

To vary or extinguish all rights and privileges which might in any way interfere with the objects of the Bill or any of them, and to confer all rights and privileges necessary or expedient for effecting these objects or in relation thereto.

Printed copies of the Bill will be deposited in the Private Bill Office of the House of Commons, on or before the 21st day of December next.
