WESTMINSTER, DEC. 15. 1801.

This day the Lords being met, a message was sent to the Honourable House of Commons by Sir Francis Molyneux, Gentleman Usher of the Black Rod, acquainting them; that "The Lords, authorised by virtue of his Majesty's Commission for declaring his royal assent to several acts agreed upon by both Houses, do desire the immediate attendance of this Honourable House in the House of Peers to hear the Commission read;" and the Commons being come thither, the said Commission, empowering the Lord Archbishop of Canterbury, the Lord High Chancellor of Great Britain, and several other Lords, therein named, to declare and notify the royal assent to the said acts, was read accordingly, and the royal assent given to

An act to prohibit the distillation of spirits from wheat in Ireland.

An act to permit, until the 1st day of July 1802, the making of starch from rice or potatoes, or any mixture thereof, and the importation of any such starch from Ireland, free of duty.

An act to continue until the 5th day of July 1802, an act made in the 35th year of the reign of his present Majesty, for permitting the importation of organized thrown silk, flax, and flax-seed into this kingdom, in ships or vessels belonging to any kingdom or state in amity with his Majesty.
