Whereas by an Order in Council, dated the 11th day of July 1877, Her Majesty was pleased, by and with the advice of Her Privy Council, to direct that the Ordinance, numbered 6 of 1877, enacted by the Legislature of the Gold Coast Colony, entitled 'The Extradition Ordinance, Gold Coast Colony, 1877,' should have effect in the Colony of the Gold Coast, as if it were part of 'The Extradition Act, 1870;' and whereas it is

expedient that the said Order be revoked. Now therefore, Her Majesty, by and with the advice of Her Privy Council, is pleased to direct that the said Order in Council of the 11th of July 1877, be, the same is hereby, revoked.

Whereas by section 18 of 'The Extradition Act, 1870,' it is among other things enacted 'that if by any law made after the passing of the said Act by the Legislature of any British Possession provision is made for carrying into effect within such Possession the surrender of fugitive criminals who are in or suspected of being in such British Possession, Her Majesty may by the Order in Council applying the said Act in the case of any Foreign State or by any subsequent Order either

Suspend the operation within any such British Possession of the said Act, or of any part thereof, so far as it relates to such Foreign State, and so long as such law continues in force there and no longer;
Or direct that such Law or Ordinance or any

part thereof shall have effect in such British Possession with or without modifications and alterations, as if it were part of the Act.'

And whereas by an Ordinance, numbered 6 of 1877, enacted by the Legislature of the Gold Coast Colony, the short title of which is 'The Extradition Ordinance, Gold Coast Colony, 1877,' it is provided that 'all powers vested in and acts authorized or required to be done by a Police Magistrate or any Justice of the Peace in relation to the Surrender of Fugitive Criminals in the United Kingdom under "The Extradition Acts, 1870 and 1873," are thereby vested in and may in the Colony be exercised and done by any District Commissioner in relation to the Surrender of Fugitive Criminals under the said Acts.'

And whereas it is further provided by the said Ordinance that the said Ordinance shall not come into operation until Her Majesty shall by Order in Council direct that the said Ordinance shall have effect within the Colony as if it were part of 'The Extradition Act, 1870,' but that the said Ordinance shall thereafter come into operation as soon as such Order in Council shall have been publicly made known in the Colony.

Now therefore, Her Majesty, in pursuance of 'The Extradition Act, 1870,' and in exercise of the power in that behalf in the said Act contained, doth by this present Order, by and with the advice of Her Majesty's Privy Council, direct that the said Ordinance shall have effect in the Colony of the Gold Coast without modification or alteration, as if it were part of 'The Extradition Act, 1870.'

And the Right Honourable the Earl of Carnarvon, one of Her Majesty's Principal Secretaries of State, is to give the necessary directions herein accordingly.

The Earl of Derby, Her Majesty's Principal Secretary of State for Foreign Affairs, has received a Despatch from the British Consul-General at Odessa, in which he reports, under date November 14, that he has received a Circular from the Governor of Odessa stating that by Imperial Order the exportation of grain by sea from the Russian ports of the Black Sea and the Sea of Azof is prohibited.

- (a) LOCH BOISDALE PIER.
(b) LOCH SKIPIORT PIER.

PROVISIONAL ORDER.

(Powers to construct Piers, levy Rates; regulate Vessels and Traffic; constitute a Harbour Authority; and other purposes).

NOTICE is hereby given that application is intended to be made to the Board of Trade, pursuant to the provisions of the General Pier and Harbour Act, 1861, and the General Pier and Harbour Act 1861 Amendment Act, on or before the 22d day of December next, by John Gordon, Esquire of Cluny (who together with his Heirs, Assignees, and Successors are hereinafter called 'the Promoters') for a Provisional Order for all or some of the powers and purposes following, that is to say:—

(1st) To authorise the Promoters to make, maintain, and regulate a Pier at Loch Boisdale, commencing at a point 68 yards or thereabouts, measuring eastward from the south end of 'Big-house,' and extending in a north-easterly direction along the Shore for a distance of 27 yards or thereabouts from the said point of commencement, together with all necessary works in connection with such Pier; and

(2nd) To authorise the Promoters to make, maintain, and regulate a Pier at Loch Skipport, commencing at a point 280 yards or thereabouts, measuring northwards from the north end of 'Shepherd's Cottage,' and extending in a north-westerly direction along the Shore for a distance of 27 yards or thereabouts from the said point of commencement, together with all necessary works in connection with such Pier.

Which Piers at Loch Boisdale and Loch Skipport, and all necessary works, will be situate

in the Parish of South Uist and County of Inverness, and on the fore Shore and in the Sea adjacent thereto.

To authorise the Promoters, in the construction of such Piers, to make all suitable deviations lateral and vertical, and to make all necessary approaches, roads, jetties, wharves, warehouses, sheds, cranes, water-pipes, and other works and conveniences, and to supply water to vessels.

To authorise the Promoters to levy tolls, rates, duties, and charges on vessels and boats, and on passengers, animals, fish, goods, vehicles, and other matters and things at or in respect of the use of the said Piers, and the warehouses, sheds, cranes, and other conveniences connected therewith, and for the supply of water to vessels; and to make provision for the collection and regulation of the same, and to confer, vary, and extinguish exemptions from such tolls, rates, duties, and charges, and to make compositions with respect to the payment thereof.

To provide for the maintenance, management, and administration of the said intended Piers and works, and all matters relating thereto; to authorise the Promoters to let on lease the said Piers and works, and the said tolls, rates, duties, and charges, or any of them; to make, alter, and rescind bye-laws, rules and regulations for the management, use, and protection of the said Piers and works, and for the regulation and control of vessels, persons, and traffic frequenting or resorting to or employed, embarked, disembarked, loaded or unloaded at or near said Piers and works; and to impose and recover penalties for the breach or non-observance of such bye-laws, rules, and regulations, and to appoint and remove pier-masters, meters, weighers, and other officers and servants.

To define the limits within which the powers of such pier-masters, meters, weighers, officers, and servants may be exercised.

To constitute the Promoters the Harbour Authority and Pilotage Authority for the said Piers and the neighbourhood thereof, and to fix the limits of such authority.

To confer on the Promoters all powers, rights

and privileges necessary for carrying the said Provisional Order into effect, and to vary or extinguish all rights and privileges which might interfere therewith.

To incorporate with the said Provisional Order all or some of the provisions of the Lands Clauses Consolidation (Scotland) Act, 1845, the Lands Clauses Consolidation Acts Amendment Act, 1860, the Railways Clauses Consolidation (Scotland) Act, 1845, and the Harbours, Docks, and Piers Clauses Act, 1847.

And Notice is hereby given that, on or before the 30th day of November instant, Plans and Sections of the proposed works, and a copy of this Notice, will be deposited for public inspection in the Office of the Clerk of the Parliament, House of Lords, the Private Bill Office of the House of Commons, the Offices at Inverness and Lochmaddy of the Principal Sheriff-Clerk for the County of Inverness, the Custom House of the Port of Stornoway, and the Office of the Board of Trade, London.

And it is proposed by the intended Act to enlarge or amend the Charters of the Company, or some of them, so far as may be necessary or expedient for the purposes above mentioned or some of them.

To incorporate all or some of the provisions (with or without amendment) of the following Acts, that is to say, The Companies Clauses Consolidation Act, 1845, The Companies Clauses Act, 1863, and The Companies Acts, 1862, 1867, and 1877.

WAID'S ORPHAN NAVAL ACADEMY,
ANSTRUTHER.

(Alteration of Powers and Purposes of Lieutenant Andrew Waid's Trust Deeds; Constitution of Waid's Orphan Naval Academy; Incorporation of Trustees; Powers to Trustees; Application of Trust Funds, Purchase of Land and other Property, and other Purposes.)

NOTICE is hereby given, that application is intended to be made to Parliament in the ensuing Session for leave to bring in a Bill (hereinafter called 'the Bill') for the following objects, or some of them, viz.:—

To alter, modify, explain, enlarge, vary, and amend the powers, provisions, and purposes of the following deeds, viz.:—(1) A Trust Disposition and Deed of Settlement executed by the now deceased Andrew Waid, then residing in Dundee, Lieutenant of His Majesty's Navy, dated the 4th day of December 1800, and recorded in the Register of Probative Writs kept for the Commissariat of Aberdeen, the 5th day of December 1800, and also recorded in the Burgh Court Books of Dundee the 28th day of July 1803, whereby he appointed certain persons, all now deceased, to be Trustees for the purposes therein mentioned; (2) A Codicil to the said Trust Disposition and Deed of Settlement executed by the said Andrew Waid, dated the 10th day of July 1802, and recorded in the said Burgh Court Books of Dundee as aforesaid, whereby he made sundry alterations in the provisions thereof; (3) A further Codicil to the

said Trust Disposition and Deed of Settlement executed by the said Andrew Waid, dated the 5th day of February 1803, and recorded in the said Burgh Court Books of Dundee as aforesaid, whereby he made sundry further alterations in the provisions thereof, which Trust Disposition and Deed of Settlement and two Codicils hereinbefore mentioned are hereinafter called 'the Trust Deeds'; (4) A Deed of Assumption, dated the 26th day of September, the 6th, 10th, and 18th days of October 1804, and recorded in the Burgh Court Books of Dundee the 23d day of October 1804, executed by the then accepting and surviving Trustees under the Trust Deeds; (5) A Deed of Assumption, dated the 12th day of October 1814, the 6th and 10th days of June 1815, and recorded in the Sheriff Court Books of Forfarshire the 11th day of July 1815, executed by the then surviving original and assumed Trustees under the Trust Deeds; (6) A Deed of Assumption, dated the 2d day of August, the 4th, 7th, and 10th days of September 1830, and recorded in the said Sheriff Court Books the 13th day of September 1830, executed by the then surviving original and assumed Trustees under the Trust Deeds; (7) A Deed of Assumption, dated the 4th day of February 1845, and recorded in the said Sheriff Court Books the 7th day of February 1845, executed by the then surviving original and assumed Trustees under the Trust Deeds; (8) A Deed of Assumption, dated the 11th and 12th days of December 1856, and recorded in the said Sheriff Court Books the 15th day of December 1856, executed by the then surviving original and assumed Trustees under the Trust Deeds; (9) A Deed of Assumption, dated the 20th day of February 1861, and recorded in the said Sheriff Court Books the 5th day of April 1861, executed by the then surviving original and assumed Trustees under the Trust Deeds; and (10) A Deed of Assumption, dated the 31st day of May and the 6th and 11th days of June 1870, and recorded in the said Sheriff Court Books the 18th day of June 1870, executed by the then surviving original and assumed Trustees under the Trust Deeds;—by which several Deeds of Assumption certain persons were assumed as Trustees for the purposes of the Trust Deeds.

To reconstitute the Trust, and to provide for the exoneration and discharge of the Trustees; to provide for the election of new Trustees, and to regulate the future administration of the same, and the investment, expenditure, and application of the Trust Funds; to enable the Trustees to purchase, acquire, and hold lands and other property for the purposes of the Trust, and to sell and convey the same from time to time as may be expedient; and generally to confer such Powers on the Trustees as will enable them to establish and maintain the Academy contemplated by the said Trust Deeds.

To restrict the number of Trustees under the Trust Deeds, and to provide that certain persons to be annually appointed by the Provost, Magistrates, and Town Council of Anstruther Easter, or certain other Trustees *ex officio*, or to be appointed by other public bodies as will be defined in the Bill, shall, together with the Trustees for the time being appointed under the powers of the Trust Deeds (who are hereinafter called 'the existing Trustees'), be Trustees for the purposes of those Deeds as enlarged and altered by the Bill, and shall be a body Corporate with all usual powers; and to make provision for the appointment of the members of such body Corporate (hereinafter

called 'the Trustees'); for transferring to and vesting in the Trustees the property, funds, rights, powers, and liabilities of the existing Trustees with such alterations as will be provided by the Bill, and for regulating the meetings of the Trustees, the appointment, powers, and meetings of Committees of their number, the investment and application of the Trust Funds, the appointment, payment, suspension, and dismissal of masters, officers, and servants, and other matters connected with the management of the Trust.

To relieve the Trustees of any obligation imposed by the Trust Deeds to erect and establish the Academy on or near the site therein contemplated.

To enable the Trustees, if they think fit, to purchase by agreement or otherwise the site appointed in the Trust Deeds for the Academy, and to adapt the same to the purposes of the Academy, or to purchase by agreement or otherwise any other site which they may consider more suitable, either in Anstruther or elsewhere, and to erect, complete, and maintain thereon suitable buildings for the Academy, and to enlarge or renew such buildings from time to time as may be requisite for the purposes of the Academy, and to provide and pay out of the Trust Funds the price of purchasing and acquiring such site, and of converting and adapting or erecting and maintaining the buildings thereon, and of enlarging and renewing the same from time to time.

To provide that the Trustees may admit to the Academy, and may board, clothe, and maintain therein such number of boys as they think fit, and may educate them either within the Academy or at any other School or Schools in such branches of education, and either gratuitously or upon payment of such fees as they may appoint, and may prescribe the age and conditions of admission and the course of study, and may pay out of the Trust Funds school fees for the education and instruction of all or any of the said boys at any other School, and may refuse to admit or may dismiss any boys whenever they find it desirable so to do.

To empower the Trustees to dispense with all or some of the requirements of the Trust Deeds with respect to the style of dress of the boys, the appurtenances and things therein prescribed to be used and employed in the naval instruction of the boys, and the mode of conducting their education, and to regulate, prescribe, and appoint such style of dress, appurtenances, and naval instruction as the Trustees think fit; and also to provide that it shall not be obligatory on the Trustees to require any of the Academy boys to serve on board a man-of-war, or to join the Royal Navy, nor to require that any of the boys shall, after leaving the Academy, make any payment or contribution to the funds of the Trust.

To enable the Trustees, if at any time they deem it expedient, to contract and agree with the School Board of Anstruther Easter, or with the Directors or Managers or Proprietors of any School within the parish of Anstruther Easter or Anstruther Wester, for the education of the boys of the Academy, either wholly or in part, at some School or Schools apart from the Academy or otherwise; and to contribute, if they should deem it expedient, such sum or sums of money out of the Trust Funds as they may think fit towards the construction, erection, or maintenance of such School or Schools, and also to enable the Trustees to contract and agree that the Academy may or may not form part of and be conducted along with any School which the Trustees may select for the education of the

Academy boys, and that upon such terms and conditions, and for such payment or contribution out of the Trust Funds, either by way of one present payment in advance, or by annual or other periodical payments or by school fees, or by all or any of these means, and subject to such regulations as the Trustees may determine, or which will be specified in the Bill, and to apply the Trust Funds, or so much thereof as the Trustees shall think proper or necessary, for carrying out the said objects, or which will be provided in the Bill.

To enable the Trustees, if they think fit, to apply part of the Trust Funds in assisting Academy boys or other boys of the class from which scholars might be admitted into the Academy to attend other schools affording a higher class of education, and in establishing libraries and reading-rooms in connection with the Academy, and otherwise in extending the benefits of the Trust.
