A PROCLAMATION.

VICTORIA, R.

WHEREAS our Parliament stands prorogued to Thursday the seventeenth day of January next, We, by and with the advice of Our Privy Council, hereby issue Our Royal Proclamation, and publish and declare Our Royal will and pleasure, that the said Parliament shall, on the said Thursday the seventeenth day of January one thousand eight hundred and seventy-eight, assemble and be holden for the dispatch of divers urgent and important affairs: and the Lords Spiritual and Temporal, and the Knights, Citizens, and Burgesses, and the Commissioners for Shires and Burghs of the House of Commons, are hereby required and commanded to give their attendance accordingly, at Westminster, on the said Thursday the seventeenth day of January one thousand eight hundred and seventy-eight.

Given at Our Court at Windsor this twentysecond day of December in the year of our Lord one thousand eight hundred and seventy-seven, and in the forty-first year of Our reign.

Mackenzie as Vice-Consul for Inverness, Nairn, Findhorn, Lossiemouth, Burghead, Portmahomack, Invergordon, Fort William, and the Island of Skye, to reside at Inverness; of Mr. Robertson as Vice-Consul for the Havens of Dysart, Kirkaldy, Wemyss, Methil, St. David's, Charleston, and Burntisland, to reside at Burntisland; of Mr. Alexander Robertson as Consul for Peterhead and Fraserburgh, to reside at Peterhead; of Mr. Robert Robertson as Vice-Consul at Peterhead for the German Empire; and of Mr. Jorge Moss as Brazilian Consul in the Island of St. Helena.
