We, by and with the advice aforesaid, do hereby order and direct that from and after the date hereof, torpedoes, torpedo boats, boats fitted with apparatus to be used for torpedoes, all apparatus for projecting inflammable materials, or firing torpedoes, and the following articles, being articles which We have judged capable of being converted into, or made useful in increasing the quantity of, military or naval stores, that is to say, pumps or other machinery intended to be used for projecting inflammable materials, machinery intended to be ... used in the construction of torpedoes or torpedo
