Her Majesty's Most Gracious Speech, delivered by the Lords Commissioners, to both Houses Parliament, on Thursday, December 5, 1878.

My Lords and Gentlemen,

REGRET that I have been obliged to call for your attendance at an unusual, and probably

to most of you an inconvenient, season.

The hostility towards my Indian Government manifested by the Ameer of Afghanistan, and the manner in which he repulsed my friendly mission, left me no alternative but to make a peremptory demand for redress. This demand having been disregarded, I have directed an expedition to be sent into his territory, and I have taken the earliest opportunity of calling you together, and making to you the communication required by law.

I have directed that papers on the subject shall

be laid before you.

I receive from all foreign Powers assurances of their friendly feelings, and I have every reason to believe that the arrangements for the pacification of Europe made by the Treaty of Berlin will be successfully carried into effect.

Gentlemen of the House of Commons,

The Estimates for the ensuing year are in course of preparation, and will in due time be submitted

My Lords and Gentlemen,

I propose that after full deliberation upon the matters which have led me to anticipate your usual time of meeting, and after a suitable recess, you should proceed to the consideration of various measures for the public benefit, which will then be laid before you.

I confidently commit to your wisdom the great interests of my Empire, and I pray that the blessing of Almighty God may attend your counsels.
