**PUBLIC NOTICE, IN TERMS OF THE
ENDOWED INSTITUTIONS (SCOTLAND)
ACT, 1878, SECTION 5.**

IN terms of an Order by the Right Honourable Richard Assheton Cross, one of Her Majesty's Principal Secretaries of State, dated 27th March 1879, made under the provisions of the Endowed Institutions (Scotland) Act, 1878, 41 and 42 Victoria, chapter 48, it is hereby intimated that a Petition has been presented to the aforesaid Secretary of State by James Hope, Deputy-Keeper of the Signet, Edinburgh, Edmund Baxter, Writer to the Signet, Edinburgh, Auditor of the Court of Session, and John Kirk, Writer to the Signet, Edinburgh, Director of Chancery, sole surviving, accepting, and acting Trustees, original and assumed, acting under the Trust Disposition and Settlement of the deceased John Robertson, sometime Schoolmaster at Preston, thereafter residing at West Newington Place, near Edinburgh, dated 17th March 1830, and with three Codicils thereto, dated respectively 17th March 1830, and 16th and 17th June 1831, all recorded in the Books of Council and Session 13th January 1832, and as such the Governing Body of 'Robertson's Academy,' Edinburgh, praying for a Provisional Order giving power to them to apply the whole of the revenue of the Trust Estate to the foundation of a Bursary of £25, tenable for five years, to be called the 'Robertson Bursary,' the Bursar to be elected annually by the Edinburgh School Board under such conditions as they shall from time to time appoint from the pupils attending the Elementary or Primary Schools of Edinburgh, and to be bound to continue his education during the whole years during which he shall be in receipt of the Bursary, at the High School of Edinburgh.

Petition of the Dean of Guild and Directors of the Merchants' House of Glasgow to the Principal Secretary of State for the Home Department, for a Provisional Order with respect to the Mortifications and other Endowments within mentioned.

To the Right Honourable Her Majesty's Principal Secretary of State for the Home Department.

THE PETITION

OF

**THE DEAN OF GUILD AND DIRECTORS OF THE
MERCHANTS' HOUSE OF GLASGOW,**

Humbly Sheweth,

THAT an Act was passed in the Session of Parliament, 1878 (41 and 42 Victoria, caput 48), entitled 'An Act to Amend the Law relating to Endowed Schools and Hospitals and other Endowed Institutions in Scotland, and for other purposes.'

That the said Act provides (sections 4, 5, 6, 7, and 8) for the Governing Body of any Endowed Institution in Scotland applying for and obtaining from Parliament, power and authority whereby changes may be made in the Government and Management of the said Institutions or in the application of their Endowments, on a petition to that effect being presented to the Secretary of State for a Provisional Order.

That your Petitioners are the Governing Body of the Mortifications and other Endowed Institutions after mentioned, the original constitution and purposes whereof are detailed in a Statement which accompanies this Petition, and to which your Petitioners respectfully refer.

That your Petitioners at a Meeting convened in terms of the said Act, held on the Eleventh Day of March Eighteen Hundred and Seventy-Nine, unanimously resolved 'that it is expedient that provision should be made for the better government and administration of the said Institutions, and for the better application of the Endowments thereof, and that an application should be made to the Secretary of State for a Provisional Order,' to the following effect, viz:—

I. That the Names of the Founders of the Mortifications hereinafter mentioned shall be retained and preserved as distinctive of their respective Endowments; but that the whole other conditions, qualifications, and preferences stipulated, prescribed, or referred to, in or by the several Deeds of Mortification or Foundation, Bonds, Minutes, or other writings relating thereto, or by any practice or usage connected therewith, of or concerning the administration or distribution of the Funds thereof, except as hereinafter mentioned, shall be cancelled, annulled, and declared of no force or effect, and that all rights and powers of control, oversight, or supervision, inconsistent or at variance with the enactments of the

Provisional Order hereby sought, shall also be cancelled and annulled.

II. That the revenues of certain of the Mortifications in this section mentioned shall be augmented by the Merchants' House of Glasgow, as hereinafter specified, and that the revenues of the whole of the Mortifications in this section mentioned, including such augmentations, shall hereafter be available for, and be paid and applied in, Pensions, in sums of not less than Five Pounds each per annum, to such persons, male or female, as the Dean of Guild and Directors of the said Merchants' House and their successors in office may deem necessitous and deserving, viz. :—

PATRICK BELL'S MORTIFICATION—
INSTITUTED IN 1641.

Present income of Four Pounds Ten Shillings and Fourpence, to be increased to Ten Pounds per Annum.

JOHN GRAHAME'S MORTIFICATION—
INSTITUTED IN 1700.

Present income of Three Pounds Ten Shillings, to be increased to Ten Pounds per Annum.

JAMES GOVAN'S MORTIFICATION—
INSTITUTED IN 1709.

Present income of Twenty-eight Pounds, to be increased to Thirty Pounds per Annum.

THOMAS PETERS' MORTIFICATION—
INSTITUTED IN 1709.

Present income of Eight Pounds, to be increased to Ten Pounds per Annum.

JOHN AIRD'S MORTIFICATION—
INSTITUTED IN 1721.

Present income of Twenty-two Pounds Two Shillings and Eightpence, to be increased to Twenty-five Pounds per Annum.

THOMAS THOMSON'S MORTIFICATION—
INSTITUTED IN 1724.

Present income of Four Pounds Ten Shillings and Fourpence, to be increased to Ten Pounds per Annum.

DONALDSON'S CLUB MORTIFICATION—

INSTITUTED IN 1754.

Present income of Four Pounds Ten Shillings and Fourpence, to be increased to Ten Pounds per Annum.

JAMES SPREULL'S MORTIFICATION—
INSTITUTED IN 1769.

Present income of Four Pounds, to be increased to Ten Pounds per Annum.

CHARLES SELKIRK'S MORTIFICATION--
INSTITUTED IN 1770.

Present income of Two Pounds Four Shillings, to be increased to Ten Pounds per Annum.

III. That the yearly income of the MORTIFICATION instituted by ROBERT SANDERS of AULDHOUSE, in the years 1726 and 1729, for payment of Apprentice Fees of Five Pounds Eleven Shillings and Three Halfpence each, amounting to Fifty-two Pounds Four Shillings and Fourpence per Annum, after deducting the Bursary founded by him of Eight Pounds Six Shillings and Eightpence per Annum, shall be combined with the annual income, Three Pounds Twelve Shillings, of the sum mortified by JAMES WARDROP in the year 1824 'for the Education and Clothing of an Auldhouse Apprentice,' and shall be increased out of the Funds of the said Merchants' House to Sixty Pounds per Annum, and be applied in affording instruction to Boys, elected by the said Dean of Guild and Directors and their successors in office, in Schools or Establishments where Scientific or Technical Education can be obtained, under such regulations as to attendance, proficiency, and other details as may from time to time be suggested by the Governors and Managers of such Schools or Establishments, and be approved of by the said Dean of Guild and Directors.

IV. That the following BURSARIES in DIVINITY at the University of Glasgow, viz. :—one of Five Pounds Ten Shillings per Annum, instituted by the REVEREND ZACHARY BOYD, in the Year 1635, and one of Eight

Pounds Six Shillings and Eightpence per Annum, instituted by the said ROBERT SANDERS of AULDHOUSE, in the Year 1726, shall be combined into one Bursary, and shall be tenable by a Student attending the ordinary curriculum in the Faculty of Theology at the said University.

V. That the BURSARY in PHILOSOPHY at the University of Glasgow of Eight Pounds Six Shillings and Eightpence per Annum, instituted by JOHN CRAIG, in the Year 1697, shall be augmented to Twenty-Five Pounds per Annum out of the Funds of the said Merchants' House, and shall be tenable by a Student of Philosophy attending the ordinary curriculum in the Faculty of Arts at the said University.

VI. That a Preliminary Test Examination of the Candidates for the before-mentioned Bursaries shall be instituted, the standard of and regulations for which shall from time to time be submitted by the Senate of the University of Glasgow for the approval of the said Dean of Guild and Directors, and their Successors aforesaid.

VII. That the Preferential Names respectively stipulated by the Founders of the said Bursaries, for the holders thereof, shall continue to be observed, but only *cæteris paribus* and after the Candidates shall have passed the Test Examination.

VIII. That the said Dean of Guild and Directors, and their Successors in office, shall have power, if they see fit at any time, to make a selection from among the Candidates who have passed the Test Examination for the before-mentioned Bursaries, or any of them, having regard not merely to merit, as displayed by the examination, but to the circumstances of the Candidate, and to present the Candidate so selected to such Bursary, subject to the regulations which may then be in force for the tenure thereof.

IX. That your Petitioners are possessed of property and effects under their own exclusive control, amply sufficient to provide for and secure the augmentation proposed to be made in the revenue of the Mortifications hereinbefore mentioned. There is herewith submitted a printed report of the affairs of the Merchants' House for the year ending the thirty-first August eighteen hundred and seventy-eight, showing the capital and revenue of that Institution.
