For his gallant conduct at the retreat at Inhlobana, on the 28th March 1879, in having assisted, whilst hotly pursued by Zulus, in rescuing Captain C. D'Arcy, of the Frontier Light Horse, who was retiring on foot, and carrying him on his horse until he overtook the rear guard. Also for having on the same date and under the same circumstances, conveyed Lieutenant C. Everitt, of the Frontier Light Horse, whose horse had been killed under him, to a place of safety. Later on, Colonel Buller, in the same manner, saved a trooper of the Frontier Light Horse, whose horse was completely exhausted, and who otherwise would have been killed by the Zulus, who were within 80 yards of him.				
1st Battalion Regiment	13th	Major William K. Leet .	For his gallant conduct, on the 28th March 1879, in rescuing from the Zulus Lieutenant A. M. Smith, of the Frontier Light Horse, during the retreat from the Inhlobana.  Lieutenant Smith whilst on foot, his horse having been shot, was closely pursued by the Zulus, and would have been killed had not Major Leet taken him upon his horse and rode with him, under the fire of the enemy, to a place of safety.				
Army Medical partment	De-	Surgeon - Major James Henry Reynolds	For the conspicuous bravery, during the attack at Rorke's Drift on the 22d and 23d January 1879, which he exhibited in his constant attention to the wounded under fire, and in his voluntarily conveying ammunition from the store to the defenders of the Hospital, whereby he exposed himself to a cross-fire from the enemy both in going and returning.				
1st Battalion Regiment	24th	Lieutenant Edward S. Browne	For his gallant conduct, on the 29th March 1879, when the Mounted Infantry were being driven in by the enemy at Inhlobana, in galloping back and twice assisting on his horse (under heavy fire and within a few yards of the enemy) one of the mounted men, who must otherwise have fallen into the enemy's hands.				
80th Regiment	•	Private Wassall	For his gallant conduct in having, at the imminent risk of his own life, saved that of Private Westwood, of the same regiment.  On the 22d January 1879, when the Camp at Isandhlwana was taken by the enemy, Private Wassall retreated towards the Buffalo River, in which he saw a comrade struggling, and apparently drowning. He rode to the bank, dismounted, leaving his horse on the Zulu side, rescued the man from the stream, and again mounted his horse, dragging Private Westwood across the river under a heavy shower of bullets.

In pursuance of an Order by the Right Honourable Richard Assheton Cross, one of Her Majesty's Principal Secretaries of State, dated 12th June 1879, made under the provisions of The Endowed Institutions (Scotland) Act, 1878, 41 and 42 Victoria, c. 48, Intimation is hereby given that there has been presented to the aforesaid Secretary of State a Petition by Sir John Marjoribanks of Lees, Baronet; Watson Askew of Pallinsburn, Esquire; David Greig, Fellow of the Royal College of Surgeons of Edinburgh, residing at No. 38 Coates Gardens, Edinburgh; John Sibbald Ritchie, Accountant, Gilmore Place, Edinburgh; John Currie, Chemist, Sauchiehall Street, Glasgow; David Douglas, Bookseller in Edinburgh; William Marjoribanks, residing at Leamington; Patrick Heron Watson, M.D., present President of the Royal College of Surgeons of Edinburgh; and James Donaldson, Doctor of Laws, present Rector of the High School of Edinburgh, Trustees of the Deceased John Robertson Sibbald, Esquire, of No. 8 Newington Terrace, Edinburgh, Doctor of Medicine, and Fellow of the Royal College of Surgeons of Edinburgh, in the following terms:-

'That your Petitioners are the governing body, as defined by the Endowed Institutions (Scotland) Act, 1878, of a Mortification of Bequest for the establishment and maintenance of certain Bursaries at the High School of Edinburgh, and at the University of Edinburgh, and a Scholarship at the said University, under and by virtue of—(First), The Holograph Will or General Trust-Disposition and Settlement of the said John Robertson Sibbald, dated 15th June, and with sundry other Testamentary Writings executed by him, recorded in the Books of Council and Session on the 31st day of October, both in the year 1868, of which a Copy will be found annexed; and (Second), Amended Scheme by the Petitioners for the Endowment of said Bursaries at the High School of Edinburgh, and the University of Edinburgh,

and of a Scholarship at the University of Edinburgh, approved of by the Lords of Council and Session on 19th May 1871, and recorded in the Books of Council and Session on the 3d day of June thereafter, of which Amended Scheme a print is sent herewith.

'That at a meeting of your Petitioners, being the governing body of the said Endowed Institution, specially called for the purpose, and held at Edinburgh on a month's notice, on the 5th day of June 1879, it was resolved, in terms of section fourth of said Act, by the unanimous resolution of those present at that meeting, that it is expedient that provision should be made for the better application of the endowment of the said Bursaries and Scholarship, and that an application should be made to the Secretary of State for a Provisional Order.

'That your Petitioners have now had under their management the bestowal of the said Bursaries and Scholarship for a period of nine years, and your Petitioners have come to be of opinion, and desire, and respectfully suggest, that the following alterations may be sanctioned:—

'I. Bursaries at the High School of Edinburgh.

'1. That these Bursaries should be open to competition by all who wish to become pupils of the High School, and that the restrictions in Articles 2 and 9 of the Amended Scheme shall be cancelled.

'2. That the Petitioners shall have the power of the bestowal of these Bursaries as regards their duration for such period of years as may be most in harmony with the special circumstances of the school and of the candidates.

'II. Bursaries at the University of Edinburgh.

'3. That these Bursaries should also be made open to competition by all students entering the University for the first time, who have not previously attended any University in the United Kingdom or elsewhere, and who do not hold any other Bursary or Scholarship, but that attendance at the University of Edinburgh during the previous summer session in any of the classes required by the Faculties of Medicine or Law shall not be regarded as a disqualification, and that Article 9 of the Amended Scheme shall be cancelled.

'4. That the Petitioners shall have the power of bestowal of these Bursaries as regards their duration for such a period of years as they may consider to be most in harmony with the special circumstances at the time.

'III. Scholarship at the University of Edinburgh.

'5. That the Petitioners shall have the power of bestowal of this Scholarship as regards its duration for such a period of years as they may consider to be most in harmony with the special circumstances, and that the Principal of the University of Edinburgh be appointed a Trustee, ex officio, in order that there may be adequate representation of the University in the body of Trustees.

'That the Petitioners desire that sanction should be given generally to enable them to frame their own rules for the bestowal of the Bursaries and Scholarship, of which they are the governing body, in conformity with what may appear to them to be best calculated to promote the interests of the Bursars and of the High School of Edinburgh and

the University of Edinburgh.

'May it therefore please you, Sir, after such publication and inquiry as the foresaid Act prescribes, or you may see fit to appoint, to issue a Provisional Order in relation to the Bursaries and Scholarship mentioned in [ this Petition, and in accordance therewith, and to cause the same to be laid before both Houses of Parliament, as required by the said Act.
