(SCOTLAND) ACT, 1878.

Unto the Right Honourable Richard Assheton one of Her Majesty's Principal Secretaries of State, the Petition of the Reverend Alexander Watson Brown, Minister of the East Parish, Aberdeen, now residing in Stirling; the Reverend Charles M'Gregor, Assistant and Successor in said Charge; the Reverend James Mitford Mitchell, B.A., Cantab, Minister of West Parish, Aberdeen; the Reverend William Wilson, Minister of North Parish, Aberdeen; the Reverend James K. Duncan, Minister of South Parish of Aberdeen, now residing in Glasgow, and the Reverend William D. Scott, Assistant and Successor in said Charge; the Reverend Joseph Henderson, Minister of Greyfriars Parish, Aberdeen; the Reverend Charles Cadell M'Donald, Minister of St. Clement's Parish, Aberdeen; and Thomas Melville of Westfield, Alexander Eddie, late Baker, William Yeats of Auguharney, Robert Gerard, Merchant, and the Reverend Daniel Baxter, late Prison Chaplain, all of Aberdeen, Trustees acting under the Deed of Mortification of the deceased James THAIN, Merchant in Aberdeen, dated 14th April 1788, and recorded in the Commissary Court Books of Aberdeen 19th February 1798.

Humbly Sheweth,

THAT your Petitioners are the Governing Body as defined in the Endowed Institutions (Scotland) Act, 1878, of a Bequest for the establishment and support of a Charity School for the instruction of children only of indigent parents residing in the City of Aberdeen, in reading, writing, arithmetic, and book-keeping, and the principles of the holy Christian religion, without payment of fees.

The said James Thain of the same date as his Deed of Mortification transferred to his Trustees the sum of £400. He afterwards, by Testament dated 9th and 19th July 1793, and recorded in the Commissary Court Books of Aberdeenshire 11th October 1794, bequeathed the reversion of his Executry Estate for the support of the Charity

School founded by him.

The residue realized for behoof of the School under Mr. Thain's Will amounted to upwards of £700; and through subsequent additions from other sources, the funds at 31st May 1879, the date of the annual balance, amounted to £3205, 12s. 10d.

The School was conducted in terms of Mr. Thain's directions in a house in Shiprow, Aberdeen, purchased for the purpose in 1803, and was largely attended by children of the class pre-

scribed.

Owing, however, to the limited revenue of the fund, and the great rise in the salaries of teachers since the date of the Mortification, the Trustees found increasing difficulty, when vacancies occurred, in procuring the services of well qualified teachers, the revenue of the Trust allowing a salary to the master of only, £80, and to his assistant £30.

The School premises were also unsuitable for

UNDER THE ENDOWED INSTITUTIONS | the accommodation of more than from 120 to 150 at the utmost.

In October 1876, in consequence of operations carried on in the erection of a church on the site immediately adjoining the School, a large portion of the wall of the School fell down, and besides this, the walls of the church were erected so near the windows of the School-room as to render it unsuitable for its purpose.

In these circumstances, the children were accommodated in temporary premises, and it was resolved to effect a sale of the premises. After advertisement, they were exposed to public sale at the upset price of £300, and sold for £320 on 15th

February 1877.

The Trustees did not consider it expedient to lock up their funds in the purchase or erection of School premises, which could only have been done at a cost far exceeding the price received for the old buildings. On careful consideration of the terms of the Trust Deed and the main objects contemplated by the Testator, they resolved that the children selected by them for the benefit of the Trust should be sent to schools under the School Board of Aberdeen, or to others, where the branches of education prescribed by the Deed were taught to the satisfaction of the Trustees, the school fees to be paid from the Trust funds.

In pursuance of this resolution, the School was closed on 16th March 1877, and the children in attendance, numbering under 100, were transferred to public schools under the Board, and other ap-

proved schools in the town.

This arrangement has been in existence now for two and a half years, and has proved to be a great

improvement on the former system.

The children have the advantage of being taught by superior teachers, and also of associating with other children, in place of being all herded together as charity scholars. At the same time, the number educated has been largely increased, there being over 200 children on the roll.

The Trustees are desirous of availing themselves of the provisions of the Endowed Institutions (Scotland) Act, 1878, in order to obtain the sanction of Parliament to the existing arrangement; and at a meeting, held in terms of the fourth section of said Act, they resolved to apply for a Provisional Order for that purpose.

As respects the future government of the Trust, some change appears to the Trustees to be desir-

At the date of the Trust Deed, the Parish of St. Nicholas or Aberdeen was undivided, there being four ministers, two congregations, and one kirk session.

In 1828 the Parish of St. Nicholas was divided into six separate parishes, with separate ministers and separate sessions, but the general session was maintained, not as an ecclesiastical court, but for the management of certain mortified funds and other purposes. Since the date mentioned, the other purposes. Since the date mentioned, the acting Trustees have been the six ministers and five elders elected by the general session.

A further division of the parish has recently taken place, by the erection of Trinity Parish; and steps are being taken for the erection of other two It is suggested, therefore, that the Governing Body in future should be the whole of the parish ministers of the parishes within the original Parish of St. Nicholas, and in the event of any of said ministers being unable for the discharge of his parochial duties, that his assistant and successor, duly appointed, should on his

absence act as Trustee, together with an equal number of elders elected by the general session.

Your Petitioners would respectfully suggest the following heads for a Provisional Order, to be

sanctioned in terms of the Statute:

1. That the Governing Body of the Trust should consist of all the Parish Ministers of the original Parish of St. Nicholas, and in their absence, their respective assistants and successors, where such have been duly appointed, together with an equal number of Elders, Members of the General Kirk Session, and appointed by said Session in terms of Mr. Thain's Deed.

2. The beneficiaries to be selected from the children of indigent parents residing within the area embraced in the municipal boundary of the City of Aberdeen, the selection to be made at such times and under such conditions as may from time to time be prescribed by the

Trustees.

3. The children to be educated at the public schools in the City of Aberdeen, which are under the management of the Aberdeen School Board, and at such other schools of recognised efficiency as the Trustees may approve, provided that in all the schools to which the children may be sent, instruction is given in reading, writing, arithmetic, and book-keeping, and the principles of our holy Christian religion.

4. That the fees for the instruction of the children at said Schools shall be defrayed out of the annual revenue of the Trust; and also the cost of supplying school books for the children in such cases as the Trustees may think

it necessary to supply them.

5. That the stock of the fund shall be held to consist of £3000 of the Trust funds now held by the Trustees, and in the event of legacies or donations being received for the purposes of the Trust, the Trustees should have power to receive and apply them accordingly,-all sums of £100 and upwards, or which the Donors or Testators may so direct, to be added to the stock.

6. That the annual revenue of the said stock be applied exclusively to the payment of school fees and books and the expenses of management; and the Trustees shall also be at liberty, in addition to said annual revenue, to expend for the foresaid purposes, the balance, or such portion of the balance as they may consider necessary, of any other funds in their hands, other than the capital or stock aforesaid.

May it therefore please you, Sir, after such publication and inquiry as the foresaid Act prescribes, or as you may see fit to appoint, to issue a Provisional Order in relation to the powers requisite in this Petition and in accordance therewith, and to cause the same to be laid before both Houses of Parliament as required
