Any Nobleman or Gentleman who proposes to be presented to The Queen, must leave, at the Lord Chamberlain's Office, St. James's Palace, before twelve o'clock, two clear days before the Levee, a card with his name written thereon, and with the name of the Nobleman or Gentleman by whom he is to be presented. In order to carry out the existing regulations, that no presentation can be made at a Levee excepting by a person actually

attending that Levee, it is also necessary that an intimation from the Nobleman or Gentleman who is to make the presentation, of his intention to be present, should accompany the presentation card above referred to, which will be submitted to The Queen for Her Majesty's approbation. It is Her Majesty's command that no presentations shall be made at Levees, except in accordance with the above regulations.

It is particularly requested that in every case the names be very distinctly written upon the cards to be delivered to the Lord Chamberlain, in order that there may be no difficulty in announcing them to The Queen.

#### ADDRESSES.

#### FORTH BRIDGE RAILWAY.

(Alteration of Levels of part of Railway No. 1 (the Railway and Bridge across the Forth) authorized by 'The Forth Bridge Railway Act, 1873; Purchase of Lands, &c.; Tolls; Altered Railways for all purposes to be held a portion of Undertaking of Company, and as if constructed under 'The Forth Bridge Railway Act, 1873; Repeal, Alteration, or Amendment of Sections 21, 22, and 24 of 'The Forth Bridge Railway Act, 1878; 'Establishment of Fund for Upholding and Repairing portion of Railway consisting of Bridge over the River or Firth of Forth; New Application of Moneys to be applied to Payment of Interest on Capital during Construction of Works under Section 24 of 'The Forth Bridge Railway Act, 1878;' Incorporation of Acts; Amendment of Acts; and other purposes.)

OTICE is hereby given, that application is intended to be made to Parliament in the Session of 1880 for leave to bring in a Bill for all or some of the following purposes (that is to say):—

1. To enable the Forth Bridge Railway Company (hereinafter referred to as the Company) to alter the levels of the Railway authorized by, and firstly described in, 'The Forth Bridge Railway Act, 1878,' and therein referred to as Railway No. 1 (the Railway and Bridge across the Forth), commencing in the Parish of Dalmeny at a point 44 yards or thereabouts measuring in a northerly direction from the commencement of Railway No. 1, as shown on the plans and sections of that Railway deposited for the purposes of the said Act in the month of November 1872 with the principal Sheriff-Clerk of the County of Edinburgh at his Office in Edinburgh, and with the principal Sheriff-Clerk of the County of Linlithgow at his Office in Linlithgow, and with the principal Sheriff-Clerk of the County of Fife at his Offices in Cupar and Dunfermline respectively, and terminating in the Parish of Dunfermline at a point 66 yards or thereabouts measuring in a southerly direction from the point marked two miles from the commencement of the said Railway No. 1 on the plans and sections deposited as aforesaid:

All which alteration in levels and works incident thereto will be situated in the Parishes of Dalmeny, South Queensferry, the Royal Burgh of South Queensferry, all in the County of Linlithgow, the bed and soil of the Firth of Forth, and the Island of Inchgarvie (the said bed and soil of the Firth of Forth and the Island of Inchgarvie being in or adjacent to the said Parish of Dalmeny and County of Linlithgow, or in or adjacent to the Parish of Dunfermline in the County of Fife, or in or adjacent to the Parish of Inverkeithing, otherwise Inverkeithing and Rosyth, and County of Fife) and the Parishes of Dunfermline, Inverkeithing, otherwise Inverkeithing, and Rosyth, and Royal Burgh of Inverkeithing, all in the County of Fife, or some or one of them:

2. To empower the Company to cross, divert, alter, or stop up, or otherwise interfere with, either temporarily or permanently, turnpike roads, streets, highways, roads, railways, tramways,

bridges, drains, sewers, navigations, rivers, canals, streams, and water courses, gas, water, and other pipes, telegraphs, and telegraphic apparatus, and the bed and soil of the Firth of Forth, in the Parishes and places hereinbefore mentioned, so far as may be necessary in constructing, maintaining, or using the said intended Railways and works, or for other the purposes of the Bill, and to deviate vertically from the levels of the said line as shown upon the plans and sections hereinafter mentioned, to any extent to be authorized by the Bill:

3. To empower the Company to enter upon, purchase, take, and use, temporarily or permanently, by compulsion or otherwise, and to hold all such lands, houses, and other property, and the bed and soil of the Firth of Forth in the Parishes and places aforesaid, as may be necessary or convenient for the purposes of the said Railway, alteration of levels and works, and of the Bill, and to vary and extinguish all rights and privileges connected therewith, or which would interfere with or prevent the carrying into execution any of the purposes of the said Bill, and to confer, vary, or extinguish other rights and privileges:

4. To empower the Company to levy tolls, rates, and charges for or in respect of the use of the Railway and works; and to confer, vary, or extinguish exemptions from the payment of tolls, rates, and charges:

5. To enable the Company to apply to the purposes of the Bill any portion of their capital or funds:

6. To provide that the Railway No. 1 authorized by 'The Forth Bridge Railway Act, 1873,' when altered as before described, shall for all purposes, and for all the purposes of 'The Forth Bridge Railway Act, 1873,' 'The Forth Bridge Railway Act, 1876,' 'The Forth Bridge Railway Act, 1878,' and 'The Forth Bridge Railway Act, 1879,' be held to be a portion of the Undertaking of The Forth Bridge Railway Company, and of the Railway No. 1 authorized by 'The Forth Bridge Railway Act 1873,' and as if the same Railway when altered had been constructed under the authority of those Acts:

7. To amend, alter, or repeal, or to re-enact with such alterations as may be thought expedient, section 21 of 'The Forth Bridge Railway Act, 1878,' and to provide for the establishment of a fund towards the upholding and repairing that portion of the said Railway No. 1 which consists of the Bridge over the River or Firth of Forth out of the surplus revenue referred to in that section, and to make other provisions in lieu of those contained in that section with reference to the surplus revenue therein referred to, or to make such other provisions with reference to the matters aforesaid as the said Bill may contain or Parliament may enact:

8. And it is proposed to repeal or alter the twenty-second section of 'The Forth Bridge Railway Act, 1878,' by which an option is conferred upon the North British Railway Company at any time of applying to Parliament for power to purchase and acquire, and of acquiring, the whole estate, property, and effects whatsoever of the Forth Bridge Railway Company, with the concurrence and upon the terms and conditions therein mentioned:

9. And it is proposed to alter, amend, or repeal, or to re-enact with such alterations as may be

thought expedient, section 24 of 'The Forth the Solicitors and Parliamentary Agents of the Bridge Railway Act, 1878;' and to make such Company. other and further provisions with respect to the matters therein referred to, and the application of the moneys thereby authorized to be applied to payment of interest on capital during the construc-tion of the works by the Forth Bridge Railway Acts authorized, as the Bill may provide or Parliament enact:

10. Also to make provision for regulating the passage of ships or vessels under the said Railway Bridge, and the passage of traffic over the said Bridge, and to confer powers on the Company with reference to those matters.

11. The Bill will vary and extinguish all existing rights and privileges inconsistent with or which would in any way interfere with any of its objects, and will confer other rights and privileges; and it will incorporate with itself the necessary provisions of

'The Lands Clauses Consolidation (Scotland)

Act, 1845;' Clauses Consolidation Acts Amendment Act, 1860;

'The Railways Clauses Consolidation (Scotland) Act, 1845;' and

'The Railways Clauses Act, 1863.'

12. The Bill will, so far as may be necessary or expedient, repeal, alter, or amend the provisions, or some of the provisions, of the local and personal Acts following (that is to say) :-

'The Forth Bridge Railway Act, 1873; 'The Forth Bridge Railway Act, 1876; 'The Forth Bridge Railway Act, 1878;' and 'The Forth Bridge Railway Act, 1879.

# STRATHENDRICK AND ABERFOYLE RAILWAY.

(Application to Parliament to sanction a Petition for Additional Provision for the Alteration of Railway and other Matters.)

OTICE is hereby given that application is intended to be made to the House of Lords in the present Session, by Petition, as soon as the forms of the House will permit, for leave to introduce into the Strathendrick and Aberfoyle Railway Bill (hereinafter referred to as 'the Bill'), now pending in that House, an additional provision to enable the Company proposed to be incorporated under the Bill (hereinafter called 'the Company'), to make the following alteration in the line of Railway No. 2 proposed to be authorized by the Bill, viz. :-

The Railway No. 2, in place of commencing by a junction with the Forth and Clyde Junction Railway at the point specified in the Bill, is intended to commence by a junction with that Railway at a point in the Parish of Drymen and County of Stirling 5\frac{3}{4} chains or thereabouts measuring in a north-easterly direction from the Bridge carrying the Forth and Clyde Junction Railway over the Road leading from Woodend Farm Steading to the Village of Bucklyvie, and to terminate at a point in the Parish of Aberfoyle and County of Perth 7 chains or thereabouts measuring in a south-easterly direction from the House called 'Bailie Nicol Jarvie's Inn' at Aberfoyle, which Railway will pass from, in, through, or into, or be situated within the Parish of Drymen, in the County of Stirling, and the Parishes of Port of Monteith and Aberfoyle, in the County f Perth, or one or some of them.

It is intended to extend to the Railway No. 2, as now intended to be made, such of the powers and provisions contained in the Bill with respect to the Railways therein described as may be applicable to the Railway No. 2 as proposed to be altered, and to make such amendments in the Bill, and add such clauses thereto as have been agreed or may hereafter be agreed upon between the Company and the Blane Valley Railway Company, the Forth and Clyde Junction Railway Company, the North British Railway Company, or any of them.
