Special Regulations (Supplementary to the General Regulations, issued 8th April 1872, and amended by subsequent notices in the London Gazette) respecting Open Competitive Examinations for the situation of Second Class Clerk at the Outports in the Department of Her Majesty's Customs.

N.B.—These Regulations are liable to alteration for future Examinations.

- 1. The limits of age for this situation are 17 and 20, and Candidates must be of the prescribed age on the first day of the competitive examination.

- 3. No Candidate can be admitted to the competition who has not previously satisfied the Civil Service Commissioners that he possesses the requisite amount of proficiency in the following subjects:—
 - 1. Handwriting.
 - Orthography.
 Arithmetic (to Vulgar and Decimal Fractions).

With this view, preliminary examinations in these subjects will be held at such times and places as the Commissioners may appoint.

- 4. Application for admission to attend a preliminary examination must be made in the writing of the Candidate, at such times and in such manner as may be fixed by the Commissioners.
- 5. A fee of £1 will be required from every Candidate attending a preliminary examination, and a further fee of £1 from every Candidate who may be admitted to the competition.
- 6. At each Competitive Examination the number of Candidates to be selected will be such as may be necessary to fill the vacancies which the Civil Service Commissioners, with the approval of the Lords of the Treasury, shall estimate as the number which will probably have to be filled within six months after the date of the publication in the London Gazette of the Notice of the Examination.*
