UNDER THE ENDOWED INSTITUTIONS (SCOTLAND) ACT, 1878.

Unto the Right Honourable Sir William Granville Vernon Harcourt, one of Her Majesty's Principal Secretaries of State, the Petition of the Reverend Robert Ross, Minister; and James Ritchie, Eastertown of Auchleuchries; George Craig, Nook; James Abel, Hay Farm; William Gray Cantlay, Bridgend; Alexander Henderson, Greenhill; James Boddic, Parkhead; Benjamin Alcock, Schoolmaster, Auchiries; Hutchison, Hardslacks; and William Davidson, Wright, Hatton,-all of the Parish of Cruden, in the County of Aberdeen, and elders of said Parish, the sole remaining Trustees acting under a provision in the Trust Disposition and Settlement of the deceased JAMES DUNCAN, sometime Farmer at Kinmuck, in the Parish of Ellon, Aberdeenshire, dated 6th September 1839, and with four Codicils thereto, dated respectively 11th September 1840, 11th September 1840, 20th August 1841, and 6th July 1842, recorded in the Commissary Court Books of Aberdeen on 21st November 1842,-

Humbly Sheweth,

HAT your Petitioners are the Governing Body, as defined in the Endowed Institutions (Scotland) Act, 1878, of a bequest of one hundred pounds sterling, made by the said James Duncan, by his Trust Disposition and Settlement before mentioned, and from which Extracts so far as applicable to said bequest are hereto annexed.

The object and purpose of the bequest is for paying the interest of the foresaid principal sum of one hundred pounds to the teacher of the school at Little Mains of Auchleuchries, in said Parish of Cruden, for the gratuitous instruction of three scholars to be named by the said Trustees.

The said sum of one hundred pounds was duly paid to and invested by said Trustees, and the

interest thereof was accounted for to the teacher of the said school, in terms of the bequest, up to the end of the year eighteen hundred and seventy-two, when the said school at Little Mains of Auchleuchries was abandoned on the death of the teacher.

In virtue of the Education Act, 35 and 36 Victoria, cap. 62, the farm of Little Mains of Auchleuchries, on which the said school was erected, although situated in the Parish of Cruden quoad civilia, yet being within the district now forming the quoad sacra Parish of Ardallie, has since the passing of said Act been included in the district provided for by the Ardallie School Board; but as there has been no teacher at the school on said farm since the above date, the Trustees have not considered themselves warranted in appropriating the revenue of the one hundred pounds, and it has therefore been accumulating, and amounted as at 11th November last to £44, 13s. 4½d.

The above accumulation of interest, if added to the original sum of one hundred pounds, would be amply sufficient to provide the means of education on the scale contemplated by the testator for from four to six children.

The Trustees are desirous of availing themselves of the provisions of 'The Endowed Institutions (Scotland) Act, 1878,' for the purpose of obtaining a Provisional Order to regulate the future administration of the bequest, and the application of the revenue thereof; and at a meeting held in terms of the fourth section of that Act they resolved to make an application for such order.

It is suggested that with the view of giving a voice in the management of said trust to the representatives of the said quoad sacra Parish of Ardallie, it might be expedient and proper to nominate from the kirk session of said Parish the minister and one elder to act along with the minister and two elders of the kirk session of the Parish of Cruden, in lieu of the whole kirk session of Cruden, to whom the Trust was originally confided.

Your petitioners would respectfully suggest the following heads for a Provisional Order to be sanctioned in terms of the Statute:—

- 1. That the interest of the said bequest since eighteen hundred and seventy-two to the date of the Provisional Order, shall be added to the sum invested, and form with it the capital sum to be held in trust.
- 2. That the Trustees for managing the said Trust shall hereafter consist of the ministers of the Parishes of Cruden and Ardallie, with two elders from the kirk session of the Parish of Cruden and one elder from the kirk session of the Parish of Ardallie, the elders to be chosen by the respective sessions of Cruden and Ardallie for periods of five years, but with power to the respective sessions to fill up vacancies which may occur during the currency of any such period.
- 3. That the Trustees shall have power to pay the annual interest of the said fund for the education of from four to six children, to be selected by them from residents on or in the immediate neighbourhood of said farm of Little Mains of Auchleuchries, to the teacher or teachers of the neighbouring schools most convenient and suitable for the education of such children, and that in other respects the directions of the bequest shall in so far as competent be adhered to in the future administration of the Trust.

'Whereas I am aware of the limited funds for the support of a teacher at the school at Chapeltown of Boisick, in the said Parish of Inverkeillor, where I received the first of my education—as also at that remote part of the Parish of Ellon called Inveribory, and also at the farms of Little Mains of Auchleuchries, in the Parish of Cruden, and being desirous of assisting in the promotion of education at the various places whereat schools have been opened, I do leave and bequeath for that purpose'

' to the minister and elders of the said Parish of ' Cruden, and James Buchan, Esquire of Auchma-'coy, if he shall accept, and while he shall survive, one hundred pounds, to be applied as aftermentioned, for the support of the teacher of ' the said school at Little Mains of Auchleuchries: declaring that the said parties respectively and the successors in office of the said ministers and elders respectively, shall lay out the said several sums on heritable security, in name of themselves and the successors in office foresaid, and shall pay the ' interest drawn by them respectively to the teachers ' of the said schools respectively: declaring also that each of the said teachers shall be bound and obliged to teach and instruct gratis yearly, three scholars to be appointed by the managers of the 'said respective funds, and that the said schools 'shall be subject at all times to the inspection and superintendence of the presbytery of the
