# PRESENT,

The QUEEN's Most Excellent Majesty in Council.

WHEREAS by 'The Weights and Measures Act, 1878,' it is (among other things) enacted, that where the Board of Trade, upon the application of any Local Authority from time to time represent to Her Majesty that it would be expedient to alter the fees taken in respect of the verification and stamping of weights and measures by the Inspectors of such authority under the said Act (whether specified in the Fifth Schedule to the said Act, or in any Order previously made under the 47th section of the said Act), or for the purpose of adapting those fees to the local standards provided by such authority, to add to the said fees, it shall be lawful for Her Majesty, by Order in Council, from time to time to alter or add to the said fees:

And whereas the Board of Trade have, upon the application of the Local Authorities for the connties, city, borough, and burgh named in Schedule A hereto annexed, represented to Her Majesty that it would be expedient to alter and add to the scale of fees taken in respect of such verification and stamping of weights and measures by the Inspectors of such Local Authorities in the manner set forth in Schedule B hereto annexed:

the alterations and additions contained in the lastmentioned Schedule are reasonable and proper:

Now, therefore, Her Majesty, by virtue of the power vested in Her by the said Act, by and with the advice of Her Privy Council, is pleased to alter and add to the fees heretofore taken by the Inspectors of the Local Authorities for the counties, city, borough, and burgh named in Schedule A hereto annexed in the manner set forth in Schedule B hereto annexed; and the fees specified in the last-mentioned Schedule shall be taken accordingly in lieu of the fees specified in the Fifth Schedule to the said Act.

PUBLIC NOTICE IN TERMS OF THE ENDOWED INSTITUTIONS (SCOTLAND) ACT, 1878, SECTION 5.

In terms of Directions by the Right Honourable Her Majesty's Principal Secretary of State for the Home Department, made under the provisions of the Endowed Institutions (Scotland) Act, 1878, 41 and 42 Victoria, cap. 48, it is hereby intimated that a Petition, dated August 1880, has been presented to the aforesaid Secretary of State, by the Trustees or Governors of James SCHAW'S HOSPITAL, -viz., George Syme, present Proprietor of the Estate of Northfield, Prestonpans; the Rev. John Struthers, LL.D., present Minister of the Parish of Prestonpans; the Rev. William Casar, D.D., present Minister of the Parish of Tranent; Thomas Jamieson Boyd, present Lord Provost of the City of Edinburgh, and present Treasurer of the Merchant Maiden Hospital, Edinburgh; Robert Cranston, present eldest Bailie of the City of Edinburgh; John Smith, present Lord Dean of Guild of the City Edinburgh; George Harrison, present Treasurer of the City of Edinburgh; Sir James Falshaw, Bart., present Preses of the Merchant Maiden Hospital, Edinburgh, and present Preses of George Watson's Hospital; John Maclaren, present Treasurer of George Watson's Hospital; John Scott Moncrieff, present Treasurer of the Orphan Hospital; Sir Alexander Grant, Baronet, present Principal of the University of Edinburgh; the Rev. James MacGregor, D.D., and the Rev. James Barclay, M.A., the present Ministers of the Parish of West Church of Edinburgh, -being (with the exception of the present Proprietor of the Estate of Prestongrange, who is a Pupil; Archibald Davidson, present Sheriff-Depute of Mid-Lothian and Haddington, who declined to accept the Trust; and the Right Honourable Lord Moncreiff, Lord Justice-Clerk, present Preses of the Orphan Hospital, who, being Chairman of the Commissioners under 'The Endowed | Institutions (Scotland) Act, 1878,' declines to take any part in the present Petition) the whole Trustees of the late James Schaw, Esq. of Preston, in the County of East Lothian, acting under (1) Trust-Disposition and Settlement by the said James Schaw, dated 4th December 1781, and recorded in the Books of Session (Office O. M.) 20th December 1784; (2) Deed of Divestment and Reconveyance by the Primary Trustees named in the foresaid original Deed of Settlement, in favour of the Residuary Trustees thereby appointed, dated 28th November 1787, and recorded in the Books of Session (Office O. M.) 30th November 1787; and (3) Royal Charter of Incorporation, dated 25th January, and written to the Seal and registered and sealed 5th April, all in the year 1830; -and said Petition is in the following terms:-

THAT the Petitioners, incorporated as aforesaid by Royal Charter, under the Name and Title of 'James Schaw's Hospital,' are desirous of availing themselves of the 'Endowed Institutions (Scotland) Act, 1878,' 41 and 42 Victoria, chapter 48, in order that provision may be made for the better government and administration of the Hospital under their charge.

That it is by the Fourth Section of the said Act enacted that 'It shall be lawful for the governing body of any endowed Institution in Scotland, at a meeting specially called for the purpose at a month's notice, to resolve, by a najority of those present at the meeting, that it is expedient that provision should be made for the better government and administration of such Institution, or for the better application of the endowments thereof, or for the transference of such Institution and the endowments thereof, and that an application should be made to the Secretary of State

for a provisional order.'

That it is by the Fifth Section enacted, that 'On the foresaid resolution being carried, it shall be lawful for the said governing body to present a petition to the Secretary of State, setting out such resolution, and stating the provisions for the better government and administration of such Institution, or the better application of the endowments thereof which they desire to have sanctioned. Upon receipt of any such petition as aforesaid, the Secretary of State may, if he shall think fit, direct such petition to be published in the Edinburgh Gazette in two consecutive numbers thereof, and in one or more newspapers circulating in the county or counties where such Institution is situated, with a view to further

Inquiry.'

That it is by the Sixth Section enacted, that 'The Secretary of State may, if he shall think fit, by writing under his hand, remit to the Commissioners hereinafter mentioned to inquire into the said petition and report thereon to the said Secretary of State; and for the purposes of such inquiry, which shall be held in public, the said Commissioners shall have power, after such public notice as they may think sufficient, to examine witnesses on oath, and to call for such information from, and to require the production of such documents by, the governing body or any other persons as they may consider necessary, and to do all such matters and things

as may seem to them expedient for the purposes of the inquiry. After the holding of such inquiry the Commissioners shall report to the Secretary of State as to whether, in their opinion, the provisional order prayed for should be made, and if so, with what, if any, alterations or modifications therein.'

That it is by the Seventh Section enacted, that 'It shall be lawful for the Secretary of State to issue a provisional order in relation to the several things mentioned in the foresaid petition, either in accordance therewith, or with such alterations or modifications, not being inconsistent with the general principles thereof, as may appear to him to be requisite, or otherwise to refuse to issue such provisional order.'

'Provided always, that in every such provisional order provision shall be made for saving or making due compensation for the vested interests to which any teacher, master, officer, scholar, bursar, exhibitioner, pensioner, or other shall be entitled at the date of such order.'

'Provided also, that if the provisional order shall contain any alterations or modifications as aforesaid, the Secretary of State shall, before signing the order, cause a copy of it to be sent to the governing body, who may, if they think fit, state in writing to the Secretary of State any objections or suggestions respecting such order within one month after the copy thereof was sent to the governing body; and the Secretary of State shall, if he think fit, remit to the Commissioners to report on such objections and suggestions, and shall consider the same, together with the report of the Commissioners.'

That it is by the Eighth Section enacted, that 'The provisional order aforesaid shall not have any effect or operation unless and until the same has been laid before both Houses of Parliament; and it shall be lawful for the Secretary of State, and he is hereby required, as soon as conveniently may be, to cause such provisional order to be laid before both Houses of Parliament; and after such provisional order has lain forty days before Parliament, then, unless within such forty days a resolution has been adopted by one or other of the said Houses disapproving of the said order, such provisional order shall come into operation.'

That it is by the Tenth Section enacted, that 'It shall be lawful for the governing body of an endowed Institution to apply for a provisional order, and such order may provide for the transference of the Institution, and the endowments of such Institution, or part thereof, to the governing body of one or more other endowed Institutions, or to one or more School Boards, subject to the provisions contained in such order.'

That it is by the Fourteenth Section enacted, that 'Nothing herein contained shall be held to limit any of the powers presently enjoyed by any governing body under any Act of Parliament, or provisional order, or charter, or by the foundation grant of the endowed Institution under their government.'

The Petitioners are of opinion that the interests of 'James Schaw's Hospital' would be greatly promoted by their availing themselves of the provisions of the Endowed Institutions (Scotland) Act, 1878, and that the efficiency of the Hospital would not only be increased, but its usefulness very considerably extended, by their taking advantage of the said Act.

With the view of ascertaining the opinions of the Trustees as to whether any action should be taken by Schaw's Hospital in regard to said Act, a Committee, consisting of the Rev. Dr. Struthers, the Rev. Dr. Cæsar, Mr. David Dickson, Mr. John Scott Moncrieff, and Mr. John Maclaren, was appointed at the Quarterly General Meeting of Trustees on 18th October 1878, to consider the matter and to report.

The Committee presented their Report to the Quarterly General Meeting of Trustees on 31st January 1879, when the following Resolution was unanimously agreed to, viz.:—'The Meeting approved of the Committee's Report, and recommitted the whole matter to the same Committee, with the addition of Mr. Harrison, Treasurer of the City, in order that a Scheme might be prepared embodying the changes in the Institution suggested in the Report, with the view of being submitted to a Special Meeting of the Trustees in terms of the Endowed Institutions (Scotland) Act, 1878, for their approval.

A Scheme was accordingly prepared and forwarded to Her Majesty's Principal Secretary of State for the Home Department on 16th June 1879, but this Scheme, after having been remitted to and reported upon by the Commissioners under the Endowed Institutions Act, has been The present Scheme has been drawn up refused. with the consent of the Home Secretary, and upon the lines suggested by the Commissioners in their Report to him.

The following explanations relative to the Foundation, Management, and Benefits of the Hospital are humbly submitted:

The late Dr. James Schaw of Preston, in the county of East Lothian (the founder of the Hospital), died on 3d November 1784, leaving a Trust-Disposition and Settlement dated 4th December 1781, and recorded in the Books of Council and Session 20th December 1784. [Copy Settlement hereto annexed.

By that settlement Dr. Schaw assigned, conveyed, and disponed 'to and in favour of Alexander Alison, Esq., Deputy - Cashier of Excise, James Balmain, Esq., Solicitor of Excise, George Fairholme of Greenhill, Alexander Thomas Account in Farrier and Balant Bernell. son, Accomptant in Excise, and Robert Boswell, Writer to the Signet, and to such of them as shall accept hereof, and to the survivors and last survivor of those accepting, as trustees or trustee, and to their assignees, declaring any three of said trustees to be a quorum, so long as three or more shall remain in life, in trust, always to the ends, uses, and purposes after mentioned, and with and under the burdens, provisions, and reservations after specified, All and whatsoever lands, tenements, heritages, debts, and sums of money, heritable and moveable, household furniture, bed and table linen, silver plate, lying money, bank-notes, horses, carriages, cattle and stocking of every kind, goods, gear, and other heritable and moveable means and effects, of whatever nature, denomination, or designation the same be, resting and pertaining, or that shall be resting and pertaining to me, at the time of my death; together with all and sundry charters, dispositions, pro-curatories, and instruments of resignation, precepts and instruments of sasine, adjudications, heritable and moveable bonds, back-bonds, reversions, tacks, contracts, assignations, bills, decreets, promissory-notes, accompts, and other writs, rights, evidents, and securities whatsoever,

in my favour, with all claims of every kind which I have or may have against any person or persons, and all action, diligence, and execution competent, or that may be competent upon the premises, and all that has followed or may follow thereupon: And particularly, I do hereby convey and dispone to and in favour of my said trustees, and the survivor of them, and to their assignees, as said is, the subjects heritable and moveable after specified, viz., All and Whole my lands and barony of Preston and Prestonpans, with the free burgh of barony of Preston, and free sea-port and harbour for ships of the same, with the whole privileges, liberties, casualties, and commodities whatever, pertaining and belonging to the said free burgh of barony, and free port and harbour aforesaid, with the manor-place of Preston, houses, biggings, yards, orchards, mills, multures, kains, customs, casualtics and duties, salt-pans, coals, coal-heughs, tenants, tenandries, and services of free tenants, and all privileges, liberties, parts, pendicles, and pertinents of the same whatsoever; as also, all and sundry the teind-sheaves of the said lands and barony of Preston and Prestonpans, with tofts, crofts, outsets, parts, pendicles, and whole pertinents thereof: with the privilege and liberty of a market weekly upon Thursday, and of a free fair yearly, beginning on the first day of October, and continuing for the first, second, and third days of that month, being the fair commonly called St. Jerome's Fair, with the whole tolls and customs of the said weekly market and yearly free fair, all united, erected, annexed, and incorporated by the ancient rights and infeftments thereof, into one free barony called the Barony of Preston, of which the manor-place of Preston is declared to be the principal messuage; and that one sasine to be taken at the said manor-place, or upon any other part of the ground of the said lands, by delivery of earth and stone of the ground of said lands only, without any other symbol, is and shall be sufficient for the said whole lands and barony, all lying within the constabulary of Haddington, and shire of Edinburgh; together with all right, title, or interest, claim of right, property and possession petitory or possessory, which I, my predecessors or authors, heirs or successors, had, have, or anywise may have, claim, or pretend to the aforesaid lands and barony, with the pertinents, or to any part or portion of the same: And also certain other subjects particularly described in the said Trust-Disposition and Settlement.

The purposes of the Trust were by said Settlement declared to be the following :-

Preses and Treasurer of the Orphan's Hospital, also both before mentioned, for the time; the Principal of the University of Edinburgh for the time; and the Ministers of the aforesaid Parish of West Church of Edinburgh for the time; and to any other person or persons whom I shall appoint by any writing or note under my hand at any time during my life; declaring any seven of the said persons to be a quorum, the said Alexander Alison, James Balmain, George Fairholme, Alexander Thomson, and Robert Boswell, or at least three of them, while so many are alive, and the last survivors and survivor of them, while able to officiate, being always members of said quorum, and to such of the aforesaid whole persons as shall accept, and to their assignees; and that also, as trustees, and for the special intent and purpose of founding and endowing an hospital or charitable institution for the aliment, clothing, and education of poor boys, and also for binding said boys apprentices, or otherwise setting them out to business, all in the most frugal and sober manner; to be formed the said institution upon such plan, and to be put under such permanent management and regulations, as my said trustees last appointed, or quorum of them aforesaid, shall, after due deliberation and advice, judge best for accomplishing the above purposes. For the establishment and foundation of which institution, and of all regulations and arrangements necessary and proper for communicating and perpetuating the benefit thereof, I do hereby vest my said trustees last mentioned, and their quorum aforesaid, with the most ample and unlimited powers; ratifying hereby and approving of the whole plan, regulations, and arrangements so to be made and established by them, and declaring the same to be as valid, binding, and effectual in every respect, as if made and established by myself, and herein particularly engrossed. The Residuary Trustees were incorporated under the name and title of 'James Schaw's Hospital' in the year 1830, conform to Royal Charter of Incorporation in their favour dated 25th January, and written to the Seal and registered and sealed 5th April 1830.

In pursuance of the Truster's object and directions, the Mansion-house of Preston was fitted up as an Hospital in the year 1789, when 20 boys were admitted as Foundationers. Mansion-house continued to be occupied as an Hospital till the year 1831, when the present Hospital Building was erected.

In the year 1864 the Trustees, with the view of promoting the better education and upbringing of the Foundationers, resolved to admit a limited number of Boys as Day-Scholars, under certain regulations, and in 1868 they further agreed to admit a limited number of Boys as Boarders. Both these changes have been fraught with much benefit, and a very marked improvement has been observed in the Foundationers by the introduction of Day-Scholars and Boarders.

The average number of Boys maintained, clothed, and educated in the Institution during the ninety years of its existence has been twentytwo per annum.
