HE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Act, 1878, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as

1. This Order shall commence and take effect from and immediately after the twenty-second day of February one thousand eight hundred and eighty-one; and shall cease to have effect from and immediately after the thirty-first day of March one thousand eight hundred and eighty-one, except as regards the institution or prosecution of proceedings in respect of an offence committed on or before that day; and words in this Order have the same meaning as in The Animals Order.

2. No animal shall be moved by land or by water from any place or port in England or Wales to any place or port in Scotland.

3. If an animal is moved in contravention of this Order, the owner thereof, and the person

person causing, directing, or permitting the movement, or conveying the animal, and the company or person moving or conveying it, and the owner and the charterer and the master of the vessel in which it is moved, and the consignee or other person receiving or keeping it, knowing it to have been so moved, shall, each according to and in respect of his or their own acts, be deemed guilty of an offence against The Contagious Diseases (Animals) Act, 1878.
