TO THE KING.

*Most gracious Sovereign,*

**W**E, your Majesty's most dutiful and loyal subjects, the General Convention of the Royal Burghs of Scotland, assembled in their annual meeting, according to the ancient statutes of this realm, take the opportunity to return your Majesty our grateful acknowledgements for your successful exertions in restoring to your people the blessings of peace.

Representing, as we do, the commercial and manufacturing interests of this part of the united Kingdom, we take a warm concern in an event, which, amidst the wreck of nations, has not only preserved entire your Majesty's dominions and our glorious Constitution, but which, we trust, will enable us to make the most beneficial use of those resources, which the wisdom and vigour of your Majesty's Councils have carried unimpaired through the calamities of war.
