**T**HE Civil Service Commissioners hereby give notice, that an Open Competitive Examination for the situation of Clerk in the Solicitor's Offices of the Treasury, Post Office, Inland Revenue, and Customs Departments, and in the Office of the Examiner of Criminal Law Accounts, will be held in London, under the Regulations dated 5th August 1881, and published in the London Gazette of the same date, on Friday the 29th February 1884, and following days.
