BY THE KING.—A PROCLAMATION.
GEORGE R.

Whereas our Parliament which we summoned to meet at Westminster upon Tuesday the thirty-first day of August last, stands prorogued to Tuesday the fifth day of October next; we, with the advice of our Privy Council, do, for divers weighty reasons, hereby publish and declare, that the said Parliament shall be further prorogued on the said fifth day of October next to Tuesday the sixteenth day of November next: And we have given order to our Chancellor of that part of our united kingdom called Great Britain to prepare a writ patent, under our great seal, for proroguing the same accordingly. And we do further hereby, with the advice aforesaid, declare our royal will and pleasure, that the said Parliament shall, on the said sixteenth day of November next, be held and sit for the dispatch of divers urgent and important affairs. And the Lords Spiritual and Temporal, and the Knights, Citizens, and Burgeesses, and the Commissioners for Shires and Burghs of the House of Commons, are hereby required and commanded to give their attendance accordingly at Westminster on the said sixteenth day of November next:

Given at our Court at Windsor the eighteenth day of September one thousand eight hundred and two, in the forty-second year of our reign.

GOD SAVE THE KING.

[The Gazette also contains an order of Council, importing that information having been received that a malignant fever is now raging in the city of Philadelphia, in the state of Pennsylvania, and Baltimore, in Maryland, within the United States of America, all vessels from those ports arriving in Great Britain, or in the islands of Jersey, Guernsey, &c. must perform a quarantine of fourteen days, at the places appointed by an act of 29th July 1802.]

TO THE CREDITORS OF
JAMES MACKENZIE, Innkeeper in Portpatrick.

At a general meeting of the creditors of the said James Mackenzie, held at Portpatrick, on the 24th day of August last, Alexander McHeel, writer in Stranraer, was unanimously elected trustee upon the said James Mackenzie's sequestrated estate, and his nomination has been since confirmed by the Lord Ordinary on the bills. Upon the application of the said trustee, the Sheriff of Wigton has appointed Tuesday the 28th of September next, and Thursday the 14th of October next, for the public examination of the bankrupt, and that each day at 12 o'clock noon, within the Ordinary Court-house of Wigton; the trustee farther intimates, that a meeting of the said James Mackenzie's creditors is to be held, at the same place, on Wednesday the 15th day of October next, at 11 o'clock forenoon, for instructing the trustee as to the management and recovery of the estate; and such of the creditors of the said James Mackenzie as have not already produced, are hereby required to produce, in the trustee's hands, their claims and vouchers or grounds of debt, with their oaths on the verity thereof, at or previous to the said meeting; and the trustee farther intimates, that unless the said productions are made between and the 14th day of May next (being ten months after the date of the first deliverance on the petition of sequestration), the party neglecting shall have no share in the first distribution of the debtor's estate.—Of all which this intimation is given in terms of the statute.

That at a meeting of the creditors of the said John Duke, held upon the 17th day of September curt.
