MIXED MARRIAGES in the United Kingdom between British Subjects and French Citizens.

The following Agreement has been entered into between the British and French Governments:—

Sir J. Walsham to Earl Granville.

(Extract.)

Paris, October 9, 1884.

M. Ferry requests me to forward to your Lordship the accompanying draft of the complete text of the certificate as it has been agreed upon at different periods by the two Governments.

His Excellency adds that, should Her Majesty's Government accept this text as definitive, the Government of the Republic will be ready to extend to the agreement the character of a diplo-

matic arrangement.

I have shown the draft certificate as it now stands to the legal adviser of Her Majesty's Embassy, and M. Treitt assures me that it ought, in its present form, to constitute a satisfactory guarantee against a repetition of the disastrous consequences which have hitherto not unfrequently been the result of these mixed marriages.

M. le Ministre de la Justice, à qui j'avais donné connaissance de cette communication, m'informe qu'en ce qui le concerne, il est disposé à donner son approbation à la nouvelle rédaction soumise à l'examen de son Département.

Je vous serai obligé de vouloir bien communiquer ce document an Principal Secrétaire d'État de Sa Majesté Britannique, et l'informer que s'il approuve cette rédaction définitive, le Gouvernement de la République est tout disposé à consacrer cette entente par un arrangement diplomatique.

M. Ferry to Sir J. Walsham.

Paris, October 7, 1884. M. LE MINISTRE,

By a letter under date of the 8th of August last, Her Britannic Majesty's Ambassador at Paris acquainted me with the modifications which Her Majesty's Government desired to see introduced into the text of paragraph C of the certificate which the Consuls of France in England might be authorised to deliver on the occasion of mixed marriages between French and English.

The Minister of Justice, whom I had acquainted with this communication, informs me that, so far as he is concerned, he is disposed to approve the new version submitted for the consideration of his

Department.

In conveying to you the reply of the Keeper of the Seals, I have the honour to transmit herewith, copy of the complete text of the certificate in question, in the form resulting from the agreement come to on various occasions between the two Governments.

I shall be obliged if you will have the goodness to communicate this document to Her Britannic Majesty's Principal Secretary of State, and to inform him that if he approves this final draft, the Government of the Republic are quite prepared to confirm the understanding by a Diplomatic arrange-Accept, &c.,

Draft of Consular Certificate to be issued by French Consuls in cases of Marriage in the United Kingdom between British Subjects and French Citizens.

Le Consul de France à déclare :-

1. Que les Français ne peuvent se marier sans avoir, préalablement, fait en France les publications légales de leur mariage, et obtenu la consen-tement de leurs parents ou des autres personnes indiqués par la loi;

2. Que des pièces et documents produits :(A.) Il résulte que M. (nom, prénoms et profession), né à , et qui se propose de demeurant à contracter mariage avec M. (nom, prénoms et profession), né à le , est de nationalité demeurant à Française;

(B.) Que les publications de son futur mariage prescrites par la loi de France ont été régulièrement faites aux domiciles spécifiés par la loi;

(C.) Que le futur époux a produit les pièces (indiquer ces pièces) qui établissent, soit qu'il a obtenu pour son mariage le consentement des parents on d'antres personnes dont le consentement est exigé; soit que les parents dont le consentement cût été nécessarie, sont décédés, soit que des actes respectueux ont été signifiés aux parents, lesquels actes suppléent à leur consentement (le Consul pourrait indiquer ici de quelles personnes le consentement émane);

(D.) Qu'aucune opposition à ce mariage ne s'est produite jusqu'à ce jour, et que s'il ne s'en révèle pas jusqu'au moment de la célébration du mariage, les époux seraient admis à contracter

mariage en France.

Le Consul déclare, en outre, que le mariage contracté en pays étranger, entre un Français et un étranger est valable s'il a été célébre conformément aux lois du pays, et à la condition :-

1. Que les publications légales en France et les consentements exigés par la loi aient précédé le mariage (Articles 148 à 159 du Code Civil).

2. Que les futurs époux aient l'âge requis par la loi; 18 ans pour le futur, et 15 ans pour la future (Article 144 du Code Civil).

3. Que le consentement de chacun des deux époux ait été absolument libre (Article 146 du Code Civil).

4. Que l'un des époux ne soit pas dans les liens d'un précédent mariage (Article 147 du Code

5. Que le mariage projeté ne viole pas les défenses de mariage entre parents et alliés au

degré prohibé (Articles 161 à 163 du Code Civil). Le Consul déclare encore que l'étrangère qui épouse un Français devient Française par le fait seul de son mariage, et que les enfants issus du mariage, même nés en pays étranger, sont Français (Articles 12 et 312 du Code Civil).

Draft of Certificate to be issued by French Consuls in cases of Marriage in the United Kingdom between British Subjects and French Citizens.

(Translation.)

The French Consul at declares :-1. That French [citizens] cannot contract marriage without having previously published, in France, the notices of their marriage, and obtained the consent of their parents, or of other persons, as prescribed by law;

2. That from the papers and documents pro-

duced: (a.) It results that M. [insert surname, Christian

names, and calling], born at , on the , residing at , who proposes to contract marriage with [insert surname, Christian names, and calling], born at

, residing at on the is of French nationality;

(b.) That the notices of his [her] intended marriage, prescribed by the Law of France, have been duly published at the domiciles specified by

(c.) That the intended husband has produced the papers [here note them] which establish, either that he has obtained for his marriage the consent of the parents, or other persons whose consent is required, or that the parents whose consent would



have been necessary are deceased, or that 'respectful summonses' have been notified to the parents, which summonses serve instead of their consent. [The Consul may note here from what persons the consent emanates.]

(d.) That no opposition to this marriage has been raised up to this date, and that if none be offered up to the moment of the celebration of the marriage the parties would be competent to contract marriage in France.

The Consul declares, moreover, that marriage contracted in a foreign country between a French citizen and a foreigner is valid if it has been celebrated in accordance with the laws of the country, and provided:—

- 1. That the legal notices in France and the [notifications of] consent exacted by law have preceded the marriage (Arts. 148 to 159 of the Civil Code).
- 2. That the parties to the intended marriage be of the age required by law, i.e., 18 years for the bridegroom and 15 years for the bride (Art. 144 of the Civil Code).
- 3. That the consent of each of the parties have been absolutely free (Art. 146 of the Civil Code).
- 4. That neither of the parties be bound by a previous marriage (Art. 147 of the Civil Code).
- 5. That the intended marriage do not violate the prohibitions of marriage between relations within the forbidden degrees (Arts. 161 to 163 of the Civil Code).

The Consul also declares that a foreign woman marrying a Frenchman becomes French through the sole fact of her marriage, and that the children issue of the marriage, even when born in a foreign country, are French (Arts. 12 and 312 of the Civil Code).

In faith of which we have issued the present Certificate, to be of all reasonable force and effect.

MY LORD,

I have to request that your Excellency will express to the French Government the satisfaction with which Her Majesty's Government have received the text of the Consular certificate to be issued in cases of marriage in this country between British subjects and French citizens, which is inclosed in Sir J. Walsham's Despatch of the 9th instant, and which meets with their full concurrence as now amended.

I should be glad if your Excellency would, at the same time, whilst expressing the acknowledgments of Her Majesty's Government for the courtesy shown by the French Government in this matter, ascertain whether they propose to issue instructions at once to their Consuls in the sense agreed upon, and, if so, at what precise date, it being desirable that publicity should be simultaneously given in this country to the arrangement.

By a letter under date of the 8th of this month your Excellency was good enough, on behalf of your Government, to express a desire to learn the date of the instructions which the Government of the Republic, in conformity with the agreement came to with Her Majesty's Government, are to issue to the Consuls of France in England, relative to the certificate to be delivered by them in cases of mixed marriages between French and English.

I hasten to inform you, M. l'Ambassadeur, that I have this day transmitted to the French Consular Officers in the United Kingdom a circular forwarding the certificate in question, and inviting them to adopt it as a model for all documents of the kind which they may be called upon to deliver.

I beg your Excellency to be good enough to acquaint your Government with the fact, as they will no doubt consider it advisable to inform the proper authorities in England of the arrangement arrived at.
