Whereas by an Order of Her Majesty's Most Honourable Privy Council, dated the twenty-fifth day of June 1885, the provisions for the Prevention of Diseases, contained in Part III. of the Act 30 and 31 Viet. c. 101, are put in force in Scotland for the space of six calendar months after the publication of the Order in the Edinburgh Gazette.

And whereas by an Order of the Secretary for Scotland, dated the twenty-first day of December 1885, the said Order in Council is renewed and continued in force for the space of three calendar months after publication in the Edinburgh Gazette.

And whereas by an Order of the Secretary for Scotland, dated the twenty-third day of February 1886, the said Order in Council is renewed and continued in force for the space of six calendar months after publication in the Edinburgh Gazette.

Therefore, exercising the powers conferred upon them by the 33d section of the foresaid Statute, the Board of Supervision renew the Directions and Regulations issued by them on the twenty-sixth day of June, the fifth day of November, the twenty-second day of December 1885, and the

twenty-fifth day of February 1886, prohibiting the Importation of Rags from Spain, and continue the same in force, unless revoked or altered, until the twenty-sixth day of August 1886.
