

Stuart, dated 12th May 1866, and recorded
6th September 1866; Alexander Green's
Bequest, hitherto held and administered under
Settlement, dated 30th July 1827, and
registered in the Books of the Prerogative
Court of Canterbury 24th July 1841;
Anderson's Legacy; and the Macpherson
Prize Fund.

## Preamble.

1. Transference of Property and Administration to New Governing Body.—From and after the date of this Scheme the said Endowments shall be amalgamated, and the whole rights, funds, and estates, heritable and moveable, belonging thereto or vested in the present governing

bodies thereof, especially including therein the sum of £100, with accumulations, standing in the name of Mr. David Wright, Writer to the Signet, shall be transferred to, and vested in the School Board of the parish of Aberlour, and in a representative to be elected by the kirk-session of Aberlour in such manner and for such period as they may determine, without the necessity of any new conveyance or instrument, to be held and administered by them under the conditions and provisions of this Scheme, and the said School Board, together with the said representative, shall be the governing body of the Endowment.

2. Discharge of Governing Body.

3-7. Conduct of Business; Powers of Sale and Investment; Casual Profits; Accounts; and Audit.

8. Preservation of Vested Interests.

9. Application of Income.—The governing body, after paying the necessary expenses of management and the burdens and taxes affecting the Endowment, shall apply the free annual income in the manner hereinafter provided.

10. Payment to Kirk-Session.—The governing body shall pay to the kirk-session of Aberlour the interest on the sum of £200, to be applied by them to the fifth, sixth, and seventh purposes to which the bequest of the said William Stuart to the said kirk-session was decided to be applied.

11. Temporary Application of Green's Bequest.

—The governing body shall pay the annual income of the capital of Alexander Green's Bequest to the present head teacher of the public school at Aberlour so long as the present arrangement as to salary subsists between him and the School Board.

- 12. School Bursaries. The governing body shall apply an annual sum of £20 in establishing school bursaries to be called the Stuart School Bursaries, each of the yearly value of not less than £5 nor more than £10. The bursaries shall be awarded by competitive examination among pupils attending public or State-aided schools in the parish of Aberlour, who have passed the fifth standard of the present Scotch Code, or such standard as may from time to time be fixed by the Scotch Education Department, pursuant to the Education (Scotland) Acts, as that entitling children to total exemption from the obligation to attend school, and whose parents or guardians are in such circumstances as to require aid for giving them higher education; these bursaries shall be tenable for two years at public or Stateaided schools in which efficient instruction is given in the higher branches.
- 13. Bursary for Higher or Technical Education.—The governing body may establish, or grant from time to time if they see fit, a bursary for higher education, to be called the Stuart Bursary, of the yearly value of not less than £15 nor more than £20. This bursary shall be awarded by competitive examination among pupils attending public or State-aided schools in the parish of Aberlour, whose parents or guardians require aid in giving them higher education, under such conditions and regulations as to age or otherwise as the governing body may determine, it shall be tenable for such period, not exceeding three years, as the governing body may determine, at such schools for higher education or technical instruction as they may approve, or with the special consent of the governing body, at a Scottish university.

The governing body shall apply the remainder of the free income of the Endowment for the purpose of promoting higher instruction in the public school at Aberlour, either by increasing the salary of the head teacher or by giving him such additional assistance as may enable him to devote his attention chiefly to the higher standards and the teaching of specific subjects; provided always that no such payment shall be made except on condition that the sum paid out of the school fund for salaries in said school shall not, except with the consent of the Scotch Education Department, be on a less scale than at the date of this Scheme, and that Her Majesty's Inspector of schools for the district shall certify that specific subjects, including Latin and mathematics, are efficiently taught in the school.

Scheme, under the Educational Endowments (Scotland) Act, 1882, for the Administration of the Endowments in the Parish of Mortlach and County of Banff, known as Sturm's Bequest, for the Education of Female Children, hitherto held and administered under the Will and Testament of James Sturm, dated 3d May 1869, and recorded in the Commissary Court Books at Edinburgh 19th July 1869; the M'Innes Bequest, hitherto held and administered by the Minister and Kirk-Session of Mortlach, under Will by Miss M'Innes, dated 29th March 1870; Mrs. Lorimer's Bequest, hitherto held and administered by the Kirk-Session of Mortlach; and the Dipple Mortification, hitherto held and administered by the Kirk-Session of Mortlach, under Will by William Duff, dated 7th May 1720.

Preamble.

1. Transference of Property and Administration to New Governing Body.-From and after the date of this Scheme, the said Endowments shall be amalgamated, and the whole rights, funds, and estates, heritable and moveable, belonging thereto or vested in the present governing bodies thereof, shall be transferred to, and vested in the School Board of the parish of Mortlach, and in one of the executors of the said James Sturm, to be appointed by his said executors to hold office for his life, and in a representative to be appointed by the minister and kirk-session of Mortlach in such manner and for such periods as they may determine, without the necessity of any new conveyance or instrument, to be held and administered by them under the conditions and provisions of this Scheme, and the said School Board, together with the said executor for life and the said representa-tive of the members and kirk-session, shall be the governing body of the Endowment.

2. Discharge of Governing Body.

3-7. Conduct of Business, Powers of Sale and Investment, Casual Profits, Accounts and Audit.

8. Vested Investments.

9. Application of Income. — The governing body, after paying the necessary expenses of management and the burdens and taxes affecting the Endowment, including therein the vested right in the Dipple Mortification, presently held by the principal teacher in the school at Dufftown, shall apply the free annual income in the manner hereinafter provided.

10. Free Scholarships at Public Schools.—The governing body shall expend a sum not exceeding £7 yearly in paying the fees of poor and deserving children, with books and stationery, at public or State-aided schools in the parish of Mortlach, who have passed in the fifth or higher standards of the Scotch Code, and whose parents or guardians, not being in receipt of parochial relief, are in such circumstances as to require aid in providing elementary education, and are persons who, in the opinion of the governing body, should not be required to apply to the Parochial Board for aid in paying school fees. These free scholarships shall be awarded on the result of a competitive examination, or as a reward for regularity of attendance, industry, general merit, and good conduct, all to be ascertained by the report of the teachers and otherwise as the governing body may determine. Any payment under this clause shall be withdrawn in the case of children who fail to give regular attendance or make satisfactory progress at school.

11. Bursary for Higher or Technical Education. — The governing body shall establish a bursary for higher education, to be called the Sturm Bursary, of the yearly value of £18. This bursary shall by awarded by competitive examination among girls attending public or State-aided schools in the parish of Mortlach, whose parents or guardians require aid in giving them a higher education, under such conditions and regulation as to age or otherwise as the governing body may determine; it shall be tenable for such period, not exceeding three years, as the governors may determine, at such schools for higher education or technical or professional instruction as they may approve. If in any year no candidate comes forward properly qualified under this section, or if none of the candidates appear to the governing body, whose determination on such point shall be final, to be

properly qualified to take due advantage of the education at a higher school, the amount of the bursary for that year shall be applied to the purposes of the immediately preceding section.

12. School Bursaries. — The governing body shall apply the remainder of the free annual income in establishing school bursaries, each of the yearly value of not less than £5 nor more than £10. These bursaries shall be awarded by competitive examination among pupils attending public or State-aided schools in the parish of Mortlach, who have passed the fifth standard of the present Scotch Code, or such standard as may from time to time be fixed by the Scotch Education Department, pursuant to the Education (Scotland) Acts, as that entitling children to total exemption from the obligation to attend school, and whose parents or guardians are in such circumstances as to require aid for giving them higher education; these bursaries shall be tenable for two years at public or State-aided schools in which efficient instruction is given in the higher branches. If in any year the annual income does not appear to the governing body sufficient for the establishment of such bursaries, they may accumulate the income for the purpose. In the event of equality of examination, a preference shall be given to the relatives of the father and mother of the foresaid Dr. John Lorimer, but not more than one bursary at a time shall be held by them in virtue of such preference.
