#### By Her Majesty's Command,

The Noblemen and Gentlemen who propose to attend Her Majesty's Levee, at St. James's Palace, are requested to bring with them two large cards, with their names clearly written thereon, one to be left with The Queen's Page in attendance in the Corridor, and the other to be delivered to the Lord Chamberlain, who will announce the name to His Royal Highness.

#### PRESENTATIONS.

Any Nobleman or Gentleman who proposes to be presented must leave at the Lord Chamberlain's Office, St. James's Palace, before twelve o'clock, two clear days before the Levee, a card with his name written thereon, and with the name of the Nobleman or Gentleman by whom he is to be pre-In order to carry out the existing regulations that no presentation can be made at a Levee, excepting by a person actually attending that Levee, it is also necessary that an intimation from the Nobleman or Gentleman who is to make the presentation, of his intention to be present, should accompany the presentation card above referred to, which will be submitted to The Queen for Her Majesty's approbation. It is Her Majesty's command that no presentations shall be made at Levees, except in accordance with the above regulations.

It is particularly requested that in every case the names be very distinctly written upon the cards to be delivered to the Lord Chamberlain, in order that there may be no difficulty in announcing

them to His Royal Highness.

# EDUCATIONAL ENDOWMENTS (SCOTLAND) ACT, 1882.

OTICE is hereby given that the Commissioners under the Educational Endowments (Scotland) Act, 1882, have prepared the Draft of a Scheme for the future administration of the Endowment known as the Marshall Trust, in the Counties of Lanark and Stirling, whereof an abstract is appended. The Commissioners will, in terms of the Twenty-fourth Section of said Act, receive and consider any objection made to them in writing by any public body or persons interested respecting such Scheme, and any amendments proposed thereon, provided that the same be delivered at their Office, at No. 46 George Street, Edinburgh, within two calendar months from the date hereof. Scheme, under the Educational Endowments (Scotland) Act, 1882, for the Administration of the Endowment known as the Marshall Trust, in the Counties of Lanark and Stirling, hitherto held and administered under Trust Disposition and Deed of Settlement by William Marshall, of Holehouse, dated 23d November 1871, with Codicils thereto, dated respectively 2d March 1874 and 6th January 1879, all recorded in the Books of Council and Session 23d April 1879, and Trust Disposition and Deed of Settlement by Miss Janet Marshall, dated 6th May 1879, and recorded in the Books of Council and Session 7th February 1880.

Preamble.—Whereas by said deeds, William Marshall, Esquire of Holehouse, and Miss Janet Marshall, his sister, appointed certain trustees, of whom Messrs. Archibald Foulds, merchant, Glasgow; Robert Murdoch, bank agent, Dundee; and John Watt, bank agent, Glasgow, are the acting survivors, and they respectively bequeathed the

residue of their estates for educational and other charitable purposes, and inter alia for the education, lodging, board, clothing, and industrial training, or such of them only as their trustees should from time to time think proper, of as many destitute boys and girls who were at the time of selection resident in the counties of Lanark and Stirling, as the funds under their charge for the time would permit, who were orphans or fatherless, or whose parents or relations were unable to clothe, educate, and maintain them; and they declared that the trustees for the time should have the most ample powers to fix and determine from time to time the numbers and proportions from both counties of the children to be selected, and no one should be entitled to interfere with their decision; and further, they conferred the most ample powers on their trustees so as the more effectually to carry out and accomplish the benevolent object they had in view according to the circumstances of the time. And whereas the said trust estates and funds have been amalgamated and are known as the Marshall Trust; and whereas the said trust estates and funds may, with consent of the present trustees, be dealt with under the provisions of the Educational Endowments (Scotland) Act, 1882; and whereas such consent has been given by Minute of the Trustees, dated

1886; and whereas it appears to the Commissioners under the said Act, after due examination and inquiry, that in order to extend the usefulness of the said Endowment, the administration thereof should be amended and in some respects altered; therefore the said Endowment shall, from and after the date of this Scheme (being the day on which Her Majesty, by Order in Council, declares her approbation thereof), be held and administered for the purposes, with the powers, and under the conditions and provisions hereinafter set forth.

1. Future Administration of Endowment.—This Endowment shall henceforth be administered under this Scheme by the governing body hereinafter constituted, which is hereby incorporated by the name of 'The Governors of the Marshall Trust,' having perpetual succession and a common seal.

2. Transference of Property.

3. Constitution and Election of Governing Body.—The governing body, hereinafter called the governors, shall consist of twelve persons, of whom

Three of the said surviving and acting trustees of the said William and Janet Marshall shall be governors for their lives; Two shall be elected by the Town Council of Glasgow;

One shall be elected by the Merchants' House of Glasgow;

One shall be elected by the 'Trades' House of Glasgow;

One shall be elected by the Chamber of Commerce of Glasgow;

Two shall be elected by the School Board of Glasgow;

One shall be elected by the School Board of Stirling:

Stirling;
One shall be elected by the Town Council of Stirling.

On the death or resignation of any or all of the said original trustees their places shall be assigned, one to each of the School Board of Glasgow, the Town Council of Glasgow, and the School Board of Stirling respectively. The governors may be elected by the several electing bodies either out

of their own number or otherwise. The governors elected by the School Boards of Glasgow and Stirling, and Town Council of Glasgow re-spectively, shall, in the case of the first election, hold office for a period of five years, and thereafter until the first day of August after the expiry of that period. The governors elected in place of any or all of the said original trustees shall hold office for a period of five years, and thereafter until the first day of August after the expiry of that period. The governors elected by the Merchants' House, Trades' House, and Chamber of Commerce of Glasgow respectively, shall, in the case of the first election, hold office for a period of three years, and thereafter until the first day of August after the expiry of that period. The governors shall, in the case of all elections subsequent to the first, hold office for a period of five years from and after the expiry of the term of office of their predecessors, except as hereinafter provided. Each election shall be made at a meeting convened and conducted according to the ordinary rules and practice of the electing body. Any governor may be re-elected. Within one month after the final approval of this Scheme the clerk or law-agent of the present trustees shall intimate the same to the various electing bodies, and the first governors shall be elected as soon as conveniently may be after the date of such intimation. The clerk, or other officer of the governors, shall, at least one month before the expiry of the term of office of any governor, give notice to the proper electing body, or to their chairman or clerk, as the case may be, and the electing body shall, as soon as conveniently may be after such notice, elect a governor to hold office from the expiry of said term. Any election not made as aforesaid within three months from the date of this Scheme, or from the date of the notice of expiry of a term of office, or from the date of the notice of a vacancy, as hereinafter prescribed, shall in that case be made by the then existing governors.

4-7. Vacancies and Meetings.

8. Chairman.—The said Archibald Foulds is hereby appointed the chairman of the governors, which office he shall hold so long as he continues to act as a governor. On his death or resignation the governors shall forthwith appoint a chairman, and afterwards make such appointment at an ordinary meeting held at such period of the year as they may from time to time determine, and such chairman shall hold office for a year, but shall be eligible for re-election. The governors shall make such regulations as they may think fit for supplying the place of the chairman in the case of his absence.

9-11. Quorum and Execution of Deeds, Minutes, and Committees.

12-17. Business Arrangements, Casual Profits, Powers of Sale and Investment, Accounts and Audit.

18-21. Clauses relating to Transference of Administration.

22. Saving Vested Rights.—The vested interests of the present factor and of the law agent and clerk of the Trust are hereby saved and reserved.

23. Marshall Institution.—The governors shall be bound, when requested by the said original trustees, or the survivors or survivor of them, to erect in Glasgow a building, conform to plans to be approved of by them or him, to accommodate the offices of the Trust, to be called the Marshall Institution. The cost of the building, exclusive of

the site, shall not exceed £12,000. Until such building be erected the governors shall rent the necessary offices, which shall be devoted exclusively to the purposes of the Trust.

#### Application of Income.

24. Application of Income. — The governors, after paying the necessary expenses of management and the burdens and taxes affecting the Endowment, shall apply the free income of the Endowment in the manner hereinafter provided.

25. Free Scholarships at Public Schools.—The governors shall expend such sum annually as they may think fit in payment, in whole or in part, of the school fees, with books and stationery, of children of the class after mentioned, who are resident in the counties of Lanark or Stirling, and who shall attend public or State-aided schools within said counties respectively, and which payments may be continued until such children pass the sixth standard of the present Scotch Code, or a similar standard to be imposed by any future Educational Act, and the governors shall have the fullest discretionary powers, not only in regard to the ages and standards of advancement of the children to be selected, but also the periods at at which such payments, or any of them, shall The children selected must be orphans or fatherless, or children whose parents or relations not being in receipt of parochial relief are unable to clothe, educate, and maintain them, and ought not in the opinion of the governors to be required to apply to the Parochial Board for such aid, provided always that no grants shall be given where the total income of the parents exceed £70 per annum. These free scholarships shall be awarded as the result of such inquiries into the circumstances of the applicants and of such examination of the children suitable to their ages, as the governors may from time to time determine. The governors may in their discretion allocate the sums applied under this section amongst such of the School Board districts within the said counties and in such proportions as they may think fit, and in making the allocation shall take into consideration the amount of free education supplied by other endowments. The governors at the end of every school year shall obtain from the teacher or teachers a special report as to the conduct, regularity of attendance, and progress of all scholars whose fees are paid under this section, and the said fees or payments shall be withdrawn in the case of children who fail to give regular attendance, or concerning whom such report shall not be satisfactory.

26. Assistance to Free Scholars.—The governors may expend such annual sum as they consider proper in grants for the board, lodging, and clothing of necessitous free scholars, but no payment to any scholar shall exceed £10 per annum, and not more than two children from one family shall receive such grants at the same time.

shall receive such grants at the same time.

27. Industrial Training Bursaries.—The governors may apply a sum not exceeding £600 per annum for providing grants of not more than £15 per annum in aid of those free scholars who, after leaving school, are learning an industrial trade, but are unable to earn wages sufficient for their maintenance. These grants shall not be tenable for more than four years, and shall be held only on condition that the recipients shall attend evening classes or other course of instruction to be approved of by the governors. The governors shall obtain a report as to the character and

efficiency of the instruction given and of the attendance and progress of the holder of the grant.

28. Bursaries for Higher Education. — The

governors shall apply a sum not exceeding £400 per annum in providing bursaries or grants of such amount as they may determine, but not exceeding £25 per annum, to each scholar for secondary, higher, or technical education at such schools as the governors may appoint, and which shall be known as the 'Marshall Bursaries.' These bursaries may be awarded by competitive examination among free scholars under this Scheme, and pupils who are resident and attending public or State-aided schools within the counties of Lanark or Stirling, whose parents are of the class specified in section 25 hereof. The governors may apply a farther sum of £400 per annum in providing similar bursaries or grants to be awarded solely to free scholars under this Scheme who shall have competed for but failed to obtain any of the bursaries first mentioned, but on condition that such free scholars shall pass the examination prescribed by the governors. The governors may allocate the bursaries applicable to the sum first mentioned among such of the School Board districts within said two counties, and in such proportion as they may think fit, and in making such allocation shall take into consideration similar bursaries supplied by any other endowment. All competitors for bursaries under this section must have passed the fifth standard of the present Scotch Code, or such other standard as the governors may from time to time fix, and the bursaries shall be tenable for not more than four years; and they shall be subject to such regulations as to age, examination, competition, and duration as the governors may from time to time determine.

29. University Bursaries.—The governors shall apply a sum not exceeding £300 per annum in providing bursaries of such amount as they may determine, but not exceeding £30 per annum, for professional or university education, and which shall be known as the 'Marshall Bursaries.' These bursaries may be awarded by competitive examination among pupils who have had free scholarships or bursaries under this Scheme, and youths of both sexes who are resident and attending public or State-aided schools within the said counties of Lanark or Stirling, whose parents or guardians are of the class specified in section 25 hereof. The governors may apply a farther sum of £300 per annum in providing similar bursaries to be awarded solely to pupils who have had free scholarships under this Scheme, who shall have competed for but failed to obtain any of the first mentioned bursaries, but on condition that such free scholars shall pass the examination prescribed by the governors. The governors may allocate the bursaries applicable to the sum last mentioned among such of the School Board districts of said two counties and in such proportion as they may think fit, and in making such allocation shall take into consideration similar bursaries supplied by any other endowment. The said several bursaries shall be tenable for not more than five years, and shall be subject to such regulations as to age, examination, competition, and duration as the governors may from time to time determine.

30. Forfeiture of Bursaries.—If, in the judgment of the governors, the holder of any bursary shall be guilty of serious misconduct, or fail to make reasonable progress, they may withdraw such bursary, and their determination in such case shall be final.

31.
