PRESENT,

The QUEEN's Most Excellent Majesty in Council.

County of Scotland under certain provisions of the said Act has been received, in pursuance thereof to order that no new Burial Ground shall be opened within certain limits specified in such Order, save with the previous approval of the Secretary for Scotland, or (as the case may require) that after a time mentioned in such Order, Burials within certain limits, or in certain Burial Grounds or Places of Burial, shall be discontinued wholly or subject to any exceptions or qualifications mentioned in such Order, and that such Order in Council shall thereupon have like force and effect as if the same were embodied in the said Act: Provided always, that notice of such representation, and of the time it shall please Her Majesty to order the same to be taken into consideration by the Privy Council, shall be transmitted to the Crown Agent in Edinburgh, and the Sheriff-Clerk of the County in which such Burial Ground is situated; and that the same shall be by them respectively published in the Edinburgh Gazette, and fixed on the doors of the Church of, or on some conspicuous places within, the Parishes affected by such representation, one month before such representation is so considered:

And whereas the Secretary for Scotland has, under the provisions of the Burial Grounds (Scotland) Act, 1855, made a representation stating that he has received a copy of an Interlocutor of the Sheriff-Substitute of Fifeshire, finding, on a Petition presented to him by the Provost, Bailies, and Councillors of the Royal Burgh of Burntisland (all the Members presenting the Petition being assessed for the relief of the Poor within the Parish of Burntisland) 'that the Whereas by the 'Burial Grounds (Scotland) Act, 1855,' as amended by 'the Secretary for Scotland Act, 1885,' it is enacted that it shall be lawful for Her Majesty from time to time, by Order in Council, upon the representation of the Secretary for Scotland, that a copy of an Interlocutor of a Sheriff of a ' health, and contrary to decency :

And whereas in the said representation it is recommended that the said Burial Ground be closed for Burials:

And whereas notice of the said representation and of the time when it pleased Her Majesty to order the same to be taken into consideration by a Committee of the Lords of the Privy Council, has been duly published in the Edinburgh Gazette, and has been fixed as required by the said

And whereas it has been suggested by the said Sheriff-Substitute that exception in regard to the closing of the said Burial Ground should be made in the case of certain persons being the husbands or wives of persons already interred in the said Burial Ground:

And whereas the Secretary for Scotland has recommended that the suggestion of the said Sheriff-Substitute should, under the conditions hereinafter set forth, he complied with:

Now, therefore, Her Majesty, by and with the advice of Her Privy Council, is pleased to order, and it is hereby ordered, that Burials be forthwith discontinued in the Burial Ground attached to the Parish Church, in the Parish of Burntisland, except for the husbands and wives, at their decease, of persons already interred in the said Burial Ground, provided that the right of interment existed at the time of the passing of the Burial Grounds (Scotland) Act, 1855, and that the exercise of the said right shall not be injurious to the public health; provided also that each grave, when required, be opened without disturbing soil in which previous interments have taken place, that each coffin be embedded in a layer of powdered charcoal four inches at the least in thickness, and separately entombed in brick or stone work cemented in an air-tight manner, that no grave be less than five feet deep, and that no grave be buried in unless it can be opened to that depth without the exposure of coffins, and that notice be given to the Sanitary Inspector of the Parish of Burntisland on the day preceding that on which a grave is to be opened: Provided also, that this permission be revocable at any time.

Whereas by an Act passed in the forty-fifth and forty-sixth years of Her Majesty's reign, entituled 'The Militia Act, 1882,' it is amongst other things enacted that, save as therein otherwise provided, the Militia shall be trained and exercised for not less than twenty-one days and not more than twenty-eight days in every year, at such

condition which is dangerous, offensive to with the advice of Her Privy Council, order that the period of training and exercise, in any year, of all or any part of the Militia be extended, but so that the whole period of training and exercise be not more than fifty-six days.

> And whereas it is expedient that the training of the 2d Brigade, Lancashire Division, Royal Artillery (formerly the Royal Lancashire Artillery Militia), and the 2d Brigade, North Irish Division Royal Artillery (formerly the Antrim Artillery Militia), and also of the Royal Anglesey Engineer Militia, the Southern Submarine Mining Militia, and the Royal Monmouthshire Engineer Militia, should be extended beyond the period of twentyeight days for the year one thousand eight hundred and eighty-six.

> Now therefore, Her Majesty, with the advice of Her Privy Council, is pleased to order and direct that the period of training and exercise of the before-specified Regiments and Brigades of Militia shall, for the year one thousand eight hundred and eighty-six, be extended, under the provisions of the before-cited Act, from twentyeight days to the number of days in each case hereinafter mentioned; that is to say :-

> 2d Brigade, Lancashire Division, Royal Artillery, thirty-four (34) days.

> 2d Brigade, North Irish Division, Royal Artillery, thirty-four (34) days.

Royal Anglesey Engineer Militia, forty-one (41)

Southern Submarine Mining Militia, fifty-five (55) days.

Royal Monmouthshire Engineer Militia, fortyone (41) days.
