EDUCATIONAL ENDOWMENTS (SCOTLAND) ACT, 1882.

OTICE is hereby given that the Commissioners under the Educational Endowments (Scotland) Act, 1882, have prepared the Draft of a Scheme for the future administration of the Endowments known as Bell's Trust, Gray's BEQUEST, BOGIE BEQUEST, and KIRKGATE SCHOOL, in the County of Fife and Parish of Cupar, whereof an abstract is appended. The Commissioners will, in terms of the Twenty-fourth Section of said Act, receive and consider any objection made to them in writing by any public body or persons interested respecting such Scheme, and any amendments proposed thereon, provided that the same be delivered at their Office, at No. 46 George Street, Edinburgh, within two calendar months from the date hereof. Scheme, under the Educational Endowments (Scotland) Act, 1882, for the Administration of the Endowments known as Dr. Bell's Trust, presently held and administered under the Trust Disposition and Settlement of the late Dr. Andrew Bell of Egmore, dated 27th July—1831,—and—recorded—in—the_books_of Council and Session 10th April 1832; Dr. Gray's Bequest, presently held and administered under the Trust Disposition and Settlement of Dr. John Gray, dated 30th June 1808; the Bogie Bequest (in so far as the same is vested in the Magistrates and Ministers of Cupar for behoof of Cupar Parish) presently held and admistered by the said Magistrates and Ministers under the Trust Disposition and Settlement of Alexander Bogie of Newmill and Balass, dated 9th October 1869; and the Kirkgate School or South Branch of the Madras Academy, presently occupied and administered by the Trustees acting under the said Trust Disposition and Settlement of the late Dr. Andrew Bell of Egmore.

Preamble.

1, 2. Future Administration; Transference of

Property.

3. Constitution and Election of Governing Body.—The governing body, hereinafter called the governors, shall consist of five persons, of

One shall be appointed by the Lord-Lieutenant

One shall be elected by the Magistrates and Council of the Burgh of Cupar;

One shall be elected by the Kirk-Session of Cupar;

One shall be elected by the Burgh School Board of Cupar;

One shall be elected by the Landward School Board of the Parish of Cupar and by the School Board of Springfield Parish alternately, the Landward School Board of the Parish of Cupar to have the first election.

The governors may be elected by the several electing bodies either out of their own number or otherwise. The governors appointed or elected by the said Lord-Lieutenant and kirk-session shall, in the case of the first election, hold office for a period of five years, and thereafter until the first day of August after the expiration of that period. The governors elected by the said School Boards shall, in the case of the first election, hold office for a period of three years, and thereafter until the first day of August after the expiration of that period. The governors shall, in the case of all elections or

for a period of five years from and after the expiration of the term of office of their predecessors, except as hereinafter provided. Each election shall be made at a meeting convened and conducted according to the ordinary rules and practice of the electing body. Any governor may be re-elected or re-appointed. The first may be re-elected or re-appointed. governors shall be elected or appointed as soon as conveniently may be after the date of this Scheme. The clerk or other officer of the governors shall, at least one month before the expiration of the term of office of any governor, give notice to the proper electing body or to the said Lord-Lieutenant as the case may be, and the electing body or the said Lord-Lieutenant shall, as soon as conveniently may be after such notice, appoint or elect a governor to hold office from the expiration of said term. Any election or appointment not made as aforesaid within three months from the date of this Scheme, or from the date of the notice of expiration of a term of office, or from the date of the notice of a vacancy, as hereinafter prescribed, shall in that case be made by the then existing governors. 4-11. Vacancies;

Meetings; Chairman: Quorum and Execution of Deeds; Minutes; and

Power to appoint Committees.

12-17. Accounts; Business Arrangements; Casual Profits; Powers of Sale and Investment; and Audit.

18. First Meeting .- Within two months from the date of this scheme, a meeting of the governors shall be held, upon the summons of the Lord-Lieutenant of Fife. At this meeting they shall make arrangements for the conduct of business, and shall elect a chairman, but they shall not at this, or any subsequent meeting, transact any business that is not necessary for the immediate administration of the Endowment until the whole of the first governors are elected or appointed.

19-21. Clauses relating to Transference of

Administration.

22. Discontinuance of School.—The governors shall, within twelve months after the date of this Scheme, discontinue the school presently maintained in the buildings known as the Kirkgate School or south branch of the Madras Academy, and shall sell the school buildings with the playground, fittings, furnishings, parts and pertinents by public roup after due advertisement, but the governors shall be bound to offer the said buildings, furnishings, parts and playground, fittings, pertinents to the School Board of the Burgh of Cupar, and to sell the same to the said Board at any time within the said twelve months at the price of £360.

23. The School Board of the Burgh of Cupar shall, at the same date as that fixed by the governors under the 19th section hereof for the transference of the Endowment, obtain possession of the buildings and other subjects other than the said Kirkgate School presently occupied by and in possession of the Trustees of Dr. Bell, and the said Trustees shall cede possession at the said date of the said buildings and subjects to the said School Board to be held and maintained by them as a school in all time coming under the name of the Madras School. The said buildings and subjects are hereby excepted from the general conveyance to the governors of the rights, funds, and estates belonging to the Endowments, or vested in the present governing bodies, and all the right, title, and interest in the said buildings and subjects beappointments subsequent to the first, hold office longing to, or vested in the said governing bodies. above mentioned, transferred and made over to the said School Board, and the said Trustees of Dr. Bell shall at the said date transfer to the said Board any titles to the said buildings and others to which they themselves may have right.

24. Vested Interests.

Application of Income.

25. Application of Income.—The governors, after paying the necessary expenses of management and the burdens and taxes affecting the Endowment, shall apply the free income of the Endowment in the manner hereinafter provided.

26. Free Scholarships.—The governors may, so long as they continue to receive any payment or revenue or benefit from the estate of the said Alexander Bogie, but no longer, apply a sum not exceeding £30 yearly in paying, in whole or in part as they may think fit, the fees of scholars, with books and stationery, at public or State-aided schools in the parish of Cupar, both landward and burgh, for elementary education as defined in the Educational Endowments (Scotland) Act, 1882. The free scholars shall be children whose parents or guardians, not being in receipt of parochial relief, are in such circumstances as to require aid for providing elementary education, and are persons who, in the opinion of the governors, ought not to be required to apply to the Parochial Board for such aid.

In the case of children under ten years of age, the selection of free scholars shall be made with due regard to merit, as ascertained by such examination, suited to the age of the candidates, as the governors may from time to time prescribe; or in the case of children for whom such examination is unsuitable, by evidence that the children possess such qualifications as to justify their selection; and in the case of children who have been in attendance at school during one or more school years, the governors shall, in making their selection, give special weight to good conduct, attendance, and progress at school during the previous year. The fees in respect of children under ten years of age shall not be paid for more than one school year without reappointment, and the amount to be expended in paying fees for such children shall not exceed one-third of the amount to be applied under this section.

In the case of children under ten years of age and upwards, the free scholars shall be selected by competitive examinations, which shall be open to all of the same age who are eligible in terms hereof, whether they have or have not previously been beneficiaries; and for such children the school fees may continue to be paid for such period, not exceeding three years, as the governors may determine. If any scholar gain a school bursary his school fees shall no longer be paid under this section.

The governors, at the end of every school year, shall obtain from the teacher or teachers a special report as to the conduct, regularity of attendance, and progress of all scholars whose school fees are paid in whole or in part under this section, and the fees of no scholar shall continue to be paid in regard to whom such report is not satisfactory.

27. School Bursaries.—The governors shall apply an annual sum not exceeding £40 in establishing school bursaries, one-half of which shall be called the Gray Bursaries, each of the yearly value of not less than £5 nor more than

shall be and hereby are from and after the date £10. These bursaries shall be awarded by competitive examination among pupils attending public or State-aided schools in the parish of Cupar, both burgh and landward, who have passed the fifth standard of the present Scotch Code, or such standard as may from time to time be fixed by the Scotch Education Department, pursuant to the Education (Scotland) Acts, as that entitling children to total exemption from the obligation to attend school, and whose parents or guardians are in such circumstances as to require aid for giving them higher education, and the Gray Bursaries shall be tenable exclusively by girls so qualified; these bursaries shall be tenable for two years at the Madras School, or in the event of its being closed at public or State-aided schools in which efficient instruction is given in the higher branches.

> 28. Payment of Free Income to School Board. The governors shall pay the whole residue of the free annual income of the Endowment to the Burgh School Board of Cupar, subject to the following conditions:—(1) The School Board shall maintain and keep in good repair the buildings of the Madras Academy, and maintain a school therein which may be as hereinafter provided divided into an upper and lower department. The lowest class in the upper department shall correspond to the sixth standard of the present Scotch Code, and it shall be in the power of the School Board, with consent of the governors, to maintain in the lower department preparatory junior classes under the teaching or superintendence of the head master of the school, provided that the fees in such lower department shall cover the whole cost of education in that department, and that neither the teaching of the head master in the upper department, nor the accommodation of said department be unduly interfered with. (2) The annual sum paid to the School Board by the governors, together with the whole fees drawn from the upper department, and any Government grant which may at any time be drawn therefor, shall be wholly applied to salaries and other educational expenses in the upper department. (3) The head master shall be a graduate of some University in the United Kingdom, and shall receive a salary of not less than £200. (4) The accounts of the school, so far as they relate to the higher department, shall be annually submitted to the governors. (5) The fees in the higher department shall be fixed on such a scale as the parents of children attending the department may reasonably be expected to pay, and shall not be reduced so as to impair the efficiency of the department for higher instruction. The table of fees in the department shall be subject to the approval of the governors, and in the event of a difference of opinion between the governors and the School Board, the questions shall be referred to the determination of the Scotch Education Department. (6) The School Board shall give free education in the higher department to such number of children not exceeding ten as the governors may determine, whose parents or guardians require aid in giving them higher education. These children shall be elected by the governors from among the children attending public or State-aided schools in the burgh or parish of Cupar or parish of Springfield, and in the event of there being more candidates than vacancies, the free scholarships shall be awarded on the result of such examination as the governors may determine.

29. Subjects of Instruction.—The subjects to be taught in the school shall include reading, writing, arithmetic, book-keeping, and mensuration, geography and history, English grammar, composition and literature, Greek and Latin, at least two modern languages, mathematics and drawing, at least one subject of natural science, and such other subjects as the governors may from time to time determine.

30. Use of remainder of the Buildings .- After providing accommodation for the said school to the satisfaction of the governors, the School Board may, with consent of the Scotch Education Department, occupy and use the remainder, if any, of the buildings of the Madras Academy as a public elementary school, but so long only as such occupation and use does not interfere with the maintenance and management of the school directed to be established by the 28th section

51. These bursaries shall be awarded by competitive examination among pupils attending public or State-aided schools in the parishes of Cameron, Ceres, Collessie, Cults, Cupar, Dairsie, Kemback, Kilmany, Logie, Monimail, Moonzie, and Springfield, under such conditions and regulations as to age or otherwise as the governors may determine; they shall be tenable for such period, not exceeding three years, as the governors may determine, at such schools for higher education or technical instruction as they may approve. the event of the annual payment to the School Board being renewed under the provisions of the immediately preceding section, the governors shall, in the first place, make payment of any bursaries awarded under this section.

33. Forfeiture of Bursaries .- If, in the judgment of the governors, the holder of any bursary

shall be guilty of serious misconduct, or fail to make reasonable progress, they may withdraw such bursary, and their determination in such case shall be final.

34. Annual Distribution of Bursaries.—The governors shall establish the bursaries herein provided for in such manner as to secure that they shall be awarded in as nearly as possible equal numbers in each year.

35. Residue of Income.—The residue of the free annual income, in so far as it has not been applied under the provisions of this Scheme, shall be invested by the governors as soon as it shall amount to £50, and form part of the capital fund of the Endowment.
