OTICE is hereby given that the Commis-sioners under the Educational Endowments (Scotland) Act, 1882, have prepared the Draft of a Scheme for the future administration of the Endowment known as ROBERT PHILP'S TRUST ESTATE AND SCHOOLS, in the County of Fife and Burghs of Kirkcaldy and Kinghorn, whereof an abstract is appended. The Commissioners will, in terms of the Twenty-fourth Section of said Act, receive and consider any objection made to them in writing by any public body or persons interested respecting such Scheme, and any amendments proposed thereon, provided that the same be delivered at their Office, at No. 46 George Street, Edinburgh, within two calendar months from the date hereof. Scheme, under the Educational Endowments (Scotland) Act, 1882, for the Administration of the Endowment in the County of Fife and Burghs of Kirkcaldy and Kinghorn, known as Robert Philp's Trust Estate and Schools, hitherto held and administered under Trust Disposition and Settlement by Robert Philp, dated 15th May 1820, and recorded in the Books of Conneil and Session 23rd April 1828, and Act of Parliament, 9 and 10 Vict. c. 24, entitled 'An Act to Incorporate the Governors and Managers appointed under the Trust Disposition and Settlement of Robert Philp, of Edenshead, deceased, and to explain and extend the Powers and Provisions contained in said Deed.'

Preamble.

1, 2. Future Administration; Transference of

Property.

3. Constitution and Election of Governing Body.—The governing body, hereinafter called the governors, shall consist of fifteen persons, of · whom

Four shall be elected by the Town Council

of Kirkcaldy;

Three shall be elected by the School Board of the Burgh of Kirkcaldy;

Two shall be elected by the School Board of the Burgh of Dysart;

One shall be elected by the Town Council of the Burgh of Kinghorn;

One shall be elected by the School Board of Kinghorn;

One shall be elected by the Presbytery of Kirkealdy;

One shall be elected by the Minister and

Kirk-Session of Kirkcaldy; One shall be elected by the Town Council of Kirkcaldy from among the ministers of religion officiating within the municipal limits of Kirkcaldy, not being members of the Established Church; and

One shall be elected by the Justices of the Peace for the County of Fife residing within the municipal limits of the Burghs of Kirkcaldy and Kinghorn.

The governors may be elected by the several electing bodies either out of their own number or otherwise. The governors elected by the Town Council of Kirkcaldy, the Presbytery of Kirkcaldy, the Town Council of Kinghorn, and the School Board of Kinghorn, shall, in the case of the first election, hold office for a period of five years, and thereafter until the first day of August. after the expiry of that period. The governors elected by the School Board of Kirkcaldy, the Minister and Kirk-Session of Kirkcaldy, the School Board of Dysart, and the Justices of the Peace, shall, in the case of the first election, hold office for a period of three years, and thereafter until the first day of August after the expiry of The governors shall, in the case of that period. all elections subsequent to the first, hold office for a period of five years from and after the expiry of the term of office of their predecessors, except as hereinafter provided. The election by the Justices of the Peace shall be made at a meeting of the Justices resident within the municipal limits of the Burghs of Kirkcaldy and Kinghorn convened by the clerk to the governors, and all other meetings for election shall be convened and conducted according to the ordinary rules and practice of the electing body. Any governor may be re-elected. The first governors shall be elected as soon as conveniently may be after the date of this Scheme. The clerk or other officer of the governors shall, at least one month before the expiry of the term of office of any governor, give notice to the proper electing body, who shall, as soon as conveniently may be after such notice, elect a governor to hold office from the expiry of said term. Any election not made as aforesaid within three months from the date of this Scheme, or from the date of the notice of expiry of a term of office, or from the date of the notice of a vacancy, as hereinafter prescribed, shall in that case be made by the then existing governors.

Vacancies; Meetings; Chairman; 4-11.Quorum and Execution of Deeds; Minutes; Power to Appoint Committees.

12-17. Accounts; Business Arrangements; Casual Profits; Powers of Sale and Investment; Andit.

18. First Meeting .- Within two months from the date of this Scheme a meeting of the governors shall be held, upon the summons of the Provost of Kirkcaldy. At this meeting they shall make arrangements for the conduct of business, and shall elect a chairman, but they shall not, at this, or any subsequent meeting, transact any business

that is not necessary for the immediate administration of the Endowment until the whole of the

first governors are elected.

19. Transference of Administration. - The present governing body shall continue to exercise all necessary acts of administration relative to the Endowment, and shall have all powers necessary therefor, until the first meeting of governors is held under this Scheme, and they shall, from and after that meeting, or at such time not exceeding six months therefrom as the governors may appoint, wholly cease to exercise any right or power of administration over the Endowment, and shall cause to be transferred to the governors, in such manner as they may direct, all the books, deeds, and papers, and all cash balances and moveables belonging to the Endowment.

20. Governors may act though Governing Body not full.—Except as herein provided, the governors for the time being, if a quorum is formed, may act for all the purposes of this Scheme, although the governing body as herein-

before constituted is not complete.

21. Discharge of Governing Body. - The governors shall have power to grant a full and effectual discharge to the present governing body of the Endowment, and to the individual members thereof, from all claims competent against them in respect of the said Endowment, on a satisfactory audit of the accounts of the said Endowment, and on compliance with the provisions of the nineteenth section hereof, and shall be bound, if required, to grant such discharge on fulfilment of the said conditions.

22. Discontinuance of Schools.—The governors shall, within twelve months after the date of this Scheme, discontinue the schools presently maintained by the Trust, and shall, except as herein-after otherwise provided, either sell or let the school buildings at a fair rent, as to them may seem best; but, notwithstanding the provisions hereof, they may, on obtaining the authority of the Scotch Education Department, continue the schools until such time as may be fixed; but it shall be in the power of the governors, if they see fit, to retain in their possession the Philp's School in the Second District, and to use the same partly for the accommodation of the classes sanctioned by the thirty-sixth section hereof, and partly for meetings of the governors or any committees appointed by them.

23. Retiring Allowances.-The governors shall have power to grant a retiring allowance to any teacher of advanced years, who has been in the service of the Trust for so long a period that they may consider him to have a claim to such retiring allowance. The amount of such retiring allowance shall be subject to the approval of the Scotch

Education Department. 24. Vested Interests.

Application of Income.

25. Application of Income.-The governors, after paying the necessary expenses of management and the burdens and taxes affecting the Endowment, shall apply the free income of the Endowment in the manner hereinafter provided.

26. Annuities to British and Foreign Bible Society and London Missionary Society.-The governors shall, as directed in the Trust Disposition of the said Robert Philp, pay an annuity of £4 to the British and Foreign Bible Society and an annuity of £12 to the London Missionary Society, provided always that if either of the said

Societies be dissolved, or if it be the opinion atany time of three-fourths of the governors for thetime being that it is expedient to withdraw eitheror both of said annuities, it shall be in their power

to cease paying the same.

27. Area of Application of Income of Endowment.-The annual income of the Endowment shall be applied within the following areas:-thethird ward of the extended burgh of Kirkcaldy, hereinafter called the first district; the civil parish of Kirkcaldy, hereinafter called the second district;. those portions of the first ward of said burgh which lie within the civil parishes of Abbotshall' and Kinghorn, hereinafter called the third district: and the parliamentary burgh of Kinghorn, herein-after called the fourth district.

28. Free Scholarships .- The governors, on the discontinuance of the schools under the twentysecond section hereof, shall apply a sum not exceeding £500 yearly in paying, in whole or in part as they may think fit, the fees of scholars, with books and stationery, at public or State-aided' schools within the area to which the Endowment is applicable for elementary education as defined in the Educational Endowments (Scotland) Act, 1882. The free scholars shall be children whose parents or guardians, not being in receipt of parochial relief, are in such circumstances as to require aid for providing elementary education, and are persons who, in the opinion of the governors, ought not to be required to apply to the Parochial Board for such aid.

Three-eighths of the said annual sum shall be expended for the benefit of children residing within the first district, two-eighths for the benefit of children residing within the second district, twoeighths for the benefit of children residing within the third district, and one-eighth for the benefit of children residing within the fourth district.

In the case of children under ten years of age the selection of free scholars shall be made with due regard to merit, as ascertained by such examination, suited to the age of the candidates, as the governors may from time to time prescribe; or in the case of children for whom such examination is unsuitable, by evidence that the children possess such qualifications as to justify their selection; and in the case of children who have been in attendance at school during one or more school years, the governors shall, in making their selection, give special weight to good conduct, attendance, and progress at school during the previous year. The fees in respect of children under ten years of age shall not be paid for more than one school year without re-appointment, and the amount to be expended in paying fees for such children shall not exceed one-third of the amount to be applied under this section.

In the case of children of ten years of age and upwards, the free scholars shall be selected by competitive examinations, which shall be open to all of the same age who are eligible in terms hereof, whether they have or have not previously been beneficiaries; and for such children the school feesmay continue to be paid for such period, not exceeding three years, as the governors may dctermine. If any scholar gain a school bursary, his school fees shall no longer be paid under this. section.

The governors, at the end of every school year,. shall obtain from the respective School Boards a special report as to the conduct, regularity of attendance, and progress of all scholars whose school fees are paid in whole or in part under this section, and the fees of no scholar shall continue to be paid in regard to whom such report is not satisfactory. Any expense incurred by the School Boards in furnishing such reports shall, if required,

be paid by the governors.

The governors may, if they see fit, entrust the carrying out of the provisions of this clause in the several districts to committees of not less than eight nor more than twelve members, appointed by them, partly from their own number, and partly from persons resident in the said respective districts.

The governors shall in the first selection of free scholars give a preference to those in attendance at the schools belonging to the Trust at the time

they are closed.

29. Clothing.—The governors shall apply an annual sum not exceeding £600 in providing clothing for the more needy of the free scholars under the previous section. The said annual sum shall be distributed among the free scholars resident in the foresaid districts in the proportion of three-eighths to the first district, two-eighths to the second district, two-eighths to the second district, two-eighths to the third district, and one eighth to the fourth district. In selecting the children to receive benefit under this section, special regard shall be had to their attendance and progress at school. The clothing shall be given in such manner and under such condition as the governors may see fit. The distributions of clothing may be entrusted by the governors to any committees appointed by them under the previous section.

30. Bursaries.—The governors shall expend the annual sum of £400 on the bursaries established under the three immediately succeeding

sections.

- 31. School Bursaries.—The governors shall apply the annual sum of not less than £200 in establishing school bursaries, each of the yearly value of not less than £5 nor more than £10. These bursaries shall be awarded by competitive examination among pupils attending public or State-aided schools within the area of the Endowment who have passed the fifth standard of the present Scotch Code, or such standard as may from time to time be fixed by the Scotch Educa-tion Department, pursuant to the Education (Scotland) Acts, as that entitling children to total exemption from the obligation to attend school, and whose parents or guardians are in such circumstances as to require aid for giving them higher education; these bursaries shall be tenable at the Kirkcaldy Burgh (Higher) School for such period, not exceeding three years, as the governors may determine.
- 32. Bursaries for Higher Education.—The governors shall apply the annual sum of not less than £80 in establishing bursaries to be awarded by competitive examination among pupils attending the Kirkcaldy Burgh (Higher) School who require aid in obtaining higher education. These bursaries shall be of the annual value of not less than £10 nor more than £15. These bursaries shall be established by the governors at such stages in the curriculum and under such conditions and regulations as they may think fit, provided always that especial care be taken to establish them in such manner as to encourage pupils of promise to complete the curriculum at the School. They shall be tenable at the Kirkcaldy Burgh (Higher) School for such period or periods, not exceeding two years, as the governors may determine:
 - 33. University Bursaries.—The governors shall

establish not fewer than three bursaries for University or Technical or Professional education, each of the yearly value of not less than £25 nor more than £30. These bursaries shall be awarded by competitive examination among those who have been pupils in public or State-aided schools within the area to which the Endowment is applicable for at least two years before the date of examination; they shall be tenable for such period as the governors may determine, at a University or Technical school or Training school for teachers to be approved by the governors.

34. Payment to Kirkcaldy Burgh School Board.—The governors shall, with the view of providing efficient higher education for the bursars under this Scheme, pay an annual sum of not less than £250 to the Kirkcaldy Burgh School Board, on

ondition—

 That the said sum shall be wholly applied by the said School Board in increasing the efficiency of higher teaching in the Burgh

(Higher) School.

(2) That the School Board gave especial attention to securing efficient teaching in mathematics, free hand, geometrical and mechanical drawing, and such other branches of instruction as may be of special advantage to those entering into mechanical or other trades in the district.

(3) That the School Board provide full accommodation for higher instruction in the said

school.

35. Provision in case of Non-fulfilment of Conditions in previous Section .- In the event of the School Board failing at any time to implement the conditions of the immediately preceding section, the governors shall cease to make payment to them of the sum provided under said section, and shall at the same time withdraw the bursaries to be established under the thirty-second section hereof. It shall be competent at any time to any two members of the governing body for the time being, if it appear to them that any of the said conditions are not being fulfilled by the said School Board, to make application to the Scotch Education Department to examine into the application of the foresaid a mual grant; and if it appear to the Scotch Education Department that the conditions of the grant are not being fulfilled by the said School Board, they shall have power to intimate their decision to that effect to the governors; and the payment of the said annual grant, and of the bursaries to be established under the thirty-second section hereof, shall thereupon be suspended. the event of said payment and awarding of said bursaries being suspended, either by a resolution of the governors or in consequence of the decision of the Scotch Education Department, the governors shall apply the said annual grant of £250, and the said minimum annual sum of £80 applied under the thirty-second section hereof, in establishing bursaries of the annual value of not less than £15 nor more than £20, which shall be awarded by competitive examination under such regulations and conditions as to age or otherwise as the governors may determine, among pupils attending public or State-aided schools within the area of the Endowment, whose parents or guardians require aid in giving them higher education. These bursaries shall be tenable at schools for higher or technical or professional education not being within the area of the Endowment to be approved by the governors. The governors shall resume payment of the said annual grant and bursaries on their

being satisfied that the School Board are ready to comply with the conditions of the thirty-fourth section, or in the case of their having been withdrawn in consequence of a decision of the Scotch Education Department as aforesaid, on an intimation from the Department that they are satisfied that the School Board are ready to comply with said conditions; provided always that payment shall be made of any bursaries already awarded under the provisions of this section, in the first instance out of the sum appropriated to bursaries under the thirty-second section, and thereafter out of the annual payment directed to be made to the School Board.

36. Grant for Science and Art Classes.—The governors shall apply the annual sum of not less than £250 in maintaining, or assisting to maintain, evening classes for science and art instruction in Kirkcaldy and in Kinghorn. Not less than £30 of the said annual sum shall be expended in Kinghorn. They shall select such branches of instruction as may be specially useful to artisans in the district. The said annual sum may be applied

as the governors may determine-

(1) In providing proper accommodation for said

(2) In furnishing apparatus, models, and other means of instruction.

(3) In paying or supplementing salaries to teachers.

(4) In paying fees for pupils, provided always that in selecting such pupils due regard be paid to merit.

All such payments shall be made under such conditions and regulations as the governors may determine. It shall be in the power of the governors, if they see fit, to retain in their possession the Philp's School in the second district, and use the same for the accommodation of these classes.

- 37. : 39. Forfeiture of Bursaries.—If, in the judgment of the governors, the holder of any bursary shall be guilty of serious misconduct, or fail to make reasonable progress, they may withdraw such bursary, and their determination in such case shall be final.

40. Annual Distribution of Bursaries.—The governors shall establish the bursaries herein provided for in such manner as to secure that they shall be awarded in as nearly as possible equal numbers in each year.

3. Constitution and Election of Governing Body.—The governing body, hereinafter called the governors, shall consist of seven persons, of whom

Three shall be elected by the Magistrates and Town Council of Forres;

Two shall be elected by the School Board of the Burgh of Forres;

One shall be elected by the School Board of Kinloss; and

One shall be elected by the School Board of Rafford.

The governors may be elected by the several electing bodies either out of their own number or

otherwise. The governors elected by the Magistrates and Town Council of Forres and the School Board of Kinloss shall, in the case of the first election, hold office for a period of five years, and thereafter until the first day of August after the expiry of that period. The governors elected by the School Board of the burgh of Forres, and the School Board of Rafford shall, in the case of the first election, hold office for a period of three years, and thereafter until the first day of August after the expiry of that period. The governors shall, in the case of all elections subsequent to the first, hold office for a period of five years from and after the expiry of the term of office of their predecessors, except as hereinafter provided. Each election shall be made at a meeting convened and conducted according to the ordinary rules and practice of the electing body. Any governor may be re-elected. The first governor shall be elected as soon as conveniently may be after the date of this Scheme. The clerk or other officer of the governors, shall at least one month before the expiry of the term of office of any governor, give notice to the proper electing body, and the electing body shall, as soon as conveniently may be after such notice, elect a governor to hold office from the expiry of said term. Any election not made as aforesaid within three months from the date of this Scheme, or from the date of the notice of expiry of a term of office or from the date of the notice of a vacancy, as hereinafter prescribed, shall in that case be made by the then existing governors.

12-17. Accounts; Business Arrangements; Casual Profits; Powers of Sale and Investment;

18. First Meeting.-Within two months from the date of this Scheme, a meeting of the governors shall be held, upon the summons of the Provost of Forres. 19. Transference of Administration. - The present governing bodies shall continue to exercise all necessary acts of administration relative to the Endowments, and shall have all powers necessary therefor, until the first meeting of governors is held under this Scheme, and they shall, from and after that meeting, or at such time not exceeding six months therefrom as the governors may appoint, wholly cease to exercise any right or power of administration over the Endowments, and shall cause to be transferred to the governors, in such manner as they may direct, all the books, deeds, and papers, and all cash balances and moveables belonging to the Endowments.

21. Discharge of Governing Body.—The governors shall have power to grant a full and effectual discharge to the present governing body of the Endowment and to the individual members thereof, and to the said Robert Urquhart, senior, as trustee foresaid, from all claims competent against them

24. 29. Fees.-The governors shall charge fees in the school except as provided in the immediately succeeding section. The fees shall not be less than those charged in the board schools, except with the consent of the Scotch Education Department.

30. Free Scholars .- The governors shall admit into the school without charge a number of. scholars, not exceeding at any time one hundred, who shall be natives of or resident in the parishes of Forres, Kinloss, and Rafford, and whose parents or guardians, not being in receipt of

parochial relief, are in such circumstances as to require aid for providing elementary education, and are persons who, in the opinion of the governors, ought not to be required to apply to the Parochial Board for such aid.
