THE Secretary of State for Foreign Affairs has received a Telegram from Her Majesty's Chargé d'Affaires at Athens, stating that in consequence of representations made by him to the Greek Government vessels from the United Kingdom bound for Greece, viâ Malta, will be admitted to pratique provided they shall not have entered the Port of Malta. The Greek Government, however, decline to allow pratique to vessels which have entered the port even without communicating with the shore.
