EDUCATIONAL ENDOWMENTS (SCOTLAND) ACT, 1882.

OTICE is hereby given that the Commissioners under the Educational Endow-ments (Scotland) Act, 1882, have prepared the Draft of a Scheme for the future administration of the Endowments known as the Marshall Endowment, the Grierson and M'Kune Endow-MENT, and the MORTIFICATION to the PARISH SCHOOL, in the County of Kirkcudbright and Parish of Kirkbean, whereof an abstract is appended. Scheme, under the Educational Endowments (Scotland) Act, 1882, for the Administration of the Endowments in the Parish of Kirkbean and County of Kirkcudbright, known as the Marshall Endowment, at present held and administered under a Deed of Donation by Andrew Marshall, Merchant in Glasgow, dated 1st June 1781, and Testament by the said Audrew Marshall, dated 5th September 1783, and recorded in the Burgh Court Books at Glasgow, on 2nd February 1785, which Endowment is held and administered along with a Bequest by the Rev. Thomas Grierson, sometime Minister of the Parish, and a Bequest or Donation by William M'Kune, Netherwood, in or about the year 1846; the said Grierson and M'Kune Endowment; and the Mortification to the Parish School, amounting to a capital sum of £608, and now held and administered by the School Board of the said Parish.

- 1. Transference of Property and Administration to New Governing Body .- From and after the date of this Scheme the said Endowments shall be amalgamated, and the whole rights, funds, and estates, heritable and moveable, belonging thereto or vested in the present governing bodies thereof, shall be transferred to and vested in the School Board of the parish of Kirkbean, in so far as not already so transferred and vested, without the necessity of any new conveyance or instrument, and the whole of such Endowment shall be held and administered by them under the conditions and provisions of this Scheme, and the said School Board shall be the governing body of the Endowment.
- 2. Discharge of Present Governing Body.—The present trustees of the Endowments, not at present held and administered by the said Board, shall transfer and make over to the clerk, treasurer, or other proper officer of the School Board, who shall after the date of this Scheme act as officer of the governing body of the Endowment, all cash balances, books, deeds, and papers to which they have rights as trustees foresaid. On such payment or transference the governing body shall discharge such lawful debts of the Endowments as may remain unpaid by the said trustees, and shall, after satisfactory examination and audit of their accounts, grant them a discharge for their intromissions with the funds of the Endowment.
- 3-8. Business Arrangements; Power of Sale and Investment; Casual Profits; Accounts; Audit; Vested Interests.

paying the necessary expenses of management and the burdens and taxes affecting the Endowment, may apply a sum not exceeding £15 yearly in paying, in whole or in part as they may think fit, the fees of scholars, with books and stationery, at public or State-aided schools in the parish of Kirkbean, for elementary education as defined in the Educational Endowments (Scotland) Act, 1882. The free scholars shall be children whose parents or guardians, not being in receipt of parochial relief, are in such circumstances as to require aid for providing elementary education, and are persons who, in the opinion of the governors, ought not to be required to apply to the Parochial Board for

In the case of children under ten years of age, the selection of free scholars shall be made with due regard to merit, as ascertained by such examination, suited to the age of the candidates, as the governors may from time to time prescribe; or in the case of children for whom such examination is onsuitable, by evidence that the children possess such qualifications as to justify their selection; and in the case of children who have been in attendance at school during one or more school years, the governors shall, in making their selection, give special weight to good conduct, attendance, and progress at school during the previous year. The fees in respect of children under ten years of age shall not be paid for more than one school year without re-appointment, and the amount to be expended in paying fees for such children shall not exceed one-third of the amount to be applied under this section.

In the case of children of ten years of age and upwards, the free scholars shall be selected by competitive examinations, which shall be open to all of the same age who are eligible in terms hereof, whether they have or have not previously been beneficiaries; and for such children the school fees may continue to be paid for such period, not exceeding three years, as the governors may determine. If any scholar gain a school bursary, his school fees shall no longer be paid under this section.

The governors at the end of every school year shall obtain from the teacher or teachers a special report as to the conduct, regularity of attendance, and progress of all scholars whose school fees are paid in whole or in part under this section, and the fees of no scholar shall continue to be paid in regard to whom such report is not satisfactory.

10. School Bursaries.—The governors shall apply an annual sum of £10 in establishing school bursaries, to be called the Marshall School Bursaries, each of the yearly value of not less than £3 and not more than £5. These bursaries shall be awarded by competitive examination among pupils attending public or State-aided schools in the parish of Kirkbean, who have passed the fifth standard of the present Scotch Code, or such standard as may from time to time be fixed by the Scotch Education Department, pursuant to the Education (Scotland) Acts, as that entitling children to total exemption from the obligation to attend school, and whose parents or guardians are in such circumstances as to require aid for giving them higher education; these bursaries shall be tenable for two years at public or State-aided schools in which efficient instruction is given in the higher branches.

11. Grant to School Board for Promoting Higher 9. Free Scholarships.—The governors, after Instruction.—The governing body shall apply the

residue of their free annual income for the promotion of higher instruction by increasing the efficiency of the staff for the higher classes in the public school of Kirkbean, either by adding to their number or otherwise as may be determined, but no part of such annual sum shall be applied in relief of any expenditure which the School Board might reasonably be expected to incur out of the school fund, and the said School Board shall be bound, as a condition of receiving the said sum, to give education gratis to all the children in the said school, who have passed in the fifth standard of the Scotch Code; provided that if it appear to the Scotch Education Department, on such information and after such inquiry as they may deem necessary, that the said annual sum is not being efficiently applied in manner foresaid, they shall have power to require the governing body to apply it to the purposes of the immediately succeeding section, until they have satisfied the Department that they are prepared to comply with the conditions under which the said annual sum is directed to be applied under this section.

12. Bursaries for Higher or Technical Education in the event of Stoppage of Payment to School Board .- In the event of the governing body receiving a requisition from the Department under the provisions of the immediately preceding section, they shall apply the said annual sum in establishing bursaries for higher education, to be called the M'Kune Bursaries, each of the yearly value of not less than £15 nor more than £20. These bursaries shall be awarded by competitive examination among pupils attending public or State-aided schools in the parish of Kirkbean, under such conditions and regulations as to age or otherwise as the governing body may determine; they shall be tenable for such period, not exceeding three years, as the governing body may determine, at such schools for higher education or technical instruction as they may approve. In the event of the Department permitting the said sum to be again applied under the provisions of the immediately preceding section, the governing body shall, in the first place, make payment of any bursaries already awarded under this section.

1, 2. Future Administration; Transference of Property.

3. Constitution and Election of Governing Body.—The governing body, hereinafter called the governors, shall consist of eleven persons, of whom

> Three shall be elected by the Magistrates and Town Council of the City of Glasgow;

> Two shall be elected by the Merchants' House of Glasgow:

> Two shall be elected by the Trades' House of Glasgow;

> Two shall be elected by the School Board of

One shall be elected by the Parochial Board of the City Parish of Glasgow;

One shall be elected by the Parochial Board

of the Barony Parish of Glasgow.

The governors to be elected by the Magistrates and Town Council shall, in the case of the first election, hold office for a period of five years, and thereafter until the first day of August after the expiration of that period. The governors to be elected by the Merchants' House and by the Trades' House, shall, in the case of the first election, hold office for a period of four years, and thereafter until the first day of August after the expiration of that period. The governors to be elected by the School Board, by the Parochial Boards of the City Parish and the Barony Parish, shall, in the case of the first election, hold office for a period of three years, and thereafter until the first day of August after the expiration of that period. The governors shall, in the case of all elections subsequent to the first, hold office for a period of five years from and after the expiration of the term of office of their predecessors, except as hereinafter provided. Each election shall be made at a meeting convened and conducted as nearly as may be according to the rules and practice of the electing body. The governors may be elected by the several electing bodies either out of their own number or otherwise. Anv governor may be re-appointed. The first governors shall be elected as soon as conveniently may be after the date of this Scheme. or other officers of the governors shall, at least one month before the expiration of the term of office of any governor give notice to the proper electing body, which shall, as soon as conveniently may be after such notice, elect a governor to hold office from the expiration of said term. appointment not made as aforesaid within three months from the date of this Scheme, or from the date of the notice of expiration of a term of office

or of a vacancy as hereinafter prescribed, shall in that case be made by the then existing governors.

Vacancies; Meetings; Chairman; Quorum and Execution of Deeds; Minutes; Power to appoint Committee.

12-17. Accounts; Business Arrangements; Casual Profits; Powers of Sale and Investment;

18. First Meeting .- Within two months from the date of this Scheme, a meeting of the governors shall be held, upon the summons of the clerk or agent of the existing governing body. At this meeting they shall make arrangements for the conduct of business, and shall elect a chairman, but they shall not, at this, or any subsequent meeting, transact any business that is not necessary for the immediate conduct of the Trust until the whole of the first governors are elected.

19-21. Clauses relating to Future Administra-

tion; Vested Interests.

Application of Income.

22. Day Industrial Schools.—The governors shall maintain within the buildings known as the Buchanan Institution, or in such other buildings as they may subsequently acquire, a day industrial

school for boys.

23. Class of Children to be admitted to Schools. The governors shall select for admission to the said industrial schools poor and destitute children, giving the preference to orphans and step-children. They may arrange with the Parochial Board of the City Parish of Glasgow and of the Barony Parish of Glasgow, to take in children who are chargeable to the said boards, on such terms as may be agreed on, but at a rate which shall be not less than sufficient to pay the whole cost of the children so taken in.

24. Age of Children.-Children shall not be admitted to the schools before the age of six, nor shall they continue therein after they have attained

the age of fourteen years complete.
25. Subjects of Tuition.—The subjects taught in the school shall be reading, writing, arithmetic, history, and geography, and such other subjects as the governors may from time to time determine.

26. The children shall further, during a portion of each day, receive such industrial training as shall be suitable to their respective ages, in such industrial departments as the governors may think

27. Food and Clothes. - The children shall receive such shelter in the school buildings during the day and such food during the day as the governors may determine. The governors may further give assistance in the way of clothing, in such manner and to such extent as they may think fit.

28. Power to send children to Board Schools .-The governors may, in the case of children above the age of ten, send them for instruction to such public schools as may be agreed upon with the Glasgow School Board, at such rate of fees as

may be arranged with the said Board.

29. Power to Transfer School.-In the event of the governors being of opinion that the purposes hereinbefore specified may and ought to be carried out in whole or in part by the School Board or other public body, they shall have power to close the school or to sell or let it under the provisions of the 15th section hereof, or to transfer the school to such Board or public body, or to enter into an arrangement with them for the joint management of the said school.

- 30. Power to Contribute to Support of School-In the event of the school being so sold or transferred or placed under such joint management, the governors shall have power to make such contribution to the support of the said school or other industrial schools in Glasgow as may be authorised by statue or as they may from time to time determine.
- 31. Power to Establish Evening School Bursaries .- In the event of the school being so sold or transferred or placed under such joint management, the governors may establish bursaries to be awarded by competitive examination among children attending day industrial schools in Glasgow who are not less than eleven and not more than fourteen years of age. These bursaries shall be tenable for such period not exceeding three years as the governors may determine during attendance at evening classes for instruction in higher or technical or scientific subjects in Glasgow, or, in the case of girls, at the classes of the Logan and Johnstone School of Domestic The amount of each bursary shall cover the class fees and the cost of the necessary books together with a sum for maintenance and clothing not exceeding £20 a year in any one
- 32. Apprentice Allowances.-In the event of the school being so sold or transferred or placed under such joint management, the governors may make payment to children who have attended day industrial schools in Glasgow, and who, after leaving such schools, become bound as apprentices, of annual sums not exceeding £20 in any one case, during the whole or such period of their apprenticeship as the governors may from time to time determine. If children who have arrended such schools enter on a trade or occupation in which apprenticeship is not customary, he or she shall enter into such obligations as to service as the governors may think fit, and may in that case receive an annual sum not exceeding £20 for a period not exceeding five years. These annual payments shall be made under such conditions and to such persons for behoof of the said children as the governors may think fit. The governors shall annually cause sufficient inquiry to be made as to the conduct, circumstances, and progress of the children who are in the enjoyment of allowances under this section, and no such payment shall be made or continue to be made to any of them unless the governors are satisfied that he or she is in such circumstances as to require assistance, and that his or her conduct is in all respects satisfactory.
