EDUCATIONAL ENDOWMENTS (SCOTLAND) ACT, 1882.

OTICE is hereby given that the Commissioners under the Educational Endowments (Scotland) Act, 1882, have prepared the Draft of a Scheme for the future administration of the Endowments known as the AYR ACADEMY FUNDS, the Ferguson or Doonholm Mortification, the COWAN BURSARIES, DR. PATON'S FUND, the PIN-MORE BEQUEST, SMITH'S ENDOWMENT, PATERSON'S ANNUITY, SLOAN'S BEQUEST, and the COWAN GOLD MEDAL FUND, the COATS GOLD MEDAL Fund, and the Hamilton Prize Fund, in the County of Ayr and Burgh and Parish of Ayr, whereof an abstract is appended. The Commissioners will, in terms of the Twenty-fourth Section of said Act, receive and consider any objection made to them in writing by any public body or persons interested respecting such Scheme, and any amendments proposed thereon, provided that the same be delivered at their Office, at No. 46 George Street, Edinburgh, within two calendar months from the date hereof. Scheme, under the Educational Endowments (Scotland) Act, 1882, for the Administration of the Endowments known as the Ayr Academy Funds, at present held and administered by the Directors of the said Academy, incorporated by Royal Charter, dated 28th June 1798, for behoof of the said Academy; the Ferguson or Doonholm Mortification, at present held and administered under a Deed of Donation by John Ferguson, Esquire of Doonholm, dated 4th October 1790; the Cowan Bursaries, at present held and administered under the Trust Disposition and Settlement of David Cowan, Esquire of Auchendrane, dated 4th April 1368; Dr. Paton's Fund, at present held and administered under the Will of the late Robert Paton, D.D., Minister of St. David's Parish in Glasgow, dated the Pinmore Bequest, at present held and administered under the last Will and Settlement of Hugh Hamilton, of Pinmore, dated 13th October 1823; Smith's Endowment, at present held and administered under a Disposition and Assignation of Captain John Smith, dated 6th May 1817; Paterson's Annuity, at present held and administered under and in virtue of a Codicil attached to the Will of William Paterson, Attorney at Law, Kingston, Jamaica, dated 30th October 1829, and a Disposition by William Paterson, Esquire of Montgomerie, dated 14th and 17th August and 18th September 1849; Sloan's Bequest, at present held and administered under the last Will and Testament of Miss Margaret Sloan, of Donaghadee, County Down; and the Cowan Gold Medal Fund, the Coats Gold Medal Fund, and the Hamilton Prize Fund, at present held and administered by the Directors of the said Ayr Academy.

Preamble.

1, 2. Future Administration; Transference of Property.

3. Constitution and Election of Governing Body.—The governing body, hereinafter called the governors, shall consist of the following persons,

Two persons elected by the Magistrates and Council of the Burgh of Ayr;

One person elected by the Kirk-Session of Ayr;

Three persons elected by the School Board of Ayr;

Two persons elected by the Directors of Ayr Academy to be members of the governing body for their respective lives or until they shall resign their membership.

On the death or resignation of the first of these life members the Sheriff of the county shall elect one person, and on the death or resignation of the remaining life member the Merchant Company of Ayr shall elect one person. The governors may be elected by the several electing bodies, either out of their own number or otherwise. The governors elected by the Kirk-Session and the Magistrates and Council shall, in the case of

the first election, hold office for a period of five years, and thereafter until the first day of August after the expiration of that period. The governors elected by the School Board, the Sheriff, and the Merchant Company shall, in the case of the first election falling to be made by these bodies and the Sheriff respectively, hold office for a period of three years, and thereafter until the first day of August after the expiration of that period. The governors shall, in the case of all elections or appointments subsequent to the first, hold office for a period of five years from and after the expiration of the term of office of their predecessors, except as hereinafter provided. Each election shall be made at a meeting convened and conducted according to the ordinary rules and practice of the electing body. Any governor may be re-elected or re-appointed. The first governors shall be elected as soon as conveniently may be after the date of this Scheme. The clerk or other officer of the governors shall, at least one month before the expiration of the term of office of any governor, give notice to the proper electing body or to the Sheriff, as the case may be, and the electing body or the Sheriff, as the case may be, shall, as soon as conveniently may be after such notice, elect a governor to hold office from the expiration of said term. Any election not made as aforesaid within three months from the date of this Scheme, or from the date of the notice of expiration of a term of office, or from the date of the notice of a vacancy, as hereinafter prescribed, shall in that case be made by the then existing governors.

4-17. Vacancies; Meetings; Chairman; Quorum and Execution of Deeds; Minutes; Power to Appoint Committees; Accounts; Business Arrangements; Casual Profits; Powers of Sale and Investment; Audit.

18. First Meeting. - Within two months from the date of this Scheme, a meeting of the governors shall be held upon the summons of the Clerk of the Directors of the Academy. At this meeting they shall make arrangements for the conduct of business, and shall elect a chairman; but they shall not, at this or any subsequent meeting, transact any business that is not necessary for the immediate administration of the Endowment until the whole of the first governors are elected or appointed.

19-22. Clauses relating to Future Administration and Discharge of Governing Body.

Application of Income.

23. Application of Income. — The governors, after paying the necessary expenses of management and the burdens and taxes affecting the Endowment, shall apply the free income of the Endowment in the manner hereinafter provided.

24. Free Scholarships. — The governors shall apply a sum not exceeding £30 in paying, in whole or in part as they may think fit, the fees of scholars, with books and stationery, at public or State-aided schools in the parish of Ayr, for elementary education as defined in the Educational Endowments (Scotland) Act, 1882. free scholars shall be children whose parents or guardians, not being in receipt of parochial relief, are in such circumstances as to require aid for providing elementary education, and are persons who, in the opinion of the governors, ought not to be required to apply to the Parochial Board for such aid.

In the case of children under ten years of age, the selection of free scholars shall be made with due regard to merit, as ascertained by such examination, suited to the age of the candidates, as the governors may from time to time pre-scribe; or in the case of children for whom such examination is unsuitable, by evidence that the children possess such qualifications as to justify their selection; and in the case of children who have been in attendance at school during one or more school years, the governors shall, in making their selection, give special weight to good conduct, attendance, and progress at school during the previous year. The fees in respect of children under ten years of age shall not be paid for more than one school year without re-appointment, and the amount to be expended in paying fees for such children shall not exceed one-third of the amount to be applied under this section.

In the case of children of ten years of age and upwards, the free scholars shall be selected by competitive examinations, which shall be open to all of the same age who are eligible in terms hereof, whether they have or have not previously been beneficiaries; and for such children the school fees may continue to be paid for such period, not exceeding three years, as the governors may determine. If any scholar gain a school bursary his school fees shall no longer be paid

under this section.

The governors, at the end of every school year, shall obtain from the teacher or teachers a special report as to the conduct, regularity of attendance, and progress of all scholars whose school fees are paid in whole or in part under this section, and the fees of no scholar shall continue to be paid in regard to whom such report is not satisfactory.

25. School Bursaries.—The governors shall apply an annual sum of not less than £45 in establishing school bursaries, to be called one-half the Ferguson School Bursaries and one-half the Pinmore School Bursaries, each of the yearly value of not less than £5 nor more than £10. These bursaries shall be awarded by competitive examination among pupils attending public or State-aided schools in the burgh or parish of Ayr, who have passed the fifth standard of the present Scotch Code, or such standard as may from time to time be fixed by the Scotch Education Department, pursuant to the Education (Scotland) Acts, as that entitling children to total exemption from the obligation to attend school, and whose parents or guardians are in such circumstances as to require aid for giving them higher education; these bursaries shall be tenable for such period not exceeding three years as the governors may determine at the Ayr Academy.

26. University or Technical School Bursaries. The governors shall apply an annual sum of not less than £80, in establishing bursaries for university education, which shall be called the Cowan Bursaries, each of the yearly value of not less than £20 nor more than £30. These bursaries shall be awarded by competitive examina-tion among those who have been pupils in the Ayr Academy for at least six months before the date of examination; they shall be tenable for such period, not exceeding four years, as the governors may determine, at any Scottish University. It shall be in the power of the governors to award the said annual sum or such portion of its of the said annual sum or such portion of its stay shall think manager in the content of the said annual sum or such portion of its stay shall think manager in the content of the said annual sum or such portions of its said annual sum or such positions. as they shall think proper, in the event of no fully qualified candidate presenting himself for the

University Bursaries, in bursaries of not less than £15 nor more than £20, tenable for such period as the governors may determine at a technical school approved by them.

27. Annual Payment to the School Board of the Burgh of Ayr.—The governors shall pay the whole residue of the Endowment to the School Board of the Burgh of Ayr on condition—

(1) That the School Board shall apply the same for the purposes of higher instruction in Ayr Academy, by augmenting the salaries of the Rector, who shall, in the case of any appointment after the date of this Scheme, be a graduate of some university in the United Kingdom, and of the other teachers in such shares as the governors shall see fit to appoint, or by increasing the teaching staff; and that it shall not be used for the relief of payments from any other quarter, nor to permit the reduction of fees.

(2) That the School Board give free education in the Ayr Academy, with books and stationery, to twelve scholars who have passed the fifth standard, and who shall be selected by the governors by competitive examination under the conditions and regulations of the twenty-fifth section hereof, from boys attending public or State-aided schools in the parish or burgh of Ayr. The free education thus given shall be continued for a period not exceeding three years, and shall include any subjects taught in the school. The governors shall award the benefits of this section in such a way that as nearly as may be the same number of boys shall be elected annually.

The governors shall satisfy themselves from time to time that the said annual payment is applied under the conditions contained herein for the promotion of higher instruction; and, if it appears to them that the said annual payment is not so applied, they shall withdraw the same; provided always that, if the said School Board object thereto, the consent of the Scotch Education Department shall be obtained before the with-

drawal of the said annual payment.

28. Application of Annual Payment to School Board in event of Withdrawal.—In the event of the School Board declining to accept the said annual payment under the conditions of the immediately preceding section, or in the event of its being at any time withdrawn under the provisions thereof, the governors shall apply the said surplus income in establishing bursaries, each of the yearly value of not less than £10 nor of more than £15. These bursaries shall be tenable for a period not exceeding three years at such schools for higher education or technical instruction as the governors may approve, and shall be awarded by competitive examination among the pupils attending public or State-aided schools in the burgh or parish of Ayr, whose age at the date of the competition shall not exceed fourteen years.

29. Forfeiture of Bursaries.—If, in the judgment of the governors, the holder of any bursary shall be guilty of serious misconduct, or fail to make reasonable progress, they may withdraw such bursary, and their determination in such case shall be final.

30. Annual Distribution of Bursaries.—The governors shall establish the bursaries herein provided for in such manner as to secure that they

shall be awarded in as nearly as possible equal numbers in each year.

31. Residue of Income.—The residue of the free annual income, in so far as it has not been applied under the provisions of this Scheme, shall be invested by the governors as soon as it shall amount to £50, and form part of the capital fund of the Endowment.
