Assembly of the Church of Scotland having been transmitted by the Right Honourable John Adrian Louis, Earl of Hopetoun, to the Most Honourable Schomberg Henry, Marquis of Lothian, K.T., Her Majesty's Secretary for Scotland, has been by him presented to the Queen, which Address Her Majesty was pleased to receive very graciously:—

May it please your Majesty,

WE, Your Majesty's loyal and dutiful subjects, the Ministers and Elders of the Church of Scotland, now met in General Assembly, beg with all respect and with all heartiness to thank Your Majesty for Your Most Gracious Letter, and especially for the assurance which it conveys to us of Your Majesty's unalterable affection towards the Church of which we are the representatives.

We acknowledge with thankfulness Your Majesty's gracious recognition of the efforts made by our Church in past times, to carry the light and the consolations of religion into the homes of the people of Scotland. And we beg humbly to assure Your Majesty that it is

our desire, and shall always be our endeavour, under the Divine blessing, to abound more and more in the same good work, and to promote to the utmost of our power both the temporal and spiritual well-being of those who are committed to our care.

We hail, with much satisfaction, the appointment for the second time of the Right Honourable the Earl of Hopetoun as Your Majesty's representative in our Assembly. The ability and dignity and kindliness with which His Grace discharged the duties of his high office last year, secured for him the high respect of all concerned; and this, we are persuaded, will be amply confirmed on the present occasion.

We receive with gratitude Your Majesty's gift of £2000 for the diffusion of Christian knowledge in the Highlands and Islands of Scotland, and we shall be careful to apply it in such a way as to give the fullest possible effect to Your Majesty's wise and pious intentions.

The day on which we received Your Majesty's Gracious Letter, being Your Majesty's Birthday, it has called forth anew our gratitude to Almighty God for having thus far prolonged Your Majesty's most valuable life; and it is our earnest prayer that He may be graciously pleased still to lengthen out the same, and to bless Your Majesty and make

you a blessing for years to come, as he has done so abundantly in the past.

CIVIL SERVICE COMMISSION, June 5, 1888.

The Civil Service Commissioners hereby give notice, that the following Regulations have been approved by the Lords Commissioners of Her Majesty's Treasury, viz.:—

SPECIAL REGULATIONS (Supplementary to the General Regulations issued 8th April 1872, and amended by subsequent notices in the London Gazette), respecting Open Competitive Examinations for the situation of Assistant to the Lecturers on Chemistry, Heat, and Electricity at the Royal Artillery College.

N.B.—These Regulations are liable to alteration for future Examinations.

I. The limits of age for this situation are 25 and 30, and Candidates must be of the prescribed age on the first day of the Competitive Examination.

II. The Competitive Examination will be in the following subjects, viz.:—

1. Chemistry and Heat.

[Skill in the preparation of apparatus, gases, explosives, and compounds required for lectures, and the assistance of students at practical work in the laboratory.]

2. Electricity.

[Skill in the preparation of Batteries, and setting up of apparatus required for lectures, and the assistance of students at practical work.]

3. Metallurgy, Steam, Mechanism, Hydraulics. [Sufficient knowledge for the arrangement of diagrams, specimens, and models required for lectures.]

** No Candidate will be eligible who fails to satisfy the Commissioners in any of these subjects.

III. No Candidate can be admitted to the Competitive Examination who has not previously satisfied the Civil Service Commissioners that he possesses the requisite amount of proficiency in the following subjects:—

1. Handwriting.

2. Orthography.

3. Arithmetic (to Vulgar and Decimal Fractions).

With this view, Preliminary Examinations in these subjects will be held at such times and places as the Commissioners may appoint.

IV. Application for permission to attend an Examination must be made in the writing of the Candidate, at such time and in such manner as may be fixed by the Commissioners.

V. A fee will be required from every Candidate attending an Examination, according to the scale laid down under the Order in Council of 22nd March 1879, by notice in the London Gazette of 29th April 1881.

. The Civil Service Commissioners further give notice, that an Open Competitive Examination will be held in London, under the foregoing Regulations, on the 24th July 1888, and following days.

A Preliminary Examination will be held in London on the 17th July 1888.

The number of situations to be filled will be the number vacant at the time of the Examination.

No person will be admitted to Examination from whom the Secretary, Civil Service Commission, has not received, on or before the 3rd July, an 'application' in the Candidate's own handwriting, on a prescribed form, which may be obtained from the Secretary at once.
