" Houses and Wair Houses and make Your Wifes Widdows and Your Children Fatherless for the " Blood of Shul de hill lyes cloose at Ower Harts

" Take Care Middleton" His Majesty, for the better discovering and bringing 10 Justice the Persons concerned in the faid Ricts, Rabto further and Excesses, is, hereby, theased to promise His most gracious Pardon to any Two of them, and to any One of the Persons concerned in Vriting the said incendiary Letter, (except the Person who actually wrote the fame) who shall discover their, his or her Accomplice or Accomplices therein, fo that he, she or they may be apprehended and convicted thereof
