*Dublin Castle, October 8.*

**T**HIS Day the Parliament having met, according to the Prorogation, his Excellency the Lord Lieutenant went in State to the House of Peers; and being seated on the Throne with the usual Solemnity, the Gentleman Usher of the Black Rod was sent with a Message from his Excellency to the House of Commons, signifying his Pleasure that they should immediately attend his Excellency in the House of Peers. The Commons being come thither accordingly, his Excellency made the following Speech to both Houses:

*My Lords, and Gentlemen,*

**M**Y Experience of your Attachment to His Majesty's Person, and of your Zeal for the Public Service, affords me the best grounded Hopes that nothing will be wanting on your Part to co-operate with His Majesty's gracious Intentions to promote the Welfare and Happiness of this Kingdom; and when to this Consideration I add my Remembrance of your kind Regard to the Ease and Honour of my Administration, I feel the most sensible Pleasure in the present Opportunity which His Majesty has given me of meeting you a Fourth Time in Parliament.

The present Prospect of Public Affairs seems to afford you the fullest Opportunity for Deliberation on such Subjects as immediately relate to your own domestic Happiness; I must therefore recommend to your Consideration whatever tends to promote and strengthen the interior Police of this Kingdom, and such Laws as may be salutary and for the Benefit of the lower Orders of the Community, for these have ever been found the most effectual Means of binding their Affections to their Country, and securing their Allegiance to one common Parent.

*Gentlemen of the House of Commons,*

As in Assembling you together in the last Session it was not His Majesty's Purpose to ask Supplies, but solely to comply with the Wishes of His People, it was not thought proper to call upon you, at that Time, for any further Aid: But as in the ordinary Course it now becomes necessary to provide for the Expences of the ensuing two Years, your last Grants being nearly expired, I have no Doubt of your turning your Thoughts to that important Subject, and of your granting such Supplies as shall be found necessary for the honorable and firm Support of His Majesty's Government, for the Security of this Kingdom, and for the Maintenance of the Public Credit.

I have ordered the proper Estimates and Accounts to be laid before you, from which you will find, not only that the Revenue has fallen considerably short of former Years, but that the Deductions made therefrom for Payment of different Grants for Premiums, Bounties, and Public Works, have

been so very great, that it has not been nearly sufficient to defray the Charges of His Majesty's Establishments, and other necessary Expences of Government, and that a large Arrear has been incurred on that Account. If such Grants are judged proper to be continued, either for these or other Public Uses, you will observe, that it is impossible that the Revenue, as it now stands, can answer those Services, and also the Support of Government: I therefore think it incumbent upon me to recommend this Subject to your most serious Consideration.

It is with Concern that I must ask a Sum of Money to discharge the Arrears already incurred on His Majesty's Establishments; but you will find that they have been unavoidable, for that the strictest Economy has been used, not only in the Charges of the late Augmentation, upon which a very large Saving has been made, but in the Reduction of the Staff, which is now diminished to the Number directed by His Majesty.

*My Lords, and Gentlemen,*

The Birth of another Prince is such an Addition to His Majesty's Happiness and our Security, that it must afford us the truest Satisfaction.

It is my indispensable Duty to recommend particularly whatever interests the Protestant Religion: There can be no Provision in its Favour, which shall tend to carry into Execution the good Effects of that important Law for limiting the Duration of Parliaments, and are, at the same Time, consistent with the Principles of Humanity, and the natural Rights of Mankind, which shall not have my hearty Concurrence.

The illegal Associations and audacious Outrages committed in different Parts of this Kingdom, particularly in the North, deserve your most serious Attention: They are as destructive to Commerce; as disgraceful to Liberty.

The Wisdom of former Parliaments, and the Affection of my Predecessors in this high Station for your Interests, have uniformly co-operated in Support of your Charter-Schools and your Linen Manufacture: I am persuaded our Zeal for these National Objects will equal theirs.

His Majesty has the firmest Reliance on your Loyalty and Duty; and is persuaded that your Proceedings will be no less consistent with your own Dignity than with the true Interests of your Country. For my Part, I have resided so long amongst you, that I trust it will be needless for me to make any new Declarations to you of my Attachment and Affection.

We most sincerely congratulate your Majesty on the happy Event of the Birth of another Prince; and do assure your Majesty, that we shall always consider every Addition to your Royal Family, as a further Security to us of our Religion, Laws, and Liberties.

And we beg Leave to declare our Readiness cheerfully to contribute, as far as possible, to whatever may strengthen and support the Religious and Civil Rights of Mankind, and to whatever may give Effect to the important and constitutional Law for Limiting the Duration of Parliaments.

As we have an Abhorrence of those audacious Outrages, which of late have appeared in different Parts of this Kingdom, we do assure your Majesty, that we shall not fail seriously to deliberate upon them, and to concur in every wise Provision that can be formed to remedy so great an Evil.

We humbly acknowledge to your Majesty the unfeigned Pleasure we feel in the Opinion you are graciously pleased to entertain of our Loyalty and dutiful Attachment to your Royal Person and Family; and do assure your Majesty, that we will ever, by our Conduct, endeavour to merit and preserve your Majesty's gracious Favour and Protection.

His Excellency the Lord Lieutenant's Answer,

*I Return the House of Commons my most sincere Thanks for this very kind and affectionate Address, which gives me the greater Satisfaction, as it follows your Experience of my Conduct during a Residence of almost four Years in this Kingdom.—Nothing shall be wanting, on my Part, to merit the Continuance of your Approbation and Confidence; and it will be a most pleasing Part of my Duty, in this high Station, most faithfully to represent to His Majesty the unshaken Loyalty and Affection of the Commons of Ireland.*

Gibraltar, September 16. On Saturday the 7th Instant about Noon, the Venus Frigate, having His Royal Highness the Duke of Gloucester on board, and the Alarm, appeared in the Offing: As soon as the Admiral could plainly discover the Standard at the Main Top Mast Head, he saluted with Twenty-one Guns. The Frigates came to Anchor about Two o'Clock, when the Garrison saluted with One and Twenty Guns from the Saluting Battery. Lieutenant Colonel Phillips was immediately sent off to congratulate his Royal Highness, and receive Orders about his Royal Highness's Landing. When his Royal Highness went into the Boat, the Standard at the Main Top Mast Head was struck, and hoisted in the Boat, on which all the Men of War saluted with Twenty-one Guns each. His Royal Highness landed about Six, and was received by the Governor, Lieutenant-General Cornwallis, at the Water-Port. The Flag of the Garrison was lowered, the Standard hoisted, and a Salute from all the Guns on the Line-Wall from the Grand Battery to the South Port. His Royal Highness was conducted through the Main Street to the Convent, the Garrison being under Arms, drawn up in two Ranks, from Water-Port to the Convent, where there was a Captain's Guard of Grenadiers with Colours. When the Troops were dismissed, the Field Officers were introduced to his Royal Highness; and about Nine o'Clock the next Morning all the Officers of the Garrison had the same Honour. The following Days his Royal Highness employed in viewing the Troops, and in visiting every Part of this Garrison with the greatest Minuteness and Attention. On the 13th in the Morning, his Royal Highness rode towards the Spanish Lines, attended by all the Field Officers; at the Miquelet Huts he was met by Mr. Mendoza, the Spanish General, and several Spanish Officers; and at the Ring a Body, of about 120 Spanish Horse, being Detachments from Four different Regiments, were drawn up to escort him. His Royal Highness, after visiting the Lines, alighted at the Guard-Room near the Barrier. The Spanish General conducted his Royal Highness back to our Barrier at Bayside, where they parted. His Royal Highness came within the Barrier, and continued on the Causeway until the Spanish General was out of Sight. About Eleven o'Clock his Royal Highness went to the Water-Port, where General Cornwallis waited to receive him. His Royal Highness immediately embarked, the Garrison and Men of War paying him the same Compliments

pliments as when he landed, except that the Troops were not under Arms. On his Royal Highness's going on board, the Frigates got immediately under Way.

*Port Mahon, Sept. 28.* His Royal Highness the Duke of Gloucester, in the Venus Frigate, accompanied by the Alarm, arrived here on Saturday Morning the 21st Instant. During his Royal Highness's Stay in this Island, he visited the Fort at St. Philip's, and viewed the Troops. His Royal Highness re embarked on the 23d, and sailed for Genoa with a fair Wind.

*Genoa, Sept. 30.* On the 27th in the Morning his Britannic Majesty's Ships Venus and Alarm arrived here, the former having on Board his Royal Highness the Duke of Gloucester. Soon after the Venus had dropped Anchor, the Master of the Ceremonies and the Captain of the Port were sent on board, with a Compliment from the Republic, to beg his Royal Highness would receive a Deputation of six Noblemen, (who had been previously named for that Purpose) and likewise accept a Lodging which the Republic had prepared for his Reception, as also the usual Present of Refreshments; but his Royal Highness chose to decline them, at the same Time expressing his perfect Sensibility of the Civilities intended to be shewn to him. His Royal Highness has since received Visits from some of the Nobility, but declines any Public Attentions.

The Tunbridge Bag of Letters, which should have arrived at this Office on Monday Morning last, being lost or stolen out of the Mail somewhere between Seven-Oaks and Bromley, two of the Bank Notes sent in the said Bag were this Day put off in Rosemary Lane at two Cloaths Shops, by two Men: The one about thirty-six or forty Years old, five Feet nine or ten Inches high, his own straight Hair, a Brown Complexion, long Nose, and long Visage; had on a light coloured Coat, and Scarlet Waistcoat, and dirty Leather Breeches; and who bought, fitted for his own Size, a Salmon-coloured Suit of Cloaths, Lining and Basket Buttons of the same, with a plain Cuff, and fall-down Collar, a Cinnamon-coloured Surtout, and a Pair of new Buck-skin Breeches, marked on the Inside of the Waistband with the Shop Mark, E I. The other, stout set, about twenty-eight Years old, five Feet six or seven Inches high, his own straight Hair, swarthy Complexion, had on a round, dirty, or brown Linnen Waggoner's Frock, Scarlet Jacket, with Cuffs, dirty Buckskin Breeches, and who likewise bought, for his own Size, a Blue Cloth Coat, Scarlet Waistcoat, and a Chocolate-coloured Bath-coating Surtout.

Yesterday Morning about Four o'Clock the Post-Boy driving the Mail-Carriage with the North-Road Mails from this Office, was attacked and robbed by two Men on Foot near Hundsfields, about Seven Miles and an Half from London on the Road to Enfield, who presented a Pistol to the Boy, and ordered him to drive into an inclosed Field some Distance from the Road, where, after binding his Hands and Legs, and leaving him about Thirty Yards from the Carriage, they cut and broke open the Roof of it, and stole thereout the whole North Mail except the St. Ives Bag; and in the Afternoon the greater Part of the Bags were found unopened in a Ditch not far from the Place where the Robbery was committed, and were immediately forwarded from hence by Express, but the following Bags of Letters are still missing, viz.
