Westminster, June 9. HIS Day His Majesty came to the House of Peers, and being in His Royal Robes feated on the Throne with the ufual Solemnity, Sir Francis Molyneux, Gentleman Usher of the Black Rod, was fent with a Melfage from His Majesty to the House of Commons, commanding their Attendance in the House of Peers : The Commons being come thither accordingly, His Majefty was pleafed to give the Royal Affent to

An AI for granting to His Majefly a certain Sum of Money out of the Sinking Fund, and for applying certain Monics, therein mentioned, for the Service of the Year One Thousand Seven Hundred and Seventy-two ; and for further appropriating the Supplies granted in and for further appropriating the Supples granica in this Seffion of Parliament; and for making forth Du-plicates of Exchaquer Bills, Lottery Tickets, Certifi-cates, Receipts, Annuity Orders, and other Orders loft, -burnt, or destroyed.

An Act for rendering the Payment of the Creditors of Infolvent Debtors more equal and expeditions, and for regulating the Diligence of the Law by Arreftment and Poinding; and for extending the Privilege of Bills to promiffory Notes; and for limiting Adions upon Bills and promiffory Notes, in that Part of Great Britain called Scotland

An A& for repealing feveral Laws, therein men-tioned, against Badgers, Engroffers, Forestallers, and Regrators; and for indemnifying Perfons against Pro-fecutions for Offences committed against the faid Acts.

An Act for the better Regulation of Buildings and Party-Walls within the Cities of London and Weft-minster, and the Liberties thereof, and other the Parifhes, Precincts and Places in the Weekly Bills of Mortality, the Parishes of St. Mary-le-Bon and Pad-dington, St. Pancras, and St. Luke at Chelsea in the County of Middlefex ; and for the better preventing of Mischiefs by Fire within the said Cities, Liberties, Parishes, Precincis, and Places; and for amending and reducing the Laws relating thereto into one AR; and for other Purpofes. And to Two Private Bills.

After which His Majesty was pleased to make the following most gracious Speech :

#### My Lords, and Gentlemen,

Cannot put an End to this Selfion of Parliament, without expressing the Satisfaction I have felt in observing the Temper, and the Prudence, which have governed all your Deliberations during the Courfe of it, and without returning you My particular Thanks for the fresh Proof, you have given, of your affectionate Attachment to Me, in the additional Security you have provided, for the Welfare and Honour of My Family.

I can with great Pleafure acquaint you, that the Difpolitions of the Powers of Europe give Me the throngeft Reafon to believe, that this Nation will not be disturbed in the Enjoyment of the Blessings of Peace.

Gentlemen of the Houfe of Commons, I thank you heartily for the Supplies, which you have granted with fo much Chearfulnels and Dif-

patch, and for the ample Provision you have made for every Branch of the Publick Service : And I fee with Pleasure, and Approbation; that you have at the fame Time been able, by a proper Difposition of the Publick Money, to make a further Progress in reducing the National Debt.

My Lords, and Gentlemen,

I make no Doubt but that you will carry into your respective Countries the fame Principles, and the fame Zeal for the Publick Good, which I have experienced from you in Parliament; and that you will continue to exert your best Endeavours to cultivate and improve a Spirit of Harmony and Confidence amongit all Ranks of My Faithful Subjects : Let it be your conftant Care to convince them, that, without a due Reverence for the Laws, and a chearful Obedience to just Authority, neither their Civil nor Religious Rights, and Liberties, can be enjoyed in Comfort, or Security; and to affure them, that I confider their Interests as inseparably connected with My own, and that I am, and have ever been, perfuaded, that the Profperity, and Glory, of My Reign, mult depend on My pollefling the Affection, and maintaining the Happinels, of My People.

My Lords, and Gentlemen,

## My Lords, and Gentlemen,

Cannot put an End to this Seffion of Parliament, without returning you my particular Thanks for your long and close Attention to the Publick Bufinéls.

I congratulate you on the many excellent Laws which have received the Royal Affent this Seffion. The Act for Preventing the Delays of Juffice, by reason of Privilege of Parliament, must be received as a very itrong Mark of your difinterested Regard for the Rights and Welfare of your Fellow Subjects. The Act to prevent Frauds committed by Bankrupts, and that for rendering Securities by Mortgage more effectual, cannot fail to produce the moft falutary Ef-fects, by reftoring that Credit and Confidence amongst the People, which have been much wanted, and are effentially

effentially neceffary, in this Commercial Country; and it was with particular Satisfaction that His Majesty gave His Royal Confent to these Laws, which do Honour to your Deliberations, and are fo wifely calculated for the Publick Good.

Gentlemen of the House of Commons, I thank you, in His Majesty's Name, for the Supplies which you granted at the Beginning of this Seffion; they shall be faithfully applied to the Sup-port of His Majesty's Establishments, and to the Advancement of the Publick Service : But, although I have Expectations that the Act for amending and explaining a Claufe in the Act of Tonnage and Poundage will be productive of fome Addition to His Majesty's Revenue, I think it my Duty to inform you that the Arrears, which had been incurred upon His Majesty's Establishments Civil and Mili-tary, before the Time of your Meeting, made it neceffary to borrow One Hundred Thousand Pounds, immediately after the Act was paffed which gave Authority for that Purpose; and, that Sum not proving fufficient, I have, sometime fince, been obliged to order the further Sum of One Hundred Thousand Pounds to be raifed, being the Remainder of the Credit intrufted to me by that Act.

So early a Demand for the whole Loan gives me Reason to apprehend that, unless there should be a confiderable Increase in His Majesty's Revenue, a ftill greater Arrear will accrue before the ufual Time of your Meeting in another Seffion.

I do therefore most earnestly recommend it to you, to take into your ferious Confideration, (between this and the next Seffion of Parliament) what will be the beft Method of making Provision for fuch Deficiencies as arife upon the present Duties, so as to guard against any farther Increase of the National gu. Debt.

The additional Duties given for the Support of Government, in Aid of His Majesty's Hereditary Revenue, are nearly the fame which were granted in the Year 1727, at the late King's Accession. Had they been folely applied to that Purpose, they would have been fully sufficient, and no Debt or Arrear would have been contracted or incurred; but the large Expence occasioned by the many Premiums, now payable under different Heads, must necessarily continue to increase both; it will therefore be true Policy, and worthy of your Wifdom, to give parti-cular Attention to this Object, and, by prudent Regulations, to form and establish such a System, as will beft obviate any further Inconvenience, and moft effectually promote every great National Purpofe.

## My Lords, and Gentlemen,

It gives me great Pleasure to observe that the Tumults and Outrages of the lower Ranks of People, which unhappily disturbed fome of the Northern Counties in this Kingdom, have now fubfided. I flatter myfelf that these deluded Persons are fully convinced of the Atrociousness of their Attempts, and of the Impoffibility of effecting any of the Purpofes intended by them — I would however recommend it to by them fuch Gentlemen, whofe Weight and Influence lie particularly in those Parts, to have a watchful Eye over their Behaviour, and to exert themselves, with the other Civil Magistrates, in enforcing a due Obe-dience to the Laws; and J doubt not that, by their Authority on one Hand, and by their Juffice and Moderation on the other, a thorough Reformation will be effected, and the Difpositions of the People reclaimed to Peace and good Order.

It gives me great Concern to fee the Affiftance of the Military Power fo frequently called, for nothing can be more worthy of your ferious Reflection, than to render that Refource unnecessary by a judicious Improvement of your Police, and providing for the due Execution of the Laws.

His Majefty gave it in express Command to me, to make your Interefts and Profperity the great Objects of my Administration; and my own Inclinations incited me to a strict and zealous Performance of that Duty. I have, upon every Occafion, endeavoured, to the utmost of my Power, to promote the Publick Service; and I feel the most perfect Satisfaction in now repeating to you my Acknowledgments for the very honourable Manner in which (after a Refidence of near five Years amongst you) you have declared your entire Approbation of my Conduct. Be affured, that I shall always entertain the most ardent Wishes for your Welfare; and shall make a faithful Representation to His Majesty, of your Loyalty and Attachment to His Royal Perfon and Government.
