After the Ceremony, which was performed in the Chapel, and conducted with great Solemnity, the Cardinal Patriarch sang Te Teum. As the Infants were below in the Chapel, their Galleries were allotted to the Foreign Ministers, who accordingly all placed themselves

Berlin, December 22. His Prussian Majesty, the Prince and Princess of Prussia, and the Landgrave of Hesse Cassel, arrived here this Morning about Eleven o'Clock from Potzdam, and immediately afterwards the Foreign Ministers and Nobility waited on his Majesty.
