N Wednesday Evening the 17th Instant, about Six o'Clock, His Sardinian Majesty was taken ill, and at Two the next Morning he lost his Speech, and apparently all Kind of Sensation, not taking any Nourishment from that Time, or shewing any other Sign of Life, than barely continuing to breathe, till near One o'Clock this Morning, when he expired, as sincerely lamented by all his Subjects, as he had constantly lived beloved and respected by them, during a Reign of upwards of Forty Years.

St. James's, February 20, 1773 Whereas it has been humbly represented to the King, Ibat on the 2d Instant, about Seven of the Clock in the Evening, John Bainbridge, of Low Harrowgate in the Parish of Pannell in the County of York, Land-Surveyor, was attacked on the Turnpike Road between Knaresbrough and Low Harrowgate aforesaid, by two Rnareforcings and Low Harrowgate aforefaia, by two
Perfors on Fcot, one of whom held his Mare's Bridle,
and the other prefented a Pistol to his Breast, and
robbed him of Twelve Shillings in Silver, and Half a
Guinea in Gold; that, not content with this, the Perfon threatened to fire his Pistol at Mr. Bainbridge, unless he also delivered to them his Pocket-Book; whereupon the said Mr. Bainbridge disengaged himself from them by shring a Pistol at the Person who held the Pistol to him, which wounded him so that he fell backwards; at the same Time Mr. Bainbridge seized the Person who beld his Mare's Bridle by the Hair of his Head, and, the Mare taking Fright and running away, Mr. Bain-bridge dragged the Man with him about an bundred Yards, when two other Persons attacked him; one of whom struck him with a Stick on the Back of his Neck, and the other fired a Pistol at him, the Ball of which lodged in his Pocket-Book; by Means of which last Attack, the said Mr. Bainbridge let go his Hold, and dropped the Person be had held by the Hair, his Mare still continuing to run full Speed: His Majesty, for the better discovering and bringing to Justice the said Offenders, is bereby pleased to promise His most gracious Pardon to any one of them, (except the Perjon who actually fired the Pistol at Mr. Bainbridge) who shall discover his Accomplice or Accomplices therein, so that he or they may be apprehended and convicted SUFFOLK. thereof.
