tificrie of the Life of his, her, or their respective i Naminee, figned by the Minister, or in his Abfence by the Curate of the Parish where such Nominee shall be then living, upon the Day when the faid half yearly Payment shall become due, if such Nominee shall be then reliding in the Kingdom of Ireland ; which Certificate the faid Minister or Curate is hereby required to make without Fee or Reward ; and the faid Certificate shall be filed in the faid Office of the Vice Treasurer or Vice Freafurers, Paymaîter or Receiver-General, his or their Deputy or Deputies, who are hereby authorized and required, whenever he or they shall find it necessary to examine upon Oath, which Oath he or they are hereby impowered to administer, any Person intitled to an Annuity, or any other Person whatsoever, touching the Existence of any Nominee or Nominees.

And be it further enacted by the Authority aforefaid, That in Cafe any Nominee fhall, at the Time of fuch Demand, be refident beyond the Seas, and any one or more of the Barons of the Exchequer for the Time being, fhall certify, that upon Proof to him or them made, which Proof he and they is and are hereis, authorifed and required to take in a Summary Way, it doth feem probable to him or them, that the faid Nominee is living, which Certificate is to be given, and Examination made without any Fee or Charge, the faid Certificate being filed as aforefaid, fhall be a fufficient Warrant for Payment of the faid Annuity or Annuities half vearly, to the refpective Subfribers, their Executor, Administrators, or Afligns

And be it further enacted by the Authority afo.ef.id, That in cafe any Perfon, who by the Intent of this Aft thall be entitled to receive any Annuity or Annuities as aforefaid, thall neglect to demand the fame in Manner aforefaid for the Space of the Years, he or the thall for ever lofe and forfeit the fame, as if his or her refpective Nominee had been dead at the Commencement of the taid three Years.

And to the Intent that it may appear upon every half yearly Payment un o and amongft what Feifons, and in what Proportions the faid Annuities are to be diffribured, be it enacted by the Authority aforefaid. That in the faid Office every halr Verr within twenty Days before the refpective Days of Payment, there thall be made up an Account of the feveral Nominees whole Deatns are come to Knowledge; and of the feveral Subforibers who have made Default in making Demand as aforefaid.

And be it enacted by the Authority aforefaid, That if any Perfon fhall demand Payment of any Sum for any Life not in Being, knowing the fame to be expired, the Perfon fo making faid Demand, fhall, upon Proof thereof, for feit treble the Sum fo demanded to any of the remaining Subscribers in the fame Clafs, who will fue for the fame; to be recovered by Action of Debt, Bill, Plaint, or Information in any of His Majefly's Courts of Record at Dublin, in which no Edoign, Protection, Wager of Law, or any more than one Imparlance fhall be allowed. And that in every Suit for Recovery of the faid Sum, the Proof of the Existence of fuch Life at the Time of fuch Demand, fhall lie upon the Perfon fo demanding as aforefaid.

And be it further enacted by the Authority aforefaid, That if any Perfon shall receive one or more Half-yearly Payment or Payments of the faid Annuity or Annuities after the Death of any Nominee or Nominees, for whose Life or Lives such Annuity or Annuities was or were payable, it shall be lawful for any Subscriber in the Class in which such Nominee was named, to require the fame to be repaid into the Office of the Vice-Treasfurer or Vice-Treasfurers, Paymaster, or Receiver General, his or their Deputyor Deputies, for the Benefit of the Subt, "ers in such Class; and in Case of Refusal or

Neglett to pay in the fame within one Month after fuch Demand, fuch Perfon fo refußing or negletting; fhall forfeit treble the fum fo received; to be recovered by Action of Debt, Bill, Plaint, or Information, in any of His Majefly's Courts of Record at the City of Dublin, in the Name of fach Subferiber who thall make the Demand as aforefaid; in which Action no Efficien, Protection, Privilege, or Wager of Law, or more than one Impartance thall be allowed; and upon the Trial of the faid Action, the Proor that the Nominee or Nominees were living at the Time fuch Payment or Payments fo required to be repaid became due and payable as aforefaid, thall he on the Subferiber or Perfon to whom or for whole Benefit the faid Annuity was fo paid.

And be it further enacted by the Authority aforefaid, That all and every Subscriber and Subscribers, his, her, or their Executors, AumInistrators and Affigns, within one Month next after Notice of the Death of his, her, or their respective Nominee or Nominees, fhall certify fiel Death to the Vice-Treasurer or Vice. Treasurers, Pay-maiter or Receiver General, his or their Deputy or Deputies for the Time being, and mall also within three Months after fuch Notice, deliver, or cashe to be delivered up to the faid Vice-Treasurer or Vice-Treas iurers, Paymader or Receiver General, his or their Deputy or Deputies, his, her, or treir Débenture; by which he, the or they was or were entitled during the Life or Lives of fuch' Nominee or Neminees, to receive any Annaity or Annuities as aforefuid, in Cafe fuch Debenture be in his, her, cr their Hands or Power, and in Default thereof, fuch Subiciiber or Subscribers; his, her, and their Executors, Administrators and Affigns, Inall forfeit the Sum of Twenty Pounds; to be recovered by Action of Debt, Bill, Plaint or Information, in Manner as aforefaid, and to be paid and received to the Uie of any Perfon who fnall ue for the fame. --

And be it further eracted by the Authority aforefaid, for the better encouraging Perfons to advance the f.id Sum not exceeding the faid Sum of Two rlundred and Sixty-five Thoufand Pounds, upon the Terms aforefaid, That all Receipts and litiues, and all other Things directed by this Act to be performed in the Office of the Vick-Treaiurer or Vice-Treafurers, Paymafter or Receiver General, his or their Deputy or Deputies, fhall be acne and performed by the Officers there, without demanding or receiving directly any Fee, Gratuity, or Reward for the fame

ty, or Reward for the fame Provided always, and be it enacted by the Authority aforefaid, That in Cafe the Vice-I reafurer or Vice-I reafurers, Paymafter or Receiver General, his or their Deputy or Deputies, thail make Payment of any Annuity of Annuities as aforefaid, upon fuch Certificate as is before directed, uch Officer thall not incur an Penalty; Forfeiture, or Difability, or be liable to any Action of the Subforibers for doing thereof, though the faid Certifacate be forged or falle, or the faid Nominee be dead, unlefs the faid Officer did know at the Time of fuch Payment that the faid Nominee was dead, or that the faid Certificate was forced or falle.

And be it further enacted by the Authority aforefaid, That all and every Perfon and Perfons refiding in the Kingdom of Ireland, who fhall fubfcribe one or more Hundred Pounds towards raifing the faid Sum not exceeding the Sum of Two Hundred and Sixty-five Thoufand Pounds, fhail at or before the Time of nominating the Life or Lives during which he, fhe, or they fhall be intitled to receive fach annual Intereft, with Benefit of Survivorfhip as aforefaid, make Oath (or, being a Quaker, foleinn Affirmation) before fome Juffice of the Peace of the County, or County of the City, or County of the Town where fuch Perion or Perfons (o nominated fhall refide, to the following Effect :
