And Our Will and Pleasure is, That Our Solicitor do cause printed Copies hereof to be sent to the Sheriffs of the several Shires, Stewarts of Stewarties, and Bailiffs of Regalities, and their Clerks, whom We ordain to see the same published; and We appoint them to send Doubles hereof to the several Paroch Kirks within their Bounds, that upon the Lord's Day immediately preceding the Day above mentioned, the same may be published and read from the Pulpits immediately after Divine Service.
