And whereas His Majesty was like-wise pleased, by His Royal Proclamation, bearing Date the 15th Day of August last, to promise and declare, That every Able-bodied Landman, not above the Age of Thirty-sive, nor under the Age of Twenty Years, who should voluntarily enter him-felf to serve on Board any of His Majesty's Ships, on or before the 31st Day of October then next, should receive as of His Majesty's Royal Bounty, the Sum of Thirty Shillings each Man, to be paid in Manner thereby directed. And whereas the Time limited by the faid Proclamations, for Payment of the said Bounties and Rewards, hath been prolonged and extended to the 30th Day of this instant April; and it being judged expedient for His Majesty's Service that the said Bounties and Rewards should be continued to be paid for some Time longer; His Majesty, with the Advice of His Privy-Council, doth therefore order, and it is hereby accordingly ordered, that the Time limited for Pay ment of the faid Bounties and Rewards be prolonged and extended from the said 30th Day of this instant April to the 30th Day of June next, inclu-sive. — Whereof all Persons concerned are to take Notice, and govern themselves accordingly.
