The following Addreſs was preſented to the Earl of Buckinghamſhire, Lord Lieutenant of this Kingdom.

To His Excellency John Earl of Buckinghamſhire, Lord Lieutenant General and General Governor of Ireland,

The humble Addreſs of the Roman Catholick Gentlemen of the County of Longford.

*May it pleaſe Your Excellency,*

WE, His Maſteſty's loyal Subjects, the Roman Catholicks of the County of Longford, conſcious of the many Bleſſings we have enjoyed under the happy Reigns of the Illuſtrious Houſe of Hanover, and impreſſed with the ſtrongeſt Sentations of Gratitude and Loyalty, beholding with the utmoſt Concern the unhappy Diſturbances of ſome of His Maſteſty's Subjects in North-America, ſupported by their Adherents in France, to the great Annoyance of our Trade and Buſineſs, moſt humbly beg Leave to aſſure your Excellency, in the moſt ſolemn Manner, by every Tye ſacred in the Breſt of Men, of our inviolable Fidelity and Attachment to His Maſteſty's Perſon and Government, and that we will with our Lives and Properties ſupport the Honour and Dignity of His Crown, and humbly hope we may be tried by our Actions.

Happy in being governed by a Vice-Roy, from whoſe wife and benign Administration and diſtinguiſhed Abilities we have every Bleſſing to expect, and every good Subject of His Maſteſty in this Kingdom a Certainty of being faithfully repreſented to the Throne; We humbly offer our Hearts, our Hands, and our Properties, to the Diſpoſal of His Maſteſty, and the Direction of your Excellency. General Poſt-Office, April 7, 1778.

ON Saturday laſt the 4th Inſtant, about Eleven at Night, the Poſt Boy was attacked and robbed, Eight Miles from York, in the Road to Malton, of the Bag of Letters from this Office of Thursday Night laſt the 2d Inſtant, for Scarborough, Malton, Whitby, and other Places within the Delivery of Scarborough and Malton, and alſo of the Bag with the Bye and Roa Letters for the ſame Places.

The Perſon who committed this Robbery was then on Foot, but when he paſſed two Turnpike Gates in the Neighbourhood was mounted upon a Light Bay mettled Horſe, about Fourteen Hands and an Half high, ſtrong made; and the Bar-keepers agree with the Poſt-Boy in the Deſcription of the Robber, that he was a ſtout Man, Six Feet high, and thin in the Face, with Black Stockings, Waſtcoat and Breeches, and Brown Copper-coloured Coat; his own ſhort curled Hair powdered, with a round Hat, two Sides of it tied up; and the Poſt-Boy obſerved, whiſt he lay with his Hands and Feet bound in a Field adjoining the Road, that the Robber put the Bills, &c. which he took out of the Letters, into the inſide Pocket of his light Great Coat.
