AT the Court at St. Jamer's, the 20th of August,

PRESENT. The KING's Most Excellent Majesty in Council. HEREAS the Time limited by His Majesty's Order in Council of the 21st of May last, for prohibit ing the Exportation out of this Kingdom, or carrying Coastwise, Gunpowder, Salt-petre, or any Sort of Arms or Ammunition, will expire on the 23d of this instant August: And whereas it is judged expedient that the faid Pro-hibition should be continued for some Time longer, except in those Cases where (for the Be-nest and Advantage of Trade, and for the Use and Defence of Ships trading to Foreign Parts, and of the Transports and Victualling Vessels employed in His Majesty's Service) His Majesty, by His several Orders in Council of the 13th and 27th of October, and of the 6th and 22d of November, 1775, of the 5th and 19th of February, and the 23d of August and 25th of September, 1776, of the 16th of April, the 13th of August, and the 3d and 10th of October, 1777, of the 19th of June, the 7th and 26th of August, and the 10th of September 1778, has thought proper to permit and allow the Exportation of, and carrying Coastwife, Gunpowder, Saltpetre, Arms and Ammunition, under certain Conditions and Restrictions mentioned in the faid Orders: His Majefly doth therefore, by and with the Advice of His Privy Council, hereby order, require, prohibit, and command, that no Person or Persons whosoever (except the Master-General, Lieutenant-General, or Principal Officers of the Ordnance, for His Majetty's Service) do, at any Time during the Space of Three Months, to commence from the faid 23d Day of this instant August, presume to transport into any Parts out of this Kingdom, or carry Coastwise, any Gunpowder, Saltpetre, or any Sort of Arms or Ammunition, or ship or lade any Gunpowder, Saltpetre, or any Sort of Arms or Ammunition, on Board any Ship or Vessel, in order to transporting the same beyond the Seas, or carrying the same Coastwise, except in the Cases comprized within the aforementioned Orders in Council, without Leave or Permission in that Behalf first obtained from His Majesty or His Privy Council, upon Pain of incurring and suffering the respective Forseitures and Penalties inflicted by an Act passed in the 20th Year of His late Majesty's Paign environment (4 An Act) His late Majetly's Reign, entituled, "An Act to impower His Majetly to prohibit the Exportation of Saltpetre, and to enforce the Law for empowering His Majesty to prohibit the Exportation of Gunpowder, or any Sort of Arms and Ammunition; and also to impower " His Majesty to restrain the carrying Coastwife of Saltpetre, Gunpowder, or any Sort of Arms or Ammunition." — And the Lords Commissioners of His Majesty's Treasury, the Commissioners for Executing the Office of Lord High Administration of Court Principles of Lord High Administration of Court Principles of Court
