HEREAS the Time limited by His Majesty's Order in Council of the 16th of February last, for prohibiting the Exportation or Carrying of Copper Coastwife (except under the Rules and Regulations therein expressed) will expire on the 24th of this instant May; and it being judged expedient that the said Prohibition should be continued for some Time longer, so as that the Exportation or carrying of Copper Coastwise may continue to be restrained, under the Rules and Regulations as the list of the Part of the Rules. Majefty is thereupon pleased, by and with the Advice of His Privy Council, to order, that the said Prohibition be continued for Three Months, to commence from the 24th Day of this instant May; but it is His Majesty's Pleasure that the same shall not be taken to extend to any Sort of Copper to the Expected or sort Coastwife for His Majesty's to be Exported or sent Coastwife for His Majesty's Service, by Order and under the Directions or Li-cence of the Commissioners of the Navy, nor to prevent the transporting or carrying Coastwise of any Sort of Copper (except Sheets of Copper of and under the Weight of Two and an Half Pounds to the Foot Superficial) without any Security being required; nor to the exporting the fame to any Parts beyond the Sea, to which it may lawfully be exported (except to any of the Ports belonging to France or Spain) upon Condition that all such Copper as is intended for Exportation shall be intended and argument by an Access of some free and examined by an Agent or Agents, appointed or to be appointed by the Commissioners of His Majesty's Navy; and that a Certificate, under the Hand and Seal of the said Agent or Agents, shall be first had and obtained, setting forth, that no Part of the same consists of Plates of Copper, or Sheets of Copper (except as hereinafter excepted) or Nails made in Whole or in Part of Copper, which can be made Use of for the Purpose of sheathing and coppering Ships or Vessels; which Certificate from the said Agent shall be delivered to the proper Officers of the Customs at the Port in which the said Copper is intended to be shipped, and shall be their Authority for allowing the Quantity of Copper specified in the said Certificate to be put on Board and exported .- And as touching Sheets of Copper of and under the Weight of Two Pounds and an Half to the Foot Superficial, His Majesty is further pleased to permit and allow the same to be carried Coastwife without any Restriction, provided that no greater Quantity than Ten Hundred
