The KING's Most Excellent Majesty in Council. HEREAS, by an Act of Parliament passed in the Twenty fixth Year of His late Majesty's Reign, intituled, "An Act to oblige Ships more ef-"fectually to perform their Quarantine; and "for the better preventing the Plague being for the better preventing the Plague being brought from Foreign Parts into Great Britain "or Ireland, or the Isles of Guernsey, Jersey, Alderney, Sark, or Man;" it is among many other
Things enacted, that all Ships and Vessels arriving,
and all Persons, Goods, and Merchandizes whatsever, coming or imported into any Port or Place
within Great Britain or Ireland, or any of the Isles aforementioned, from any Place from whence His Majetty, His Heirs or Successors, by and with the Advice of His or Their Privy Council, shall judge it probable that the Infection may be brought, shall be obliged to make their Quarantine in such Place and Places, for such Time and in such Manner as has been, or shall from Time to Time be, directed by His Majesty, His Heirs or Successors, by His or Their Order or Orders, made in His or Their Privy Council, and notified by Proclamation, or published in the London Gazette; and that until such Ships; Vessels, Persons, Goods and Merchandizes shall have respectively performed, and be discharged from such Quarantine, no such Person, Goods, or Merchan-dizes, or any of them, shall come or be brought on Shore, or go or be put on Board any other Ship or Vessel, in any Place within His Majesty's Dominions, unless in such Manner and in such Cases, and by such Licence, as shall be directed or permitted by such Order or Orders made by His Majesty, His Heirs or Successors, in Council as aforesaid; and that all such Ships and Vessels, and the Persons or Goods coming or imported in, or going or being put on Board the same; and all Ships, Vessels, Boats and Persons receiving any Goods or Persons out of the same, shall be subject to such Orders, Rules and Directions concerning Quarantine and the Prevention of Infection, as have been or shall be made by His Majesty, His Heirs and Successors, in Council, and notified by Proclamation, or published in the London Gazette as aforementioned, under fuch Pains and Penalties as are inflicted by the faid And whereas Information hath been received that the Plague hath manifested itself in many Places of the Ukraine and Wolhynia, and that the Contagion thereof spreads further every Day; and His Majesty, by and with the Advice of His Privy Council, doth thereupon judge it probable, that the Infection may be brought into this Kingdom from

Dan zick, or some Port or Place in Royal and Ducal Prussia or Pomerania, or from some Port or Place in Courland, Samogitia, or Livonia; His Majesty doth therefore, by and with the Advice of His Privy Council, hereby order, that all Ships, Vessels, Persons, Goods and Merchandizes, now arrived, or that shall hereaster arrive, in any Port of this Kingdom, or the Isles of Jersey, Guernsey, Alderney, Sark or Man, from Dantzick, or any other Port or Place in Royal and Ducal Prussia or Pomerania, or from any Port or Place in Courland, Samogitia, or Livonia, do make their Quarantine for Forty Days, which is to commence and be computed from the Day each Ship or Vessel shall come to Anchor in the Place appointed for performing Quarantine, and not before.

That the Places herein after named shall be and are hereby appointed to be the Places, wherein fuch Ships or Vessels (not having the Infection on Board) shall respectively perform Quarantine; that is to fay, All such Ships or Vessels which are or shall be bound to the Port of London, or any Member, Creek, or other Parts thereof, or to the River Thames, or Medway, shall perform their Quarantine in Stand-gate Creek; all such Ships or Vessels which are or shall be bound to the Ports of Ipswich, Yarmouth, Lynn, Boston, Hull, Newcastle, or Berwick upon Tweed, or any of them, or any Member or Creek-thereof, or other Place therein, shall perform their Quarantine in Whitebooth Road between Hall and Grimsby; all such Ships or Vessels which are or shall be bound to the Ports of Carlisle and Chesser, or either of them, or any Member or Creek there-of, or other Place therein, or to any Part of the Isle of Man, shall perform their Quarantine in a Place called Highlake, near Liverpool, at the West End thereof; all such Ships or Vessels which are or shall be bound to the Ports of Milford, Cardiff, Gloucester, Bristol, Bridgwater, or any of them, or any Member or Creek of them, or any of them, or to Padstow or St. Ives, being Members of the Port of Plymouth, or to Ilfracomb or Barnstaple, being Members of the Port of Exeter, or to any other Place within the faid Ports of Milford, Cardiff, Gloucester, Bristol, or Bridgwater, or within the said Members or Creeks, shall perform their Quarantine in Kingroad and Porshute Pill; all such Ships or Vessels which are or shall be bound to the Port of Plymouth, except such Parts thereof as have been herein before mentioned, and also except Falmouth, One Member thereof, or to the Port of Exeter, except such Parts thereof as have been herein before mentioned, or to the Port of Pool, or any of the Members or Creeks, or other Places within the faid Ports of Plymouth, Exeter, and Pool, except as before excepted, shall perform their Quarantine in some Place between Woodend and

Saltash in the River Tamar; all such Ships or Vessels as are or shall be bound to Falmouth, a Member of the Port of Plymouth, or any Creek thereof, or any other Place therein, shall perform their Quarantine in a Place called St. Ives Pool, within the Mouth of the Harbour of Falmouth; and all such Ships or Vessels as are or shall be bound to the Ports of Southampton, Chichester, Sandwich, or any of them, or any of the Members or Creeks thereof, or of any of them, or any other Place within the same, shall perform their Quarantine at a Place called the Mother Bank near Portsmouth; and all such Ships or Vessels as are or shall be bound to the Eastern Coast of Scotland, comprehending the Ports of Leith, Borrowstoness, Alloa, Dunbar, Kirkaldy, Anstruther, Preston Pans, Dundee, Perch, Montrose. and Aberdeen, or to any Member, Creek, or other Parts thereof, shall perform their Quarantine in Inverkeithing Bay; and all fuch Ships and Vessels as are or shall be bound to the Western Ports of Scotland, comprehending the Ports of Port Glasgow, Greenock, Irvine, Campbeltoun, Oban, Rothsay, Fort William, Air, Port Patrick, Stanraer, and Wigtown, or to any Member, Creek, or other Parts thereof, shall perform their Quarantine at Lamlash in the Island of Arran; and all such Ships or Vessels as are or shall be bound to the Northern Ports of Scotland, comprehending the Ports of Inverness, Zetland, Orkney, Caithness, and Stornaway, or to any Member, Creek or other Parts thereof, shall perform their Quarantine in Cromarty Bay in the Murray Frith; and all such Ships or Vessels as are or shall be bound to the South west Ports of Scotland, comprehending the Ports of Dumfries and Kirkcudbright, or to any Member, Creek, or other Parts thereof, shall perform their Quarantine at Carsthorn at the Mouth of the River Nith; and all such Ships or Vessels which are or shall be bound to the Isle of Jersey, or any Part thereof, shall perform their Quarantine at a certain Place on the Coast of the said Island called Belle Croute, or at some Place herein before appointed for Performance of Quarantine on the Coast of England; and all such Ships or Veffels as shall be bound to the Islands of Guernsey, Sark or Alderney, or either of them, or any Part of them, or any of them, shall perform their Quarantine in a Place near the Island of Guernsey, called the Little Road, or at some Place herein before appointed for Performance of Quarantine on the Coast of England.

That no Pilot shall go on Board any Ship or Ves-fel obliged to perform Quarantine, in order to conduct the fame into any Port or Place, but shall per-form such Service in some other Boat or Vessel, which Boat or Vessel shall keep as much to the Windward of the Ship or Vessel, so to be conducted, as possible; and if any Pilot or other Person shall go on Board fuch Ship or Veffel, fuch Pilot or other Person shall persorm Quarantine, in like Manner as any Person coming lim such Ship or Vessel shall be

obliged to perform the same.
That all Goods, Wares, and Merchandizes liable to Quarantine as aforefaid, shall be opened, unpacked, and aired, unless His Majesty shall think fit, by His Order in Council, to direct otherwise, and fo remain a Week, other than Henip and Flax, Paper or Books, Silk Raw, Thrown, or Wrought, Linnen, Cotton Wool, Cotton Yarn or manufactured,

in Chests, Thread Stockings, all Goods packed with Straw or Cotton, Straw Hats, and Brushes, Matting and Artificial Flowers; which Goods and Merchandizes, so as aforesaid enumerated, are to be opened, unpacked, and aired, unless His Majesty shall think fit, by His Order in Council, to direct otherwise, and

fo remain for the Space of a Fortnight.

That all Goods imported by fuch Ships and Veffels respectively shall be aired in the following Places, that is to fay: All such Goods as shall be imported to the Port of London, or any Member, Creek, of other Paris thereof, or to the River Thames, or Medway, shall be aired in Standgate Creek: All such Goods as shall be imported to the Ports of Ipswich, Yarmouth, Lynn. Kirkcudbright, or to any Member, Creek, or other [Parts thereof, shall be aired at Carsthorn, at the Mouth of the River Nith: And all such Goods as shall be imported to the Isle of Jersey, or any Part thereof, shall be aired at a certain Place on the Coast of the said Island called Bel'e Croute; or at such Place herein before appointed for Performance of Quarantine on the Coast of England, where the Ships, in which such Goods are imported, shall repectively perform their Quarantine: And all such Goods as shall be imported to the Islands of Guernfey, Sark, or Alderney, or either of them, or any Part of them, or any of them, shall be aired in a Place near the Island of Guernsey, called the Little Road, or at such Place herein before appointed for Performance of Quarantine on the Coast of England, where the Ships, in which such Goods are imported, shall respectively perform their Quarantine: That whatsoever Ship or Person shall receive any Men or Goods from on Board any Ship or Vessel under Quarantine, shall be compelled to perform the like Quarantine; that such Persons as, after Quarantine persormed, shall be employed in the Hold of any Ship or Vessel, for the taking any Goods not liable to retain Infection from the Goods and Merchandizes before enumerated, shall be obliged to perform a new Quarantine; that the Captains of every of His Majesty's Ships of War, who shall meet any such Ship or Vessel coming to any of the Ports of Great Britain or Ireland, or of the Isles of Guernsey, Jersey, Alderney, Sark or Man, shall take due Care to prevent the Landing any Goods, Seamen, or Passengers from on Board the same, until they shall be put under the Direction of the Officers of His Majesty's Customs.

That the Commissioners and other Officers of His Majesty's Customs do use their utmost Diligence and Care that the Quirantine before directed be duly

performed.

That the Commanders of His Majesty's Ships of War, as likewise the Commanders of His Majesty's Forts and Garrisons, lying near the Sea Coasts, and all the Justices of the Peace, Mayors, Sherists, Bailists, Chief Magistrates, Constables, Headboroughs, Tything Men, and all other Officers and Ministers of Justice, be aiding and assisting to the said Officers of His Majesty's Customs, and to all others that shall be concerned in stopping all such Ships as aforesaid, and in bringing them to their Places appointed for the Performance of their Quarantine, and in due Performance thereof.

And the Lords Commissioners of His Majesty's Treasury, the Commissioners for Executing the Office of Lord High Admital of Great Britain, the Lord Warden of the Cinque Ports, the Master-General and the Principal Officers of the Ordnance, His Majesty's Secretary at War, and the Governors or Commanders in Chief for the Time being of the said respective Isles of Jersey, Guernsey, Alderney, Sark, and Man, are to give the necessary Directions herein, as to them may respective-

ly appertain.

WHEREAS it has been represented unto His Majetty, that great Inconveniences have driffen, by Appeals in Prize Causes not being prose-

cuted in a reasonable Time, and from Secret Appeals, or Protocols of Appeal, being entered tesore a Notary Publick, without any Notice given to the Court of Parties appellate, or their Proftors: For Remedy whereof His Majesty harb thought fit, by and with the Advice of His Privy Council, to order and direct, that every Perfon being a Party in a Prize Cause in the High Court of Admiralty of England, or in any Vice-Admiralty Court, and against whom a Sentence shall hereafter be given; or an Interlocutory Decree pronounced, and who shall appeal therefrom within Fourteen Days, shall profecute fuch his Appeal, by taking out the usual Inhibition within Three Months after the Time such Senience or Interlocutory Decree shall be given, if fuch Sentence or Decree shall be given in the High Court of Admiralty, and within Nine Months, if such Sentence or Decree shall be given in any of the Vice-Admiralty Courts; and that after the Expiration of the said Terms of Three Months and Nine Months respectively limited as asorefaid, without any Inhibition having been taken out, no Appeal shall be allowed to be profecuted by any Person being a Party in the faid High Court of Admiralty, or Vice-Admiralty Courts, nor shall any Inhi ition be granted at the Prayer of such Person, or his Proctor, but the faid Sentence or Interlocutory Decree shall stand confirmed as to such Person. And that in all Cases where a Sentence shall be given; or Interlocutory Decree shall be pronounced in the High Court of Admiralty, or in any of His Majesty's Vice-Admiralty Courts, any Person not being a Party in the first Instance, who does not interpose his Appeal, and at the fame Time give his Claim, and pray the usual Inhibition within One Year, shalf not, after such Year hath elapsed; be intitled to any Appeal.

7HEREAS His Majesty was graciously pleased, by His Royal Proclamation, bearing Date the 25th Day of October, 1776, to promise and declare, That the Bounties of Five Pounds for every Able Seaman, and of Two Pounds Ten Shillings for every Ordinary Seaman, fit for His Majesty's Service, should be paid in the Manner thereby directed, to every such Able and Ordinary Seaman, not above the Age of Eisty, nor under the Age of Eighteen Years, who should, on or before the 31st of December then following, enter themselves to serve in His Majesty's Royal Navy, either with the Captains or Lieutenants of His Majesty's Ships, or the Chief Officers on Board fuch Tenders as should be employed for raising Men for the Service of the Royal Navy: And whereas His Majesty was also pleased, by His Royal Proclamation, bearing Date the 8th Day of November, 1776, to promise and declare, That a Reward of Two Pounds for every Able, and Thirty Shillings for every Ordinary Seaman, should be paid in the Manner thereby directed, to any Person who should discover any Seaman or Seamen who might secrete themselves, that so such Seaman or Seamen should be taken for His Majesty's said Service, by any of His Majesty's Sea-Officers employed for raising Men, on or before the 31st Day of Deraining ivien, on or before the 31st Day of December, 1776: And whereas His Majesty was likewise pleased, by His Royal Proclamation, bearing Date the 15th Day of August, 1777, to promise and declare, That every Able-bodied Landman, not above the Age of Thirty-sive, nor under the Age of Twenty Years, who should voluntarily enter himfelf to serve on Board any of His Majesty's Ships, on or before the 31st Day of October then next, should receive, as of His Majesty's Royal Bounty, the Sum of Thirty Shillings each Man, to be paid in Manner thereby directed: And whereas the Time limited by the faid Proclamations, for Payment of the faid Bounties and Rewards, hath been prolonged and extended to the 31st Day of this instant December; and it being judged expedient for His Majesty's Service that the said Bounties and Rewards should be continued to be paid for some Time longer, His Majesty, with the Advice of His Privy-Council, doth therefore order, and it is hereby accordingly ordered, that the Time limited for Payment of the faid Bounties and Rewards be prolonged and extended from the said 31st Day of this inftant December to the 31st Day of March next, inclusive. — Whereof all Persons concerned are to take Notice, and govern themselves accordingly.
