HIS Day the Lords being met, a Message was fent to the Honourable House of Commons by Sir Francis Molyneux, Gentleman Usher of the Black Rod, acquainting them, that The Lords, authorized by virtue of His Majesty's Commission, for declaring His Royal Assent to several Acts agreed upon by both Houses, do desire the immediate Attendance of this Honourable House in the House of Peers, to hear the Commission read; and the Commons being come thither, the said Commission, impowering His Royal Highness the Prince of Wales, the Lord Archbishop of Canterbury, the Lord High Chancellor of Great Britain, the Lord Prefident of the Council, and feveral other Lords, to declare and notify the Royal Assent to the said Acts, was read accordingly, and the Royal Affent given to

An Act for punishing Mutiny and Defertion, and for the better Payment of the Army and their Quarters.

An Ast for paving, lighting and watching the Streets, Lanes and other Public Passages and Places within the Walls of the City of Canterbury, and the Liberties thereof; and also several Streets and other Places near or adjoining to the faid City; and for re-moving and preventing Incroachments, Obstructions, Nuisances and Annoyances therein.
