#### Vienna, March 20.

An Imperial Edict has been published here, dated the 8th Inftant, prohibiting the Importation into any of the Auftrian Dominions of Hardware, Cutlery, Turnery, Toys, Stationary, Cordage, Whalebone, Leather-Gloves, Ribbons, Cottons, Linens, Watches, Fans, Thread, Sadlery, &c. unlefs by Individuals for their own Ufe, and not for Sale; but Cambricks, Gauzes, Mullins and Lawns are permitted to be imported by Passport for Sale, paying a Duty of Six Florins per Pound Weight.
