A PROCLAMATIÓN, For Encouraging Seamen and Landmen to enter themfelves on Board His Majesty's Ships of

War.

GEORGE R.

WHEREAS it is Our Royal Intention to give all due Encouragement to all fuch Seamen and Landmen who shall voluntarily enter themfelves in Our Service; We have thought fit, by and with the Advice of Our Privy Council, to publish this Our Royal Proclamation : And We do hereby promife and declare, That all fuch Able Seamen, not above the Age of Fifty, nor under the Age of Twenty Years, fit for Our Service, who fhall, on or before the Thirty-first Day of October next, volun-tarily enter themselves to ferve in Our Royal Navy, either with the Captains or Lieutenants of Our Ships, or Officers employed in Tenders, or at Rendevous on Shore, for raifing Men for the Service of Our Navy, thall receive, as Our Royal Bounty, the Sum of Three Pounds each Man; and all fuch Ordinary Seamen, fit for Our Service, who shall so enter themfelves as aforefaid, fhall receive the Sum of Two Pounds each Man; and all fuch Able-Bodied Landmen, not above the Age of Thirty-five, nor under the Age of Twenty Years, who fhall fo enter themielves as aforefaid, fhall receive the Sum of Twenty Shillings each Man, as Our Royal Bounty ; fuch refpective Sums to be paid them by the refpective Clerks of the Cheque, reliding at the Ports or Places where the Ships into which they fhall be entered fhall be, immediately after the Third Mufter of fuch Seamen and Landmen : And We do declare, that the Qualifications of the Seamen and Landmen to entering themfelves as aforefaid, shall be certified by the Captain, Master, and Boatswain of the Ship or Vessel where they shall enter. And for Prevention of any Abuses, by any Persons leaving the Vessels to of any Abues, by any renous leaving the venets to which they shall belong, and entering themselves on Board any other Our Ships or Vessels, in order to obtain the faid Bounty-Money, We do hereby declare and command, That such Seamen and Landmen belonging to any of Our Ships or Vessels, as shall absent themselves from any of the faid Ships or Vessels to which they shall belong, and shall enter

themselves on Board any other of Our faid Ships OF Veffels, in order to obtain the faid Bounty, shall not only lofe the Wages due to them in the Ships or Veffels they shall leave, but also be severely punished according to their Demerits.

PROCLAMATION; A

For Recalling and Prohibiting Seamen from ferving Foreign Princes and States, and for granting Re-wards for difcovering Juch Seamen as shall conceal themselves.

GEORGE R.

HEREAS We are informed, That great Numbers of Mariners and Seafaring Meri, Our natural-born Subjects, are in the Service of divers Foreign Princes and States, to the Prejudice of Our Kingdom; We have therefore thought it necessary, by and with the Advice of our Privy Council, to publish this Our Royal Proclamation; and do hereby ftrictly charge and command all Mafters of Ships, Pilots, Mariners, Seamen, Shipwrights, and other Seafaring Men whatfoever and wherefoever, (being Our natural-born Subjects) who are in the Pay or Service of any Foreign Prince or State, or do ferve in any Foreign Ship or Vessel, That forthwith they, and every of them, do (according to their known and bounden Duty and Allegiance) withdraw themselves, depart from, and quit fuch Foreign Services, and return Home to their Native Countries. And farther, We do hereby strictly prohibit and forbid all Masters of Ships, Pilots, Mariners, Seamen, Shipwrights; and other Seafaring Men whatfoever, (being our natu-ral-born Subjects) from entering, and do charge and command them, and every of them, from henceforth to forbear to enter themfelves into the Pay or Service of any Foreign Prince or State, or to ferve in any Foreign Ship or Veffel whattoever, without Our Special Licence first had and obtained in that Behalf; to all which We expect due Obedience,

publish and declare, that the Offenders to the contrary shall not only incur Our just Displeasure, but be proceeded against for their Contempt according to the sutmost Severities of the Law. And We do hereby declare, that if any fuch Matters of Ships, Pilots, Mariners, Seamen, Shipwrights, or other Seafaring Men, (being Our Subjects) shall be taken in any Foreign Service by the Turks, Algerines, or any others, they shall not be reclaimed by Us as Subjects of Great Britain.

And we do hereby further promife and declare, That a Reward of Two Pounds for every Able, and Thirty Shillings for every Ordinary Seaman, shall be paid any Perfon who shall difcover any Scaman or Seamen who may fecrete themfelves, fo that fuch Seaman or Seamen shall be taken for our faid Service by any of our Sea Officers employed for raifing Men; the faid Rewards to be paid for any Seaman or "Seamen fo difcovered and taken in and about London, by the principal Officers and Commiffioners of our Navy: And at the Out-ports by the Naval Officers (where there are any); and (where there are no Naval Officers) by the Collectors of Our Cultoms, immediately upon a Certificate being produced to the faid principal Officers and Commissioners of Our Navy, Naval Officers, or Collectors respectively, by the Perfon who may make Difcovery of any Seaman or Seamen as aforefaid, certifying his Name, and the Name or Names and Number of Seamen procured in confe-quence of his Difcovery; the faid Certificate to be given by fuch Officer as may take fuch Seaman or Seamen for Our Service.

ABROCLAMATION

Respecting the GOLD COIN.

GEORGE R.

WHEREAS it has been reprefented unto Us, that great Quantities of the Gold Coin of this Realm, deficient in Weight, are now in Circulation, contrary to the Tenour of Our Royal Proclamation of the TwelfthDay of April, One thousand feven hundred and feventy-fix, and there being Reafon to believe that due Attention is not paid to the weighing of the faid Gold Coin, and to the Directions given in the Acts of Parliament now in Force with Refpect to the cutting, breaking or defacing of fuch Rieces thereof as are found to be of lefs Weight than those declared and allowed by Our faid Proclamation to be current and pais in Payment ; We do think proper, by this Our Royal Proclamation, to declare and command, in like Manner as We did declare and command in Our before-mentioned Proclamation of the Twelfth Day of April, One thousand feven hundred and feventy-fix, That all Guineas, Half Guineas and Quarter Guineas, more deficient in Weight than the Rates specified in the Table following, 11 1 1 Beach

dience, and exact Conformity. And We do hereby be not allowed to be current or pais in any Payment whatloever : And We do hereby strictly require and command all Our loving Subjects, and particularly all. the Officers, Collectors and Receivers of Our Revenues, strictly to conform to the Orders hereby given, and to the Directions and Regulations enacted and established in the feveral Acts of Parliament now in Force with Respect to the cutting, breaking and defacing fuch Pieces of the faid Gold Coin as fhait be found deficient in Weight. Given at Our Court at St. James's, the Twenty-first Day of September, One thousand seven hundred and eighty-seven, in the Twenty-feventh Year of Our Reign.

Act of the 14th Year of His prefent Majesty's Reigno Chap. 70. Sect. 7.

ND be it further enacted, by the Authority A aforefaid, That the Tellers in the Receipt of His Majefly's Exchequer in Great Britzin, and all Receivers, Collectors and other Officers of all His Majefty's Revenues wherefoever, and all other Perfons whatloever, are hereby authorifed and re-quired to cut, break or deface, or caule to be cut, broken or defaced, every Piece of Gold Coin of this Realm that shall be tendered to them or any of them in Payment, after fuch Time and Times as any fuch Piece of Gold Coin shall, by virtue of any Proclamation of His Majefty in Council, be declared not to be allowed to pais in any Payment whatfoever, any Law or Statute to the contrary thereof in anywife notwithstanding; and the Person tendering the same shall bear the Loss: But if any fuch Piece fo cut, broken or defaced, fhall be of due Weight, and appear to be lawful Money, the Perion that cut, broke or defaced the fame, shall and is hereby required to take and receive the fame at the Rate it was coined for : And if any Questions or Disputes shall arise, whether the Piece fo cut be lawful Coin, within the Intent and Meaning of His Majefly's Proclamations, it fhall be heard and finally determined by the Mayor, Bailiff or Bailiffs, or other Chief Officer of any City or Town Corporate where fuch Tender shall be made; and if fuch Tenders shall be made out of any City or Town Corporate, then by fome Justice of the Peace of the County inhabiting or being near the Place where fuch Tender shall be made; and the faid Mayor or other Chief Officer, and Justice of the Peace, shall have full Power and Authority to administer an Oath, as he shall see convenient, to any Person, for deter-mining any Questions relating to the Weight and lawful Currency of the faid Piece of Coin,

AND be it further enacted, by the Anthority aforefaid, that from and after the 31st Day of December, One thousand seven hundred and seventy-four, all Weights to be made Use of for Weighing the faid. Gold and Silver Coin, shall be regulated and afeertained by the Duplicates or Copies of the faid Stand-ard Weights of a Guinea, and of a Shilling, and of the Parts and Multiples thereof refpectively, lodged in the Cuftody of the Officer beforementioned, (viz.) the Officer appointed by His Majefty for this Purpole, in purluance of a preceding Clause of the faid AG) and after having been tried and compared therewith ...

therewith, and found to be just and true, shall, in] Testimony thereof, be marked by the faid Officer with a Stamp or Mark, or Stamps or Marks, to be approved of by the Malter of His Majesty's Mint; which Stamps or Marks the faid Officer is hereby directed to provide: And in order that the Impreffion or Impressions made thereby may be known to all His Majesty's Subjects, the faid Officer is hereby also directed to publish a Description of the same, by Advertisement in the London Gazette, Three Times at least before the faid Thirty-first Day of December, One Thousand Seven Hundred and Seventy-four; and the faid Officer is hereby required, upon Application made to him, at all feafonable Hours to stamp or mark, in Manner aforefaid, all Weights to be used for weighing the faid Gold and silver Coin, which fhall be brought to him for that Purpole, and which he fhall find to be just and true, according to the faid Duplicates or Copies of the Standard Weights of a Guinea and of a Shilling, and of the Parts and Multiples thereof refpectively, hereby directed to be lodged in his Cuftody, without Fee or Reward, and without wilful Delay: And from and after the faid Thirty-first Day of December, One thousand feven hundred and feventy-four, no other Weights but fuch as shall be just and true, according to the Weights with and by which they are hereby directed to be compared and accertained, and shall be marked in Manner before-mentioned, shall be reputed or accepted in Law to be true or of any Effect for determining the Weight of the Gold or Silver Coin of this Realm.

Hague, September 21.

The Prince of Orange arrived here Yeflerday at Two o'Clock in the Afternoon, and was received by the Deputations from the States General, the States of Holland, the Council of State, and Committees, the Equefrian Order, the Courts of Juffice, and the different Colleges. The Deputies of Fifteen Towns were prefent in the Affembly of the States of Holland Yeflerday, when they unanimoufly voted an Addrefs to the Stadtholder; and this Day they came to a Refolution declaring him reinflated in all his Rights. It is impossible to defcribe the universal Joy that prevails here among all Ranks of People upon this Event.

Constantinople, August 25.

In the Morning of the 16th Inflant, after a Public Audience of the Grand Vizir, Monf. de Bulgakow, the Ruffian Envoy, with his Secretary Monf. Jacobloff, Meff. Nicolo Pifani and Dandria, the two principal Interpreters of that Miffion, and two of the Envoy's Servants left to attend him, were conducted to the Seven Towers. The Reft of the Ruffian Minister's Suite was efforted by a Guard to his Hotel in Pera, where they continue unmolefied.

The formal Declavation of War against Russia was read at the Porte on the 22d, with full and absolute Power to the Grand Vizir for conducting the Operations.
