This Convoy is to be speedily returned again for spain, and with it several Ships for Liebenne.

One of the Ships employed to transport Soldiers into Spain from Finale, las been unhappily cast away, and in her above 300 Soldiers, onely one man escaping the Wreck:

'Tis said that the King of France has lately wrote to the Duke of Savey, to sorbear his design of fortifying Trino, a place of great importance in Montferrat, not far diffant from Cafal, which he has done in favor to the Duke of Mantoua, who has some pretentions to that place, upon the account of some ancient Treaties; being unwilling he should have any occasion given him to defert the French interest.
